### DISCUSSION OF THE 2016-2017 SCHOOL DISTRICT BUDGET

- Dr. Chapman reviewed the proposed budget cuts in the amount of \$1,336,324.
- Mr. Deserable reviewed the proposed Local Tax Levy, Ratable Base, Average Home Cost, School Tax Rate and School Tax Rated based on the Average Home Value.

A motion was made by Mrs. Young and seconded by Mrs. Snyder to approve item numbers 1 and 2. The motion was approved by a roll call vote with all Board Members present voting yes. 7-0-0.

1. **RECOMMEND** the Board of Education for the Township of Pennsauken to approve the 2016-2017 Pennsauken Township School District budget for submission to the County Office of Education as follows:

**BE IT RESOLVED** to seek approval for Health Care Cost Adjustment in the amount of \$513,989 and CAP Banking in the amount of \$266,225.

**BE IT FURTHER RESOLVED** to withdrawal from Capital Reserve – Other Capital Projects. Included in budget line 620. Budgeted withdrawal from Capital Reserve – Excess Costs and Other Capital Projects, is \$1,680,000 for the following Capital Projects:

- Air Conditioning Benjamin Franklin Elementary School \$430,000
- Pennsauken High School Alternative Education Center \$1,250,000

The total costs of these projects is \$1,680,000 which represents expenditures for construction elements or projects that are in addition to the facilities efficiency standards determined by the Commissioner as necessary to achieve the core curriculum content standards.

**2. RECOMMEND** the Board of Education of the Township of Pennsauken approve the following resolution:

**WHEREAS** N.J.A.C. 6A:23A-7.3(a) provides that the Board of Education shall establish in the annual school budget a maximum expenditure amount that may be allotted for such travel and expense reimbursement for 2016-2017 school year; and

**NOW THEREFORE BE IT RESOLVED**, that the Pennsauken Board of Education hereby establishes the school district travel maximum for the 2016-2017 school year at the sum of \$70,000; and

**BE IT FURTHER RESOLVED**, that the School Business Administrator shall track and record these costs to insure that the maximum amount is not exceeded.
