It does, however, respectfully suggest that citizens attempt to resolve concerns by speaking directly to school administrators before bringing it to the Board. Individuals with a relevant interest in the function or duties of the Board are invited to speak a maximum of five (5) minutes on any one issue. You are required to give your name and address before speaking.

Executive Meetings are conducted when the Board of Education must review and discuss confidential matters. By illustration, pending legal cases, personnel matters, and collective bargaining proposals are appropriate reasons for the Board to hold an Executive Session. 3. **BE IT RESOLVED by the Board of Education of the Township of Pennsauken** to approve the Girl Scouts of America to conduct the BFF (Be a Friend First) initiative at Phifer Middle School this spring (DTA). GSA will run a 4-5 week program (once a week for a class period or during an after school program) for girls. As a culmination to the BFF program, GSA is also looking to host a 1 day event at the school, where girls can come and learn basic life skills, such as first aid, healthy cooking, and self-defense. The day would end with a community service project.

Justification: Phifer Middle School is seeking to put preventative measures in place to reduce the incidences of bullying. BFF is a fully funded program based on providing girls with the tools and confidence to prevent bullying and relational aggression.

Justification: Support career pathways opportunity students.
