Senior Citizen Exemption Form
Instructions

1. This parcel tax exemption is for property owners who are over 65 years of age or older on July 1, 2025.
2. This parcel tax exemption is for your principal place of residence only, and applies to one parcel only.
3. New Measure A parcel tax exemption applications must be received at our district office by June 30 to claim an exemption for the term of the tax that begins July 1.
4. The parcel tax applies to parcels with land value. If your parcel is taxed for improvement value only (as in some mobile home parks), the parcel tax will not be assessed on your parcel, and you do not need to fill out this application.
5. To find your Parcel Number, look for the 8-digit number (XXX-XX-XXX) on your property tax bill, or call the County Assessor at 408-299-5500.
6. **The application form and supporting proofs of residency, age and ownership must be received no later than June 30, 2025.** Please mail or bring the signed completed application to:
