

**Palm Elementary Parent and  
Family

Staff professional development is conducted throughout the school year both district wide and at the building level. Teachers participate in weekly C3 Team meetings to analyze data and discuss best instructional practices. We hold staff meetings to maintain an understanding of all of our building practices. Family Engagement Coordinators will engage school staff to build their capacity to work with families.
