In support of strengthening student academic achievement, Toni Morrison receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by section 1116(b) and (c) of Every Student Succeeds Act (ESSA). ### **JOINTLY DEVELOPED**

Professional development happens throughout the year. Weekly staff meetings are held to discuss building practices. Teachers participate in C3 teams weekly to discuss best practices after looking at current data. Family Engagement Nights are offered three times a year.
