# GSL Area Scholarship Info Packet

Glencoe-Silver Lake High School December 20, 2024

## Updates to this "Scholarship Information Packet" may take place up to the date applications open in December. Prior to applications opening is for student awareness only.

This is the time of the year to think about last minute details regarding graduation and your educational and vocational plans following graduation. There are still many details to take care of before graduation comes around.

1. Log onto your Infinite Campus account and check your credits on your transcript under the "Reports" tab. Continue to work hard in your current classes to ensure you meet the graduation requirements.

2. HOUSING- If you have not yet heard anything regarding residence hall arrangements - please contact the Housing Office at the school you will be attending to see when housing assignments will be made. In most cases, it is your responsibility to let the college know you are interested in on-campus housing. Off-campus housing is expected at technical, trade and community colleges.

3. <u>It is not too late to consider going on to school next year if you have not yet made final plans</u>. If you are planning to attend a state college or university, the chances are very good that you will still get in; however, the schools cannot guarantee ON-CAMPUS HOUSING or FINANCIAL AID AWARDS for new applicants at this time. There are still many programs open at various technical colleges and trade schools. You may check in the Admissions Office regarding which specific schools have openings and when those openings will close.

## FINANCIAL AID

Send in the 2024-25 Free Application for Federal Student Aid (FAFSA) which qualifies the applicant for Federal Aid, and, if attending a Minnesota school, State Aid. Applications can be completed any time after December 1st. Then expect a Student Aid Report (SAR) which will determine Federal Aid eligibility in 3-4 weeks after submit the application. If you chose to complete a paper form of FAFSA you will need to request the form on the FAFSA website. I am quite confident that there will be significant levels of State and Federal monies available to students this year. Preliminary aid awarded letters may be received as early as April if your FAFSA was sent early. <u>Final</u> financial aid award will most likely be sent in March-May. Some of you have submitted your FAFSA for processing, but, it is not too late to do so. Also, some colleges have separate aid applications in addition to the FAFSA. Contact the institution's Financial Aid Office for this separate aid application which is sometimes called an <u>Institution Verification Form</u>. (Unless it is mailed directly to your home address.) Separate aid applications are required in order to award campus based aid (Perkins Loan, Supplemental Educational Opportunity Grant (SEOG) and Work-Study).

I STRONGLY ENCOURAGE EVERYONE planning any type of postsecondary education or training to submit the Free Application for Federal Student Aid and apply for financial aid.

NOTE: in Step Four: Releases and signatures on the 2024-25 FAFSA, you are asked to list the college name(s) and codes for those colleges listed. Because colleges package aid awards differently (for example --greater or lesser expectation for loan borrowing), it may be advantageous to list all colleges you have previously applied to and been accepted at-- a final decision regarding your chosen school could be postponed until sometime this spring after you compare aid award offers!!

# 2025-2026 APPLICANT CHECKLIST Federal Student Aid and Minnesota State Grant Program

- Complete a 2025-26 Free Application for Federal Student Aid (FAFSA) to qualify for Federal Pell Grants, Supplemental Grants, Subsidized and unsubsidized Stafford Loans, Perkins Loans, Work study and State Grants.
- \_\_\_\_ The U. S. Department of Education will send information from the FAFSA to the state agency for Minnesota colleges to determine state aid awards.
- \_\_\_\_ Only Minnesota schools are eligible to participate in the State Grant program. To apply for a State Grant, you must list at least one Minnesota school in Step Four of the FAFSA.
- \_\_\_\_\_ Submit your 2025-26 FAFSA for consideration for Federal and State Aid. It is your advantage to apply early so an aid award can be determined in time for fall term. Check on your individual school's financial aid priority deadline. For most schools, submit FAFSA no later than March 2<sup>nd</sup> for priority consideration for all types of aid you may qualify for.
- \_\_\_\_ If possible, <u>provide only data from completed tax forms</u>. Incorrect or estimated data may cause a delay in your application.
- Make sure you provided the correct social security number on the FAFSA. An incorrect number will delay processing of applications for both you and the other applicant whose number you mistakenly used. Both applicants would be required to submit copies of social security cards.
- \_\_\_\_ Double check your zip code. A blank or inaccurate zip code may cause your award notification letter to be lost in the mail.
- Make a copy of your tax forms and financial aid applications for your own records. You may have to refer to them later. Approximately 20% of applicants get selected in a process called "verification" which requires providing proof of information supplied on the 2025-26 FAFSA, usually by filling out the institution verification form sent to you by the school and attaching copies of federal tax returns and W-2's. Some schools verify all of their applicants, usually smaller schools.
- Promptly, respond to any letters sent from Federal Student Aid program, your school or the state agency. Keep a copy of letters you received for your own records.
- Some schools require a separate aid application form as well.
- \_\_\_\_\_ All information on the FAFSA for determining your aid eligibility is sent electronically to the school you released to in Step Four. Most corrections to the SAR, part 2, can be done "electronically" by simply calling the financial aid office or if completing the FAFSA on-line, you can make corrections to your file by following instructions.

If you have questions on how to apply for financial aid, see your high school guidance counselor or the financial aid officer at the school you plan to attend. If you have questions on your financial aid awards, contact the financial aid office at your college.

# FINANCIAL NEED AWARDS

In most cases your financial aid award will include an expectation <u>that you borrow</u> from the Direct Subsidized or Direct Unsubsidized Loan Program. It takes about 8-12 weeks for the loan to be processed, so I recommend that you start the process as soon as a determination is made (indicated in the preliminary award letter received from the institution's Financial Aid Office) regarding your loan amount eligibility. <u>You must fill out a FAFSA to determine</u> if you qualify for a Direct Subsidized or Direct Unsubsidized Loan.

The steps to follow are:

 The Financial Aid Office will indicate the amount of the Direct Subsidized or Direct Unsubsidized Loan (up to a maximum of \$5,500 for entering Freshman) that you qualify for; the <u>Financial Aid Office will send you an</u> <u>application form/promissory note in order to begin the process of applying for</u> <u>a Direct Subsidized or Direct Unsubsidized Loan to be distributed through the</u> <u>institution's Business Office</u>. Subsidized loans are preferable because while attending school the federal government will pay the interest on your loan. The American Opportunity credit, which replaced the HOPE credit, equals 100 percent of the first \$2,000 of qualified expenses (tuition, fees required for enrollment, and required course materials), and 25 percent of the next \$2,000

of qualified expenses. The Lifetime Learning Tax Credit is not available when: The taxpayer claimed the American Opportunity Tax Credit during the same tax year. The taxpayer pays for college expenses for someone who is not a dependent. The taxpayer files federal income tax returns as married filing separately.

2. You will have to find your own lender or the Financial Aid Office will suggest a list of possible lenders for your loans.

The financial aid office will ask you to accept or reject some or the entire proposed award for the 2025-26 academic year. You must respond by the deadline indicated on the response form or risk losing aid!

NOTE: Most local scholarships are selected by the organizations' selection committees, NOT by the school.

Seniors planning to attend college or technical college next fall have several local scholarships they may apply for. All local scholarship criterion is listed on the following pages. The applications will be available December 20, 2024 on the GSL website wwwlgsl.k12.mn.us Click on Our Schools/GSL HS/Counselors Corner/Scholarships/local scholarship applications. NOTE: Don't hesitate to apply - - in some cases, we had less applicants than scholarships.

Many of the applications are similar, but because there are different selection committees, it is necessary to complete a separate application for each scholarship. Please observe the following points in completing the applications:

- 1. **Be NEAT** - type or use ink
- 2. Be careful about spelling
- 3. The application is the only contact you have with the selection committees convey the best message you can.
- 4. Please observe the application deadline. (Some applications have different deadlines)
- 5. Staple application, so all forms stay together (No paper clips or manila envelopes)

## The application DEADLINE is Tuesday, February 11, 2025 @ 8:00 AM <u>NO EXCEPTIONS</u>

Completed applications get turned into Mrs. Templin in the HS Counseling Office unless an address is provided on the application. It is your responsibility to mail those applications.

Please make sure applications that require transcripts or additional information are <u>stapled</u> (no paper clips or manila envelopes) to the application so that they are not separated from your application.

#### **American Legion Scholarships**

#### **BROWNTON**

Must have a Brownton address and have a GPA of 3.0 or higher.

#### **GLENCOE**

The Brownton Bruins would like to offer a scholarship to a graduating student that is currently active in baseball or softball and has a GPA of 3.0 or higher.

#### **BONGARDS' COMMUNITY SCHOLARSHIP**

A scholarship will be awarded in memory of Gladys Severtson by her family. This is open to a female member of the graduating class.

#### **GLENCOE CAR AND BIKE SHOW SCHOLARSHIP**

This scholarship will be awarded to a student going to a 2-year trade program. Preference will be given to students pursuing but not limited to an automotive trade. Other qualifying trades would include welding, construction trades and computer related fields.

Criteria is as follows:

- 1. Must have a cum GPA of 2.66
- 2. Must be pursuing a qualifying trade. Suggestion: When in doubt complete the application.

#### **GLENCOE AREA CHAMBER OF COMMERCE**

Two \$500 scholarships will be awarded to graduating seniors. Applicants are required to submit an essay including their career goals and plans to achieve those goals, examples of what they've done to make the community a better place, and share their achievements and how they overcame challenges to reach them.

#### **GLENCOE –SILVER LAKE EDUCATION MINNESOTA SCHOLARSHIP**

The GSL teacher's union would like to award two (2) \$200 scholarships to a high school senior planning to attend a college to become a teacher.

- The Criteria is as follows:
  - 1. Must have a cum GPA of 3.00 (B) or higher
  - 2. Monies will be dispersed once one official term of college is completed with satisfactory grades.

Scholarships will be awarded to eligible members of the current graduating class who will be attending an accredited one to two year vocational or technical program. The exact amount and number of scholarships is determined each year by the committee. *Be sure to include your GPA/Rank on the application and attach a transcript*.
