

For the Central Film Academy to ensure a quality education in the art of film making and prepare our students for the industry, there must be an open and trusting relationship between students and faculty. While a student's commitment to honesty and personal integrity is assumed and expected, this Code is intended to provide an added measure of assurance in fulfilling the academy's requirements. The student will abide by all standards outlined by the Forsyth County Schools and CFA. This Code of Conduct agreement is made effective upon acceptance in the Central Film Academy and continues throughout a student's 4 year enrollment.

If a faculty member believes that the Code has been violated, all information and behavior of the student will be reviewed by the CFA Faculty. Failure to follow this simple code will put a CFA Student at risk of dismissal from the Academy.

CFA Code violations include but are not limited to:

Inappropriate use of social media :

Causing dissention between cohort members
Production Group Chats as vehicles of personal venting
(The ONLY Communication is through REMIND that includes Faculty members. NO
Production Group Chats)

- Disrespect of production team members. Each of the production team has a job and a responsibility. You are only responsible for yours unless otherwise requested by your producer and/or director.
- Any behavior that disrupts the educational experience of another student or production process.
- Plagiarism or lack of artistic integrity. Representing as one's own work the work of another.
- Unauthorized access to any CFA facility, including, editing suites, computer rooms, classrooms, faculty offices, and equipment storage areas.
- Unauthorized use of filming equipment. Must be scheduled, approved by Mr. Hanline and signed out and in after use.
- Inappropriate treatment or disrespectful use of filming locations and property on and off the FCHS Campus.

Quality Control and Expectations for all films

<u>All films</u> will have to apply for entry into the Film Expo, Forsyth Film Fest. .*Sophomores are required to submit to 1 Film Festival outside of the School District and prove submission. Juniors/Seniors are required to enter 2 Film Festivals outside the district with proof of submission.

Deadlines will be at the end of each semester. CFA Staff will evaluate the entries for acceptance. Nothing will be accepted late.

- 1st Semester Deadline for submitting entries Monday, Dec 4.
- 2nd Semester Deadline for submitting entries is **Friday, March 29**
- *Auditions will be open to **all students and staff** for films. Must communicate the dates, deadlines, character needs. Expectations of casting and filming.

What is a Quality Film?

- Completed by due date
- Must fall under school policies and school appropriate
- Well crafted, unique, original script (NOT Cliché)
- Well told story, character development, and resolution
- Production Craftsmanship: Camera work is creative and well done, camera angles that propel
 the plot. Excellent use of lighting, sound, Foley, technical aspects of filmmaking.
 Editing is clever and consistent to propel the story.
- Acting is authentic, engaging. Not superficial, corny or uninspired.

For Seniors:

*All CFA Students will undergo a Sophomore Review at the end of their 10th grade year. This is to evaluate the student's progress, work ethic and commitment to filmmaking and the academy. Students are required to maintain at least a B average in ALL CFA classes. Must conference with CFA faculty if a student's falls below a B average, they have the next grading period (9 weeks) to raise the average to a B or above otherwise risk removal from the academy.
