We are pleased to present you with the Annual Education Report (AER) which provides key information on the 2023-2024 educational progress for Gull Lake Virtual Partnership (GLVP). The AER addresses the complex reporting information required by Federal and State laws. The school's report contains information about student assessment, accountability, and teacher quality. For the 2023-2024 school year, schools were identified based on previous years' performance using definitions and labels as required in the Every Student Succeeds

Act (ESSA). A Targeted Support and Improvement (TSI) school had at least one underperforming student subgroup in 2023-2024. An Additional Targeted Support (ATS) school had a student subgroup performing at the same level as the lowest 5% of all schools in the state in 2023-2024. A Comprehensive Support and Improvement (CSI) school is one whose performance was in the lowest 5% of all schools in the state or had a graduation rate at or below 67% in 2023-2024. Some schools are not identified with any of these labels. In these cases, no label is given.

Our school has been labeled a Comprehensive Support and Improvement (CSI) school.

State law requires that we also report additional information.

1. PROCESS FOR ASSIGNING PUPILS TO THE SCHOOL

GLVP is a public school accepting any student who is a resident of our school district. We also accept school of choice students from within Kalamazoo County (105) and contiguous counties (105c), and students from non-contiguous counties if their resident district provides a release on a per school year basis.

- 6. IDENTIFY THE NUMBER AND PERCENT OF STUDENTS REPRESENTED BY PARENTS AT PARENT-TEACHER CONFERENCES.
 - Virtual Partnership utilizes weekly communication, as required by the state of Michigan.
 - 47% of GLVP families attended parent-teacher conferences in Fall 2023-24.
 - 47% of GLVP families attended parent-teacher conferences in Spring 2022-23.
- 7. ADDITIONAL INFORMATION ABOUT OUR SCHOOL AS REQUIRED PER STATE LAW:
 - GLVP currently offers a wide range of Advanced Placement (AP) courses. In the 2023-2024 school year, GLVP completed 24 AP courses. Students can earn college credits based on AP Exam results.



- 2023 2024 GLVP completed 5 AP classes. This number represents less than 1% of all GLVP students eligible to take an AP course.
- GLVP had 543 students dual enroll at a local college or university over the past two school years. This number represents approximately 43% of the student population.
- Last school year, GLVP students completed 1745 dual enrollment courses making them eligible to receive college credit. 100% of all GLVP students who dual enroll earn or are eligible to receive college credit.

GLVP provides students with a personalized learning plan and a challenging curriculum in an online setting. The curriculum features courses in Mathematics, Science, Language Arts, Foreign Languages, Social Studies, and other electives. There are opportunities for Advanced Placement and remedial levels as well.
