Dear family of a Hewlett High School Senior,

We invite you to apply! Every year the Central Council Scholarship Fund, Inc. awards scholarships to cover costs of post high school education/training to a number of graduating seniors who demonstrate financial need. How much we are able to grant varies from year to year, based upon donations to the Scholarship Fund. Central Council PTA encourages all eligible students to take advantage of the opportunity to apply, potentially to reduce the financial burden of a college/post high school education. A professional independent agent reviews each application to determine eligibility and the amount of the award. All students' personal information will be kept confidential and is not released to PTA.

Students must have applied for the Free Application for Federal Student Aid (FAFSA) and received the official acceptance to the college they are attending prior to applying for this scholarship. Please note that FAFSA must be filled out online at [www.fafsa.ed.gov](http://www.fafsa.ed.gov). We do not require the College Scholarship Service (CSS) for this scholarship; however, if you choose to provide it, the CSS can be found at [www.collegeboard.org](http://www.collegeboard.org).

Your application for this scholarship WILL NOT be processed unless a copy of your 2025-26 Student Aid Report is included with your scholarship materials, which will be released to the professional agent contracted by the Central Council PTA. In addition, we require the student's high school transcript which will also be forwarded to the third-party agent by Pupil Personnel Services. Please attach a copy of the acceptance letter to the college the student will be attending to the application form.

If you are interested in applying, please read the entire enclosed packet and submit your application with the required attachments by **June 1, 2025**. In order to ensure confidentiality, all applications should be placed in a sealed envelope that is labeled Hewlett-Woodmere Central Council PTA, Central Council Scholarship Fund, Inc. c/o Pupil Personnel Services, Attn: Mrs. Harrison and delivered to the High School.

If you wish to make a tax deductible donation to the Scholarship Assistance Fund, checks should be made payable to "Central Council Scholarship Fund, Inc." and mailed to 1 Johnson Place, Woodmere, NY 11598. ### **2025-26 FAFSA RELEASE (Mandatory)**

To be considered for a Central Council PTA Scholarship award, students **MUST** have completed the 2025-26 Free Application for Federal Student Aid (FAFSA) and must attach a copy of their processed Student Aid Report to this application.

The FAFSA application is available online at **[www.fafsa.gov](http://www.fafsa.gov)**.

There is no cost to apply for FAFSA.

Once the student registers with the College Scholarship Service (CSS), he/she will receive the CSS acknowledgment Data Confirmation Report. Please attach a copy of this report to the application if you would like the information to be used in the scholarship process.
