Superintendent Sandstrom reported on the work taking place to meet with secondary students in focus groups to hear their thoughts on a variety of topics regarding their instruction and other school experiences.	STUDENT FOCUS GROUPS
Superintendent Green reported on the site visits that took place with staff from the Harbor Learning Center as plans progress for the new school, as well as a tour of the proposed South Aberdeen site.	SEISMIC UPDATE
Executive Director of Business and Operations Elyssa Louderback presented the Fiscal Status Report for January. With 41.67 percent of the fiscal year elapsed, the district has received 37.92 percent of budgeted revenue and is at 41.21 percent of budgeted expenditures. Under enrollment, the report showed the final count for February was 4.76 average annual FTE above budget. Director Louderback said the budget implications are being watched carefully this year. She reported the following fund balances: \$2,402,474.50 in the General Fund, \$300,703.96. in the Capital Projects Fund, \$738,084.44. in the Debt Service Fund Summary, \$339,622.51 in the Associated Student Body Fund and \$347,641.28 in the Transportation Vehicle Fund. A recommendation for the purchase of a new bus is being prepared, she noted.	FISCAL STATUS REPORT
Director Louderback presented a report on enrollment trends showing a declining enrollment this year that has the district just 4.76 average annual FTE above budget. Current elementary enrollment of 1,208.16 FTE is 79.75 less than 2020- 2021 (COVID year). Enrollment of 697.55 at the middle school is 79.80 less than 2020-21. High school enrollment is up 83.95 since 2020-2021. Overall, K-12 enrollment is down 75.60 FTE since 2020-2021. Director Louderback reported she is developing a recommendation to budget for enrollment of 3,020 next year, which is a 1 percent reduction (about 70 fewer students). The board concurred. 



Haley & Aldrich, Inc. (Haley & Aldrich) is pleased to present this proposal to the Aberdeen School District No. 5 (District), to conduct a Phase I Environmental Site Assessment (Phase I ESA) of an approximately 99-acre parcel of land located north of Basich Boulevard in Aberdeen, Washington ("Site 3"), and an approximately 28-acre parcel of land located east of S. Evans Street in Aberdeen, Washington ("Site 4"). It is our understanding that both sites are currently vacant and undeveloped.

Project Understanding

Haley & Aldrich recently performed geotechnical and seismic evaluations of several existing school campuses within the District, the results of which indicate that these campuses will be subject to significant seismic hazards in the event of a major earthquake along the Cascadia Subduction Zone. Retrofit of the structures at these campuses may not be cost-effective, and we understand that the District is interested in performing preliminary studies to evaluate relocation options for these schools to more geotechnically favorable sites in Aberdeen. Haley & Aldrich recently performed a geotechnical study for one such site located at the intersection of East 3rd Street and North H Street (Site 1), while investigation of a second site (Site 2), located east of Grays Harbor College, was not completed due to the extensive presence of mapped wetlands. We understand that the District now intends to evaluate two new potential relocation sites designated Sites 3 and 4.

Site 3 is a 99.28-acre, roughly triangular-shaped parcel located northwest of Basich Boulevard near the intersection with Harborview Drive in northern Aberdeen. We understand that, conceptually, the proposed school structures would be located in the northern portions of this site. Electrical transmission

lines supported by steel truss transmission towers cross through the southern portion of the site in a roughly east to west configuration. The site is otherwise undeveloped and largely tree covered.

Site 4 is a 28-acre, rectangular-shaped parcel located in southern Aberdeen, bordered by housing developments to the west and south and undeveloped forested lands to the north and east. Historical photos indicate that the site was heavily forested as recently as 2018. Site topography slopes up toward the south to southwest, from a low elevation of approximately 14 feet to a high elevation of about 120 feet. We understand that proposed school structures, conceptually, may be located in the southern portion of the site in the higher elevation areas. Anecdotally, a lumber mill may have been present on this site historically.

We understand that the District does not own either property. TCF Architecture PLLC (TCF) and the District are requesting a proposal from Haley & Aldrich to perform Phase I Environmental Site Assessment studies at Sites 3 and 4 to help inform the District's decisions regarding acquisition of the subject sites.

Scope and Costs

The work scope for a Phase I ESA is based on the ASTM International (ASTM) E1527-21 standard for Phase I ESAs. Following this standard in performance of a Phase I ESA will satisfy the U.S. Environmental Protection Agency's All Appropriate Inquiries (AAI) rule in evaluating the environmental condition of a property prior to property acquisition. A complete work scope for a standard Phase I ESA is included in Attachment I.

Below, we have provided cost estimates for each parcel (one for Site 3 and one for Site 4). We suggest two separate reports for each parcel because the historical and environmental records to be searched as part of a Phase I ESA will be different for each property. Additionally, each site is owned by a different property owner and a separate Phase I ESA document will make it easier to combine with other documents for each parcel, if the District moves forward with acquisition.

The costs below anticipate that we can conduct the site visits for both parcels on the same day, thus providing a cost savings to the District for one mobilization to conduct the site reconnaissance. Two separate reports will be prepared (one for each site). The cost estimate will increase by approximately \$500 if the District authorizes only one Phase I ESA.

Haley & Aldrich's scope of services and associated costs are summarized in the table below. A complete work scope for the Phase I ESAs is included in Attachment I.

1. Cost estimate is per site, based on a combined site visit for a total cost of \$18,500. If the District intends to authorize only one site, the cost for one site would increase from \$9,250 to \$9,750.

These user responsibilities are further described in Attachment I and in the User Responsibilities Questionnaire in Attachment II.

We request that you provide the user-provided information described in Attachment I and the paragraph below to us. Though it is not required by the AAI Rule or the ASTM E1527-21 Standard that this information be provided to Haley & Aldrich, failure on the part of the user to obtain such information for their own records, should it be reasonably ascertainable, may invalidate the user's compliance with the AAI Rule for CERCLA liability protection in the future.

To meet the requirements of 40 CFR 312, a search for the existence of environmental liens, deed restrictions, engineering/institutional controls, Activity and Use Limitations (AULs), etc., that are filed or recorded against the subject property must be conducted by the user. The scope of work included in Attachment I includes a search of those records as part of the database search, with the exception of a lien search. We understand that as part of your due diligence you will either engage a title company, real estate attorney, or title professional to undertake a review of reasonably ascertainable recorded records for environmental liens deed restrictions, engineering/institutional controls, AULs, etc., currently recorded against or relating to the subject property. If you would instead like us to include a lien search as part of our assessment, this can be conducted at an additional cost of \$400 per tax lot.

Scope of Services

The scope of services below summarizes Haley & Aldrich, Inc.'s proposed environmental professional services required to complete an environmental site assessment and "All Appropriate Inquiry" (AAI) for a parcel of commercial real estate with respect to the range of contaminants within the scope of the Comprehensive Environmental Response, Compensation and Liability Act (CERCLA) (42 U.S.C. §9601), in accordance with Code of Federal Regulations Title 40 (40 CFR) Part 312.20 (AAI), to permit a user to satisfy one of the requirements to qualify for CERCLA's innocent landowner defense, contiguous property owner liability protection, or bona fide prospective purchaser liability protection (landowner liability protections or LLP).

Title 40, Part 312.11 of the Code of Federal Regulations provides that the procedures of ASTM International (ASTM) Standard E1527-21 entitled "Standard Practice for Environmental Site Assessments: Phase I Environmental Site Assessment Process" (ASTM E1527-21) may be used to comply with the requirements of 40 CFR 312, AAI.

The goal of ASTM E1527-21 is to assess whether recognized environmental conditions (RECs) exist at the subject property. A REC as defined by ASTM E1527-21 means: (1) the presence of hazardous substances or petroleum products in, on, or at the subject property due to a release to the environment; (2) the likely presence of hazardous substances or petroleum products in, on, or at the subject property due to a release or likely release to the environment; or (3) the presence of hazardous substances or petroleum products in, on, or at the subject property under conditions that pose a material threat of a future release to the environment.

Please provide contact information for the "key site manager" so Haley & Aldrich can arrange a mutually convenient appointment to interview the key site manager. We also ask that you advise all known past and present owners, operators, and occupants of our site visit so we may interview a number of them as required by ASTM E1527-21. Lastly, in accordance with the ASTM E1527-21 Standard, we request that you arrange to have assembled and available to Haley & Aldrich, on the day of our subject property visit, or as soon as possible, copies of any previous environmental documents (user-provided information), including: environmental site assessment reports, environmental compliance audit reports, environmental permits, registrations for underground and above-ground storage tanks, registrations for injection systems, material data safety sheets, community right-to-know plan, safety plans, spill prevention plans, emergency preparedness plans, hydrogeologic reports for the subject property, any government notices concerning the subject property, hazardous waste records and reports, geotechnical studies, risk assessments, recorded Activity and Use Limitations (AULs), environmental land use restrictions (ELURs), or environmental liens.

- Interviews with State and/or Local Government Officials Haley & Aldrich shall reasonably attempt to interview applicable state and/or local government officials to obtain information indicating RECs in connection with the subject property.

Haley & Aldrich's services will be performed in accordance with generally accepted practices of engineers and/or scientists providing similar services at the same time, in the same locale, and under like circumstances ("Standard of Care"). No warranty, expressed or implied, is included or intended by this Agreement.
- 4. <u>CLIENT RESPONSIBILITIES</u>. Except as otherwise agreed, Client will secure the approvals, Site access, permits, licenses, and consents necessary for performance of Haley & Aldrich's services under this Agreement. Client shall provide Haley & Aldrich with a plan delineating the boundaries of the Site and all documents, reports, surveys, plans, drawings, information concerning known or suspected Site conditions, above and below ground, information related to hazardous materials or other environmental or geotechnical conditions at the Site, utility information and other information that is reasonably foreseeable to be pertinent to Haley & Aldrich's services under this Agreement. Haley & Aldrich shall not have any liability whatsoever for any failure of contractors to comply with any laws, rules, regulations, ordinances, codes or orders. - 16. <u>ADDITIONAL SERVICES</u>. Neither party, nor their parent, affiliated or subsidiary companies, nor the officers, directors, agents, employees, or contractors of any of the foregoing, shall be liable to the other in any action or claim for incidental, indirect, special, collateral, punitive, exemplary or consequential damages arising out of or related to the services, whether the action in which recovery of damages is sought is based upon contract, tort (including, to the greatest extent permitted by law, the sole, concurrent or other negligence, whether active or passive, and strict liability of any protected individual or entity), statute or otherwise.
- 18. <u>WAIVER OF PERSONAL LIABILITY</u>. No officer, director, or employee of Haley & Aldrich shall bear any personal liability to Client for any injuries, claims, demands, losses, expenses or damages, of whatever kind or character, arising out of or in any way related to this Agreement or the performance of services hereunder.
- 19. LIMITATION OF REMEDIES. AGREEMENT FOR INTERDISTRICT COOPERATIVE EDUCATIONAL SERVICES 2025-2026 SCHOOL YEAR

This Agreement is hereby entered into by and between New Market Skills Center, Tumwater School District No. 33, Thurston County No. 34, Washington, collectively referred to as the "SERVING DISTRICT," and

Aberdeen School Distict, Grays Harbor County hereinafter referred to as the "PARTICIPATING DISTRICT".

The purpose of this Agreement is to utilize interdistrict cooperation, authorized by RCW 28A.335.160, RCW 28A.225.250, and Chapter 392-135 WAC, to provide educational programs not otherwise available to students residing in the Participating District and to avoid duplication of specialized programs and facilities. These objectives will be achieved by the attendance of the Participating District's students in courses offered at New Market Skills Center (NMSC).

This Agreement is for the 2025-2026 school year, and it was approved by each respective Board of Directors on the date indicated below. **NMSC** anticipates serving an estimated number of between 1-5 students from **PARTICIPATING DISTRICT** for the 2025-2026 school year. It is understood that students attending **NMSC** from the **PARTICIPATING DISTRICT** will be funded for all NMSC classes up to 1.6 full time equivalents as determined by the Office of the Superintendent of Public Instruction per RCW 28A.245.020.

In addition, as directed by NMSC's Administrative Council and in accordance with WAC 392-600-030(7), it is hereby understood and agreed that for the 2025-2026 school year the **PARTICIPATING DISTRICT**, due to its status as a non-consortium district, will be required to pay a \$300 per FTE student per year fee, with said fee to be placed in the **SERVING DISTRICT'S** Capital Investment Fund. This fee will be reviewed annually by the NMSC's Administrative Council.

This agreement also provides **NMSC** permission to access student address information from the data resource management center of the **PARTICIPATING DISTRICT** to be used for mailing newsletters, program brochures, summer school information, and student information.

CONTRACT FOR SERVICES BETWEEN ABERDEEN SCHOOL DISTRICT #5

(hereinafter referred to as ASD #5)

216 North "G" Street Aberdeen, WA 98520

The City of Aberdeen Fire Department (hereinafter referred to as AFD)

In consideration of the promises and conditions contained herein, ASD #5 and AFD enter into this agreement to provide students a summer Introduction to Fire Science class and do mutually agree as follows:

I. DUTIES OF AFD

AFD shall perform the following duties to the satisfactions of ASD #5's designee: A. The general objectives(s) of this contract shall be as follows:

To provide students enrolled in the Twin Harbors Branch Skills center a 13 day Introduction to Fire Science class

- B. In order to accomplish the general objectives(s) of this agreement, AFD shall perform the following specific duties:
 - Provide instructor(s) for the program who will meet certification requirements including fingerprinting and teacher certification application requirements in collaboration with the Twin Harbors Branch Skills Center Director; process for teacher certification will be completed by May 1, 2025
 - Provide classroom space, necessary curriculum, all necessary training, equipment, training grounds and personal protective gear necessary for successful implementation of the summer Introduction to Fire Science program
 - Implement the Introduction to Fire Science program in accordance with the mutually developed curriculum framework submitted to OSPI for approval
 - Provide final grades for each enrolled student based on evaluation of progress and units of instruction identified in the curriculum framework
 - Keep records for attendance and grades
 - Provide students the opportunity to earn industry certification in First Aid/CPR

- c. The time schedule for completion of AFD's duties shall be within the program dates:
 - Summer: 13 days to conclude by July 31, 2025

II. DUTIES OF ASD #5

In consideration of AFD's satisfactory performance of the duties set forth herein, ASD #5 shall partner with the AFD program as follows:

- A. Except for expressly provided herein, expenses necessary to AFD's satisfactory performance of this agreement shall be invoiced to ASD #5 by July 31, 2025. Expenses may include staff time, materials and supplies for enrolled students and certification costs for students, not to exceed \$6,000.
- B. ASD #5 will provide an administrator to oversee student enrollment,
- c. ASD #5 will provide a classroom space as needed.
- D. Transportation will be provided for students to and from the skills center/high school facility.
- E. ASD #5 will provide breakfast and lunches for students on each class day.

III. PROHIBITION AGAINST ASSIGNMENT

Neither this contract nor any interest therein may be assigned by either party without first obtaining the consent of the other party.

IV. INDEPENDENT CONTRACTOR STATUS

AFD and AFD's employee(s) and agents(s) shall perform all duties pursuant to this agreement as an independent contractor. District shall not control or supervise the manner in which this agreement is performed nor withhold or pay taxes on behalf of AFD or AFD's employee(s) or agent(s).

V. INDEMNIFICATION

To the fullest extent permitted by law, AFD agrees to defend, indemnify and hold harmless ASD, its directors, volunteers, students and employees from and against all expenses, damages, losses, claims, and liabilities, direct, indirect or consequential (including attorney fees incurred on such claims and in proving the right to indemnification), arising out of or resulting from the acts or omissions of AFD or the operation of the 21st Century program at ASD.

Similarly, ASD agrees to defend, indemnify and hold harmless AFD, its directors,

officers, and employees from and against all expenses, damages, losses, claims brought by third parties, and liabilities, direct, indirect, or consequential (including attorneys fees incurred) arising out of or resulting from the acts or omissions of ASD and/or its employees relating to the operation of the Introduction to Fire Science program.

VI. TERMINATION

This Agreement may be terminated by either party, at any time, upon written notification thereof to the other party. The notice shall specify the date of termination. This written Agreement constitutes the mutual agreement of AFD and ASD #5 in whole. No alteration or variation of the terms of this Agreement and no oral understandings or agreements not incorporated herein, unless made in writing between the parties hereto, shall be binding.

VI. APPLICABLE LAW

This agreement shall be governed by the laws of the State of Washington.

I. NON-DISCRIMINATION

No person shall, on the ground of race, creed, color, national origin, religion, sex, sexual orientation including gender expression or identity, the presence of any sensory, mental or physical disability be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under any activity performed pursuant to this Agreement.

II. EFFECTIVE DATE-DURATION

This Agreement shall commence on the 1st day of May, 2025. This agreement shall terminate at midnight on the 31st day of July 2025, with the sole exception of Section V (Indemnification) which shall continue to bind the parties.

III. FEDERAL BACKUP WITHHOLDING INFORMATION

AFD certifies to ASD #5 that AFD is not subject to backup withholding under Section 3406(a)(1)(c) of the Internal Revenue Code. AFD agrees to notify ASD #5 in writing if this information is not true.

IV. CERTIFICATION REGARDING DEBAREMENT, SUPERVISION, AND ELIGIBILITY

The contractor certifies that neither it nor its principals are presently debarred, declared ineligible, or voluntarily excluded from participation in transactions by any Federal

department or agency.


