- collusion -- Supporting malpractice by another student, as in allowing one's work to be copied or submitted for assessment by another.
- duplication of work - Presentation of the same work for different assessment components and/or IB requirements.
- any other behavior that gives an unfair advantage to a student or that affect the results of another student (falsifying data, misconduct during an examination, creating spurious reflections)

Academic Honesty for Students

Guilford County students will graduate responsible and College or Career ready citizens, prepared to succeed in Higher Education. Hairston Middle School will provide excellence and responsible teaching, learning necessary for their development of positive character and profiles.

Students are taught through the learning profiles and the system's character development initiatives the expectations that contribute to positive success in a global society.

The following are shared with both the student and parent electronically and printed in the appropriate translations:

- **Plagiarism** - students may not present the work or ideas of another person as though it is their own
- **Copyright** – students may not copy, download, or share any type of copyrighted material (including music or movies) without the owner's permission. This is illegal and result in civil and criminal penalties.
- **Cheating**- Students agree to the stipulations set forth in the above document including the Guilford County Schools Amplify Tablets Acceptable Use Guidelines and the Acceptable Use Policy (AUP) for Technology
- **Integrity**- students agree to act with honesty and forthrightness, holding to high academic and ethical standards, and dealing with everyone with respect.
- **Acceptable Use of Electronic Transmission Capabilities**- recognizes that technology and the Internet offer students and staff the resources of thousands of computers all over the world and to millions of individual people. Students, teachers and staff may have access to: 1) electronic mail (e-mail) communication with people all over the world; 2) information and news, some of which may include advertisements, from a variety of sources and research institutions; 3) discussion groups on a wide variety of topics; 4) access to many university libraries, the Library of Congress and other libraries around the world.
- **Act of Deception**-Students shall not engage in any act of deception or falsification of work product. This includes cheating by receiving any unauthorized aid or assistance or the actual giving or receiving of unfair advantage on any form of academic work, plagiarism by copying the language structure, idea and/or thought of another and representing it as one's own work, and a verbal or written statement of untruth.
