FACILITY RENTAL FEES

ORGANIZATIONS AFFILIATED WITH THE SCHOOL DISTRICT – <u>PTA/PTO, PSEA, Booster Organizations,</u> <u>Recreation Commissions, etc. will not be charged the rental fee.</u> <u>They will, however, be responsible for</u> <u>paying any expenses the District must pay to custodians, kitchen help, stagehands, audio visual help, etc.</u> <u>for wages.</u> There will be no charge for using school facilities for voting purposes.

ORGANIZATIONS NOT AFFILIATED WITH THE SCHOOL DISTRICT WILL BE REQUIRED TO SUBMIT A DOWN PAYMENT (DEPOSIT) PRIOR TO THE EVENT.

1. RENTAL OF MIDDLE SCHOOL AUDITORIUM OR SENIOR HIGH LECTURE HALL

- \$300
- One Rehearsal is included in this rate. Additional Rehearsals are **\$100** each.
- If the Middle School Auditorium is rented with the Expanded Sound System the charge will be as stated above plus: \$50/HOUR FOR SOUND CONSOL OPERATOR, \$10/HOUR FOR STUDENT STAGE CREW, \$25/HOUR FOR A.V. & STAGE CREW SUPERVISORS

2. RENTAL OF CLASSROOMS

3. RENTAL OF CAFETERIAS

 - Tiger Baseball Field **\$150/Game (Lights/Scoreboard-Additional \$100/game)** Daily Maximum **\$300**
 - Concession Stand \$150 (A Deposit of \$150 is Required to Rent the Concession Stand)
 - North Baseball Field **\$50/Game**
 - North Softball Field **\$50/Game**
 - North Practice Field **\$50/Day**
 - Joe Namath Practice Football Field \$100/Game (Scoreboard Available for \$50)
 - High School Tennis Courts **\$50/Day**
 - North Basketball Courts \$50/Day
 - Elementary Athletic Fields **\$50/Day**
