Bid opening will be held Monday, March 31, 2025 at 11:00 AM at the Blount County Board of Education CNP Office. Bids may be mailed to the attention of Megan Mitchell, Child Nutrition Program Director, Blount County Board of Education, 415 5<sup>th</sup> Avenue East, Oneonta AL, 35121 or hand delivered at the bid opening. Bids will be publicly opened and read promptly at 11:00 AM on Monday, March 31, 2025. No bids will be accepted once the opening begins. Please note any requirements listed on the response form and bid specification sheet.

Blount County Schools reserves the right to award the bid based on budgetary limits approved by the Alabama State Department of Education.

The responsible bidder shall be responsible for delivery, installation, and training to the specified school.

Bidders are to use the bid response form included in this packet and guarantee the quality of work to meet or exceed specifications set forth in this bid request.

Each party shall follow the procedure outlined below if this contract is to be terminated. All transactions shall be sent by Registered or Certified mail.

- Step 1: Issue warning letter and outline violations and length of time allowed to correct the problem.
- Step 2: Issue letter of intent to cancel contract if problem is not resolved by given date.
- Step 3: Issue letter to cancel contract.

#### **GENERAL CONSTRUCTION:**

## A. Counter Tops

Counter tops to be 14-gauge stainless steel. All exposed edges to have a straight turndown as specified. All corners to be fully welded. Top to have equal to a #4 finish with corner edges ground and polished to match. Tops enclosed base counters and serving counters to be braced with hat channel galvanized bracing stud bolted to the underside of top and furnished with cadmium plated lock nut fasteners.

### **B.** Counter Body

Body of the counter is constructed of 18-gauge stainless steel side panels and 14-gauge galvanized bottom. All exterior sides are reinforced with overlapping corners and are welded in place. All body cutouts are reinforced with 14-gauge galvanized channel supports. Counter exterior front, rear, and ends will be 18-gauge stainless steel covered with plastic laminate. Bottom of the counter will be closed and furnished with heavy gauge channels for mounting the legs or casters. Counter bodies to be trimmed with 18-gauge stainless steel corner angles and bottom trim strips.

- a. As called for in itemized specifications, provide 18-gauge stainless steel louvered panels.
- b. Counter bodies to be constructed to appear as a continual counter when installed together.

#### C. Hot Food Wells

Food Wells to be electric dry-moist insulated built-in style with die-stamped drawn 12" x 20" individual 20-gauge wells. Each well is equipped with a heating element rated and 1000 watts furnished with individual infinite temperature controls and indicator lights prewired to a control panel. Wells insulated on all sides with 1" of fiberglass and bottom to have 2" of fiberfrax blanket insulation. Each hot food well is furnished with a ½" stainless steel drain that is connected to a manifold and routed to a common connection point and furnished with a gate valve shut off. The wells include the Delfield 204C auto fill option.

#### D. Cold Pan

Cold Pan to be built-in style the length as described in the itemized specification. Cold pan to be 21.62" wide x 7" deep with a 2" recessed stainless steel top and stainless-steel interior liner. The sides of the pan have copper refrigeration coils attached and sealed with thermal transfer compound. The pan is then fully insulated with polyurethane foam and furnished with 18-gauge galvanized exterior. Each cold pan is furnished with a prewired control panel with face mounted switch. Pan to have 1" drain extended to shut-off valve below bottom of counter. A self-contained refrigeration system is suspended below the cold pan on a 16-gauge galvanized frame and uses environmentally friendly R290 refrigerant. Cold pan designed to meet NSF-7 standard requirements.

#### E. Two Tier Flexi Top Shelf

Two tier flexi shelf is constructed with a stainless-steel exterior with an aluminum inner shelf surface. Heaters and refrigeration lines are secured to the bottom of each aluminum shelf to ensure even distribution of frost and heat. The shelves are designed to operate hot from 100-180 degrees F and cold from 0 - 20 degrees F, independent of each other. The complete assembly is insulated with urethane foam, isolating a full perimeter stainless steel drain trough for each shelf. The R-290 refrigeration system for the shelves is in the counter body and features a control panel on the counter side with rocker switches for each shelf to change the temperature mode. A stainless steel over shelf is mounted above the upper shelf. Each shelf includes a 616B LED light fixture, and a double service fixed tempered glass sneeze guard.

#### F. Casters

Where specified, counters are to be mounted on SG32C Adjustable Height 5" polyurethane casters. Casters are attached to the counter bottom and designed to be removable in the field for servicing or replacement. Casters will all have brakes.

#### G. Stainless Steel Kick Plates

Counter sections are to be supplied with SG-23 Stainless Steel Kick Plates. Kick plates to be removable for cleaning and access to the counter electrical connections and plumbing.

# H. Self Service Double Sided Single Tier Sneeze Guards

FlexiShield Sneeze guards will have a 3/8" tempered glass serving shelf with sloped front and rear 1/4" tempered glass sneeze guards and 1/4" tempered glass end panels. All glass includes chrome plated hardware, uprights and framing to be 1" tubular stainless steel. Guards are attached to the counter tops with flanged feet with a decorative stainless steel cover plate.

### I. Display Lights

Where specified, provide LED display light fixtures mounted below the sneeze guard shelves. Light fixtures are to be interwired to a switch mounted in the counter control panel and to a junction box in the counter body. All wiring for the display lights is to be run through the stainless-steel tubing supports for the sneeze guards.

#### J. Counter Junction Boxes

As specified, the serving counter sections will be wired to a junction box and provided with a cord and plug. All counter sections with electrical will be UL Listed with a label attached.

#### K. Tray Slides

Tray Slides to be #B-36 V-rib solid style stainless steel, 10" wide. Slides will be mounted to the counter with 14-gauge stainless-steel drop-down style knife type brackets bolted to the counter body. Tray Slide height will be the same height as the counter top unless otherwise specified.

#### L. Warranty

- 1. Two (2) Year Parts and Labor for the food wells and cold pan.
- 2. Seven (7) Years Parts warranty on the refrigeration compressor.

- 5. Four (4) Model 313U tempered glass sneeze guards attached to the stainless-steel display shelves.

- 8. Counter dimensions will be 80" x 31"

- 4. Counter rear will have a hinged door for access to the cabinet base for storage.
- 5. Dry storage base with center shelf.

- 7. Counter dimensions will be 49" x 31". The right end of the counter will be recessed 7-1/2" to accommodate outlet/plugs on the adjoining utility wall.

- 9. Counter top will have a 4" x 15-1/2" x 6" high 3-sided service chase with a top to route the water, power, and drain lines to the counter base for the Ice-O-Matic Dispenser Model GEMD270A2.
- 10. Counter bottom shelf will have a 4" x 15-1/2" opening to route the utility connections from the chase to the water, power, and drain locations in the floor below the counter.
- 11. Counter is mounted on SG32C 5" adjustable height casters all with brakes.

- 5. Stainless steel exterior with Wilson Art Black Matte 1595-60 laminate on the front and sides.
- 6. Stainless steel rear finish.
- 7. Hinged door on the counter front for access to the base storage area with a mid-shelf.
- 8. Stand is mounted on SG32C 5" adjustable height casters all with brakes.

#### SCOPE OF WORK

#### **Food Service Dealer**

- 1. Coordinate with the Delfield factory representative to review all drawings for approval.
- 2. Access is from a loading dock through a single door. Tray slides may need to be removed for access.
- 3. Deliver and set in place the new serving lines items.
  - a. Remove all PVC protective coating from the serving line counters.
  - b. Level the counters and connect the individual counters together.
  - c. Remove all cartons and crates.
- 4. Provide the specified plastic pans for the serving lines.

#### **School System**

- 1. Provide access to the building for the food service dealer and related trades to complete the work required.
- 2. Disconnect and remove the existing serving line from the serving area.
- 3. Provide updated electrical receptacles for the new serving line counter sections.
- 4. The existing electrical conduit is to be reused.
- 5. In the event the conduit cannot be reused, the school system will provide new conduit to the receptacles.
- 6. Provide a plumber to connect a tail pipe to cold pan drain valves and route to the floor drains located under the counters.
- 7. Inspect the job for final approval.

#### INSTALLATION GUIDELINES

- Awarded Bidder is responsible for verifying all dimensional, utility and layout requirements at Hayden Elementary School, before ordering the new serving system.
- Awarded Bidder is responsible for delivering, uncrating, setting in place, and leveling the new serving system.
- Awarded Bidder is responsible for making all internal electrical connections to the new serving system.
- Blount County Schools will be responsible for providing access to the building for the food service dealer and related trades to complete the work required.
- Blount County Schools will be responsible for removing and disposing of existing serving equipment.
- Blount County Schools will be responsible for any and all utility upgrades required to accommodate new serving system and associated equipment.
- Blount County Schools will be responsible for making final electrical connections to new serving system and associated equipment.

It is not the policy of the Blount County Board of Education to purchase on the basis of low bid only. Quality, conformity with specifications, purpose for which required, terms of delivery, transportation charges, and dates of delivery are factors which may be used to determine the low responsible bidder. Bidders must abide by the provisions of the Americans with Disabilities Act of 1990 in order to provide goods or services to the Blount County Board of Education.

Section 9 of the Alabama Immigration Act No. 2011-535 (<a href="http://www.ago.state.al.us/File-Immigration-AL-Law-2011-535">http://www.ago.state.al.us/File-Immigration-AL-Law-2011-535</a>) requires contractors provide the Alabama Department of Education with an Affidavit of Immigration Compliance and the contractor's E-Verify Memorandum of Understanding as a condition of the award of any contract. These two documents must be included with the bid. If you do not believe these requirements are applicable to your entity, include an explanation justifying such exemption. The successful bidder must provide a copy of their current Blount County business license (if applicable) before the bid can officially be awarded by the Blount County Board of Education. A bid that does not contain a price for each item may not be considered.

Payment will be made by the school system upon receipt of invoice, inspection, and acceptance by a designated employee of the Blount County Schools system.

The Blount County Board of Education reserves the right to reject any and all bids and to award the bid in a manner deemed to be in the best interests of the Blount County Schools system. In the event that any provisions of the bid award or written contracts emanating from the award is in conflict with Alabama's bid law, the bid award and resultant contract are declared null and void.

The vendor's representative must complete and sign the attached Itemized List Bid Proposal form, Vendor Certification page, and the form titled "Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion – Lower Tier Transactions."

Envelopes containing bids should be sealed and clearly marked on the outside, <u>CNP Bid 2025-01</u> due <u>Monday</u>, <u>March 31, 2025 at 11:00 AM</u>.

#### **GENERAL INSTRUCTIONS TO BIDDERS**

Listed below are instructions to bid on this project for the Child Nutrition Program of Blount County Schools:

- 1. All bid quotations shall include delivery under conditions specified. Bidder shall be responsible for removal of existing equipment if applicable, disposal of said equipment, installation of all new equipment, and final connections; unless otherwise noted in Specification Installation Guidelines.
- 2. Sealed bids may be mailed to: Megan Mitchell, Child Nutrition Program Director, Blount County Board of Education, 415 5<sup>th</sup> Avenue East, Oneonta AL, 35121.
- 3. No oral, telegraphic, or telephone proposals or modifications will be accepted. The bidder, before submitting a proposal, shall carefully examine the specifications to be fully informed as to all conditions and limitations.
- 4. Unit Cost prices are not to exceed two decimal places. The decision of the Blount County Board of Education will be final on any question of pricing.
- 5. USDA regulations prohibit schools from paying service charges and/or interest. Vendors are thus prohibited from making such charges.
- 6. The bid will be awarded to the most responsible bidder meeting all requirements of the identifications listed herein.
- 7. It is the intent of Blount County Schools to award the bid as a total package bid award; however, the Board reserves the right to award the bid in any manner which will best serve the needs of Blount County Schools.
- 8. By submitting bids, all vendors agree to and accept the provisions of the specifications and considerations.
- 9. Any requests for substitutions to the items listed in this Invitation to Bid must be received and approved by the CNP Director by Monday, March 3, 2025. Reasons for requesting the substitution must be specified in comparison to the specifications of this bid document. A copy of any approved substitutions will be sent to all vendors in an amendment.
- 10. All bids submitted must be valid for a minimum of 60 days after the bid opening date. Equipment to be delivered within 90 days from the date of the issuance of the purchase order.

- 11. The Initial Contract Term shall continue in effect from the effective date for a one-year period and shall expire on the last day of the Contract Term unless the Blount County Board of Education and the successful bidder mutually agree to exercise the contract extension option. Upon mutual agreement, both Parties may elect to extend the initial contract term for a period of up to 4 years, in one-year increments. Such extension(s) shall be contingent on successful bidder's consent to honor its original bid prices pursuant to all terms, conditions, and stipulations specified herein. Contract Extension(s) shall be subject to Blount County Board of Education approval prior to the Contract Term's Expiration Date.
- 12. The Blount County Board of Education reserves the right to terminate the contract award for nonperformance or a material breach of stipulated terms and conditions set forth in this Invitation to Bid. In the event a contract is terminated for non-performance, the Blount County Board of Education reserves the right to award this bid to the next Lowest Responsible Bidder pursuant in accordance with Alabama Code Section 16-13B-1 et. seq (Alabama Competitive Bid Law). Procedures for termination of contracts. 1. Verification. Upon receipt of a written report of acts or causes which may constitute ground(s) for termination as aforementioned, or upon its own initiative, the Implementing Unit shall, within a period of seven (7) calendar days, verify the existence of such ground(s) and cause the execution of a Verified Report, with all relevant evidence attached. GPPB Resolution No. 018-2004 dated December 22, 2004, Annex "A" Page 4 of 6 Annex "A" 2. Notice to Terminate. Upon recommendation by the Implementing Unit, the Head of the Procuring Entity shall terminate contracts only by a written notice to the Supplier/Contractor conveying the termination of the contract. The notice shall state: a) that the contract is being terminated for any of the ground(s) afore-mentioned, and a statement of the acts that constitute the ground(s) constituting the same; b) the extent of termination, whether in whole or in part; c) an instruction to the Supplier/Contractor/Consultant to show cause as to why the contract should not be terminated; and d) special instructions of the Procuring Entity, if any.
