Dear Parent/Guardian:

I hope the school year is off to a successful start for you and your child. I am writing this letter to let you know that *Ronald E. McNair Elementary School* has been designated as a Targeted Support & Improvement Additional Targeted Support (TSI-AT) school by the North Carolina State Board of Education. Per ESSA Section 1111(d)(2), schools are identified as TSI-AT schools in North Carolina because one or more of the following subgroups received a subgroup performance grade score at or below the highest identified CSI-LP school's All Students group during the identification year; and is on the TSI-CU list for the subgroup(s) for the previous year. Subgroup performance scores are provided for the following subgroups: (1) Students with Disabilities, (2) Economically Disadvantaged, (3) Black, (4) White, (5) Hispanic, (6) Asian-Pacific Islander, (7) Multi-racial, and (8) English Learners. This letter is to notify our parents and guardians of *Ronald E. McNair Elementary School* intentions to improve educational outcomes for underperforming student subgroups and close achievement gaps for all students.

As a TSI-AT (ATSI) school, *Ronald E. McNair Elementary School* is required to develop an Additional Targeted Support and Improvement (ATSI) plan that specifically addresses how the school will improve outcomes for underperforming subgroups. The plan will also include strategies that our district or charter will employ to support *Ronald E. McNair Elementary School* improvement efforts. The ATSI plan will address the following areas:

- Classroom Management
- Standards-aligned Instruction
- Professional Learning Communities (PLCs)
- Instructional Leadership
- Recruitment & Retention of Effective Teachers
- Support for Grade-to-Grade Transitions
- Implementation of a Tiered Instructional System
- Data-Driven Decision Making
- Student Support Services
- Family and Community Engagement

We have set the following goals for *Ronald E. McNair Elementary School* this year:

- By the end of 2024-25, McNair Elementary will increase 2023-24 Reading Proficiency of 38.1% by at least 3 percentage points.
- By the end of 2024-25, McNair Elementary will increase 2023-24 Math Proficiency of 40.3% by at least 3 percentage points.
- By the end of 2024-25, McNair Elementary will increase 2023-24 Science Proficiency 56.6% by at least 3 percentage points.
- By the end of 2024-25, McNair Elementary will decrease the 2023-24 percentage (31) of students who were chronically absent by 5 percentage points.
- By the end of 2024-25, McNair Elementary will decrease the 2023-24 number of lost instructional days (13.97) due to In-School Suspensions and Out-of-School-Suspensions by 10%



Here are some strategies that we will be implementing to improve student outcomes:

- A multi-tiered support system to support all student learning.
- Continued implementation of CKLA (Core Knowledge Language Arts)
- Continued implementation of Eureka Math
- A system for regular communication with parents about academics. Title-I funds will be allocated for parent engagement.

Also, parent engagement is at the heart of our school improvement efforts. Here are some ways we can work together:

- Ensure that both you and your child know the academic expectations set for your child this school year. A list of learning objectives in student-friendly language is available from your student's teacher(s).

- Make sure that your child is prepared and attends school each day.
- Monitor your child's homework.
- Monitor the progress your child is making and attend meetings with your child's teacher(s).
