

## Estimate of Time Spent on State Required Assessments (High School EOC Assessments)

At the high school level, based on course enrollment, the following End-of-Course assessments are required:

- End-of-Course Assessment for Biology
- End-of-Course Assessment for English II
- End-of-Course Assessment for NC Math 1
- End of Course Assessment for NC Math 3

In Guilford County Schools, each school selects the administration date for assessments within the state-mandated test window. The administration date selected by the school must fall within the testing window and adhere to all procedural requirements outlined by the North Carolina Department of Public Instruction (NCDPI).

### For the End-of-Course Assessments:

The chart below details the estimated time for each assessment, which is the time that the NCDPI estimates it will take nearly all students to complete the assessment. The NCDPI does allow ALL students some time beyond the estimated time. However, each EOC assessment has a maximum time allowed.
