Please revise the following bidding instruction to read as follows:

“BIDDING SUBSTITUTES: LINE ITEMS 1 – 20 – The specifications listed herein are not to be considered restrictive to one source of supply. However, items offered must be equal in quality and performance.”

Q: Do you accept a width size of 5 inches for lines 1-9?
