1. Call to Order

2. Act on the Articles of the Meeting

• *ARTICLE 1 To elect a moderator for a one-year term*

Mr. Cecchinelli opened the floor for nominations.

Mrs. Leclerc nominated Tom Koch. Mr. Boutin seconded the nomination.

Ms. Reynolds nominated Giuliano Cecchinelli, no second.

There were no additional nominees. Nominations were closed.

On a motion by Mrs. Leclerc, seconded by Mr. Boutin, the assembly voted to elect Tom Koch to serve as Moderator for a one-year term, the motion passed.

• *ARTICLE 2 To elect a clerk for a one-year term*

The Moderator opened the floor for nominations.

Mr. Reil nominated Tina Lunt. Mr. Boutin seconded the nomination.

There were no additional nominees. Nominations were closed.

On a motion by Mr. Reil, seconded by Mr. Boutin, the assembly voted to elect Tina Lunt to serve as Clerk for a one-year term, the motion passed.

• *ARTICLE 3 To elect a treasurer and assistant treasurer for a one-year terms*

The Moderator opened the floor for nominations.

Ms. Reynolds nominated Ashley Young as treasurer and Craig Farnham as assistant treasurer. Mr. Cecchinelli seconded the nominations.

There were no additional nominees. Nominations were closed.

On a motion by Ms. Reynolds, seconded by Mr. Cecchinelli, the assembly voted to elect Ashley Young to serve as Treasurer and Craig Farnham to serve as Assistant Treasurer for one-year terms, the motion passed.

On a motion by Mrs. Farrell, seconded by Ms. Reynolds, the assembly voted to adopt Article 5, as presented, the motion passed.

- ***ARTICLE 6*** *To do any other business, proper to come before said meeting*

On a motion by Mrs. Farrell, seconded by Mr. Grant, the assembly voted to adjourn at 6:24 p.m.
