Presented March 8, 2023

Interim budget reports provide a picture of a district’s financial condition during the fiscal year. The Governing Board of a school district certifies the district’s financial condition to the county office of education through these reports. The Second Interim Report is from July 1<sup>st</sup> through January 31<sup>st</sup>. Illustrated below is a summary of the financial condition of Natomas Unified School District as of the second reporting period. In addition, the Second Interim Report contains detailed budget, multi-year projections, and estimated cash flow reports.

**Significant Changes since First Interim**

On January 10, 2023, the Governor released the proposed State budget. The proposal includes an 8.13% cost of living adjustment (COLA) to the Local Control Funding Formula (LCFF) for the 2023-24 school year, as well as an 8.13% COLA to special education and several other categorical programs outside the LCFF. The COLA is used to cover mandated employer costs including increasing costs for pensions (PERS and STRS) estimated at \$490K, Step and Column estimated at \$1.35M, increase in required contribution to Routine Restricted Maintenance Account (RRMA), and any negotiated salary increases.

Other funding priorities in the Governor’s Proposed Budget are:

- \$300 million (ongoing) to create an LCFF Equity Multiplier intended to close opportunity gaps
- \$855 million (ongoing) to implement the second year of transitional kindergarten (TK) expansion
- \$175.3 million (ongoing) to support an 8.13% COLA for California State Preschool Program reimbursement rates
- \$250 million (one-time) to expand the number of high-poverty schools participating in the Literacy Coaches and Reading Specialist Grant Program
- \$100 million (one-time) for LEAs to provide high school seniors with cultural enrichment experiences
- \$301.7 million (ongoing) for Child Care and Development Programs and \$1.5 million (ongoing) for the Child and Adult Care Food Program to support an 8.13% COLA

**2022-23 NUSD Budget Components**

- ❖ Average Daily Attendance (ADA) is estimated at 9,979

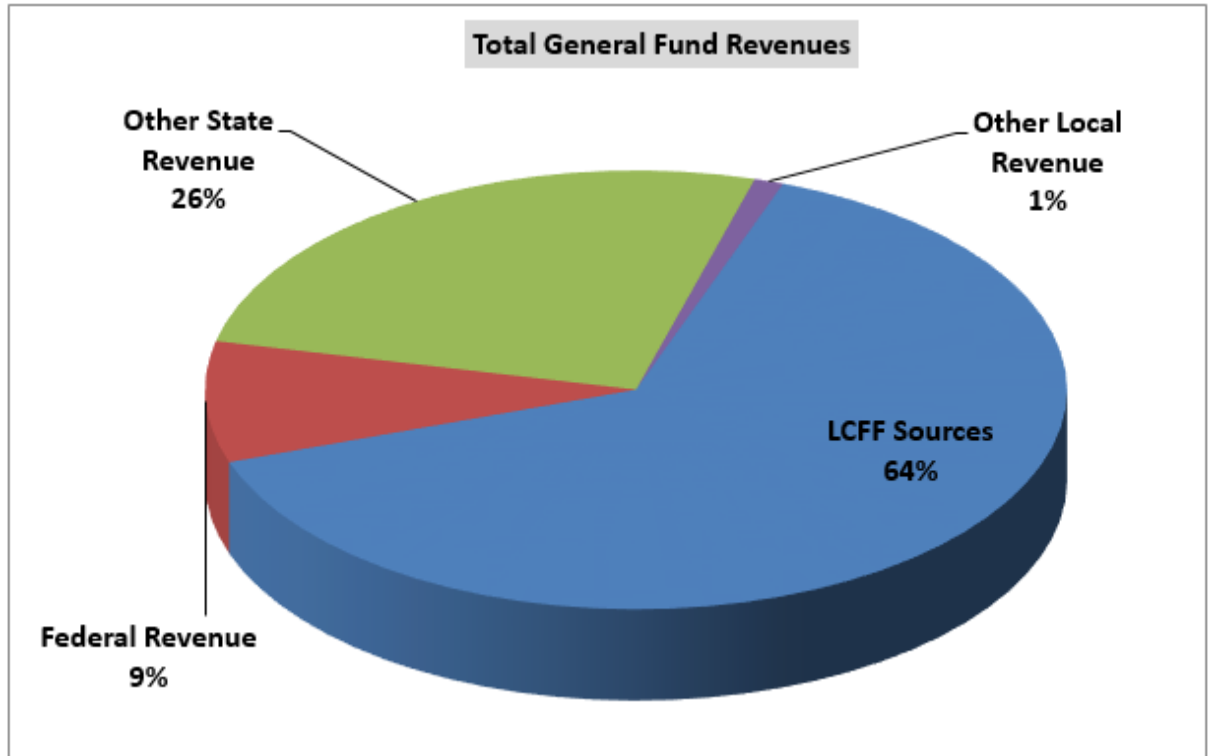
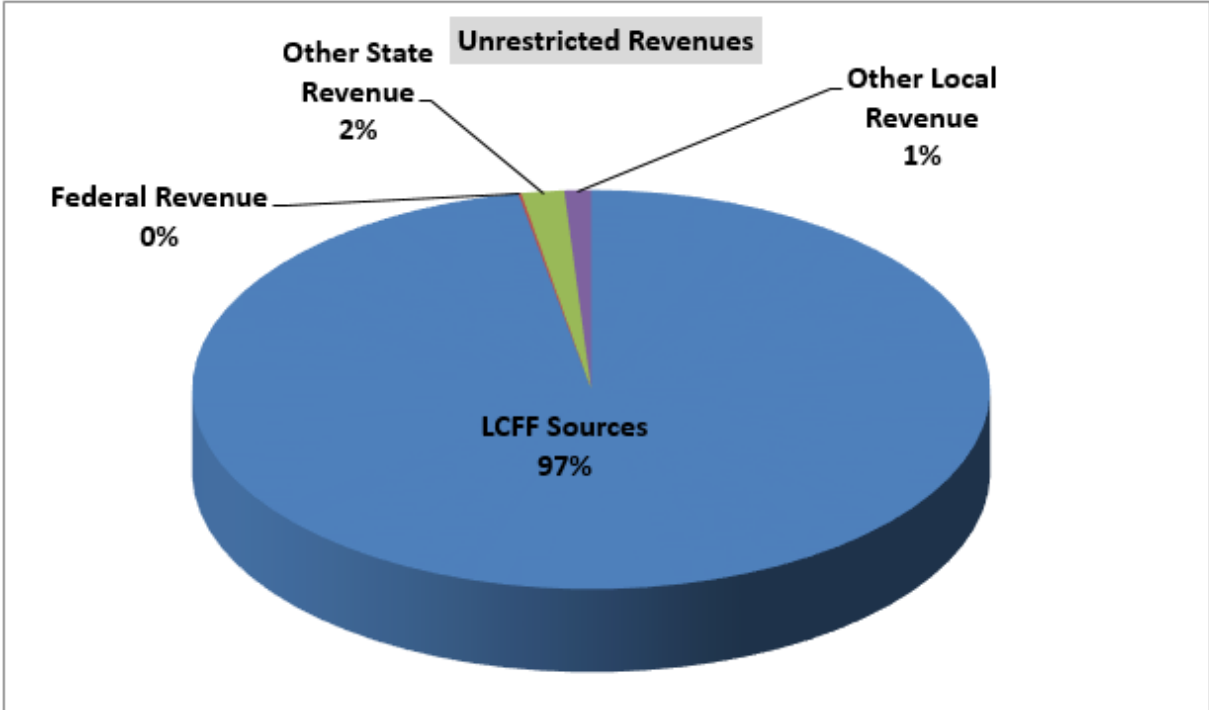
- Estimate being funded on ADA of 9,873, which is almost 94% with the ADA Mitigation Loss Factor, instead of the forecasted Second Interim ADA at 91%
- The District’s CBEDS enrollment is projected at 10,946 with an unduplicated count of 66.65%
- ❖ Lottery revenue is estimated to be \$170 per ADA for unrestricted purposes and \$67 per ADA for restricted purposes
- ❖ Mandated Cost Block Grant is \$34.94 for K-8 ADA, and \$67.31 for 9-12 ADA
- ❖ Illustrated below are the salary & benefit costs (savings) of a 1% salary increase (decrease):
  - Certificated: \$670,000
  - Classified: \$280,000
  - Management & Confidential: \$170,000
- ❖ Except as illustrated under Contributions to Restricted Programs, all federal and state restricted categorical programs are self-funded
- ❖ Summary of budget highlights:
  - Additional one-time expenditures for TK Furniture
  - Additional one-time expenditures for Social Emotional Learning (SEL) and Classroom Management

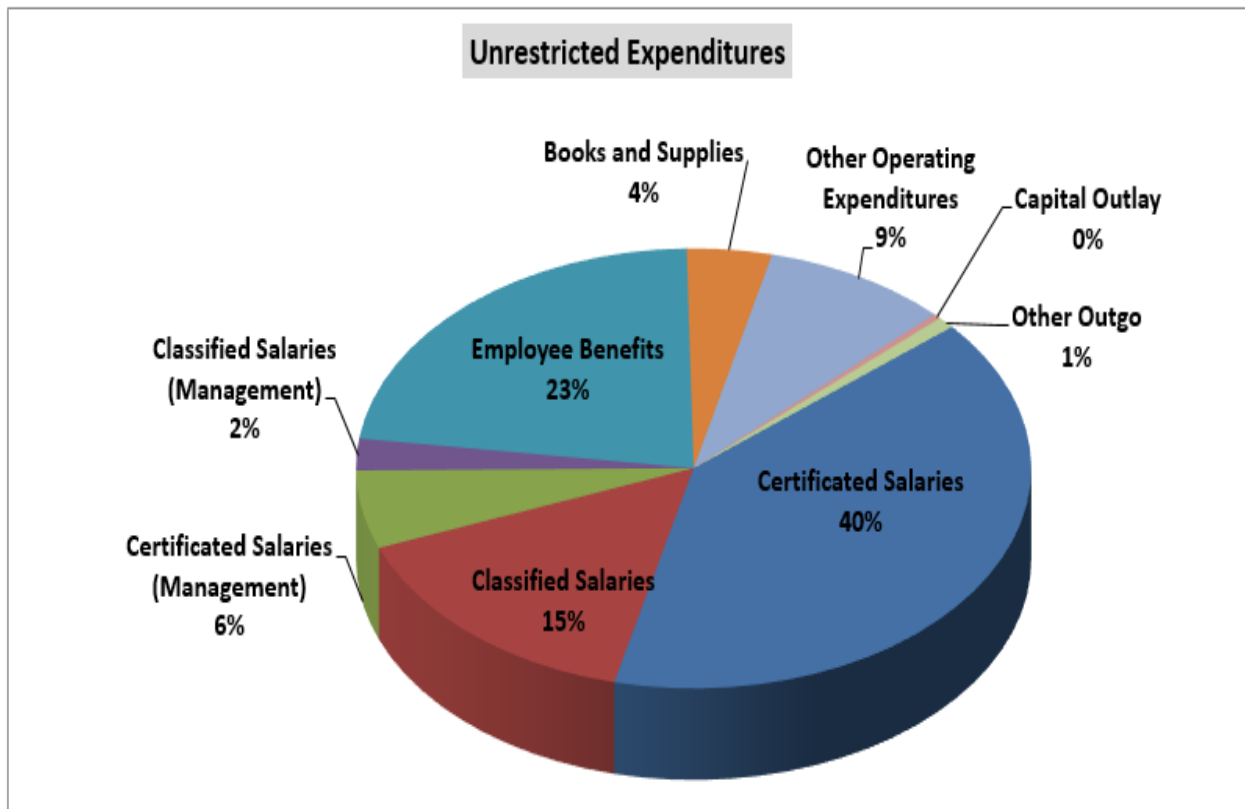


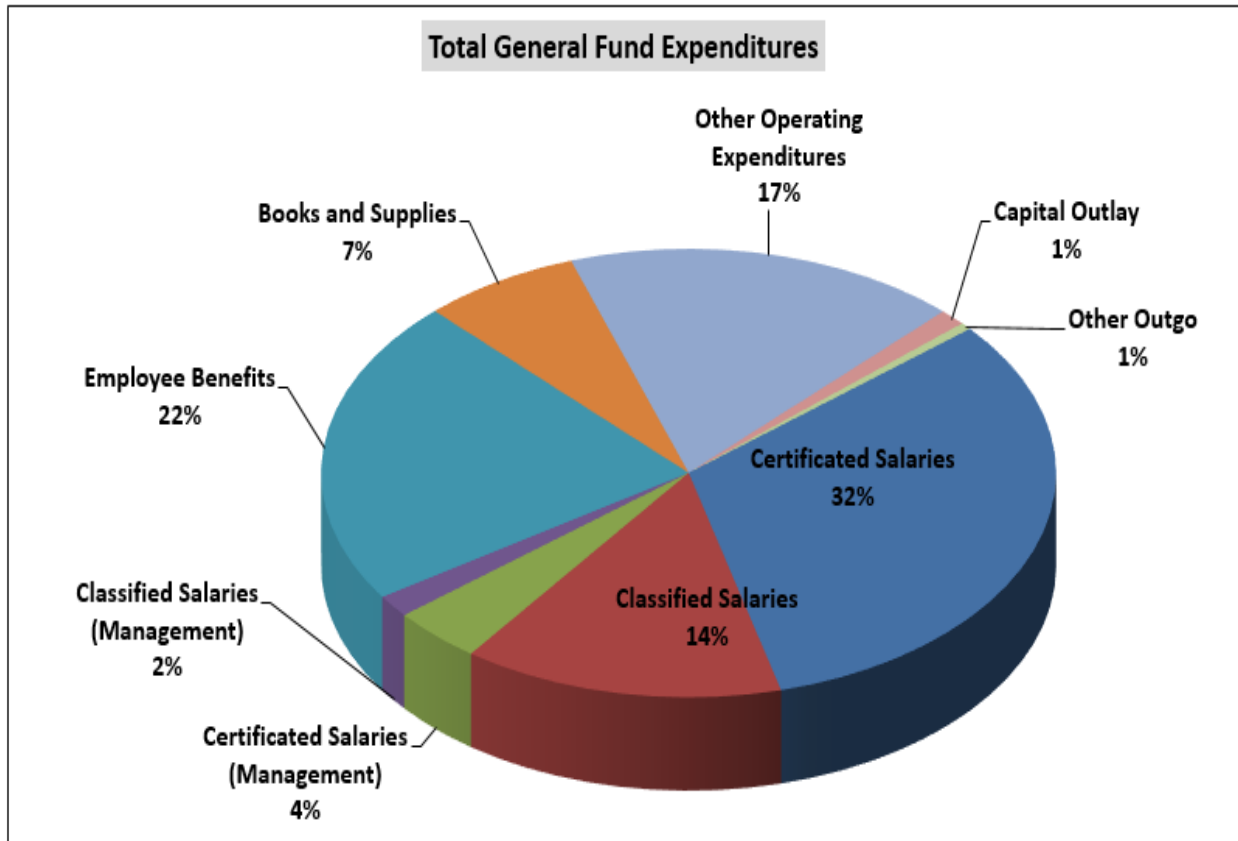
**Operating Expenditure Components**

The General Fund is used for expenditures for many of the functions within the District. As illustrated below, the largest part of expenditures are salaries and related benefits that comprise approximately 86% of the District’s unrestricted budget, and approximately 74% of the total General Fund budget.

**Education Protection Account**

The creation of the EPA by Proposition 30 provides that a portion of K-14 general purpose funds must be utilized for instructional purposes. K-14 local agencies have the sole authority to determine how the funds received from the EPA are spent, but with these provisions:

- *The spending plan must be approved by the governing board during a public meeting*
- *EPA funds cannot be used for the salaries or benefits of administrators or any other administrative costs*
- *Each year, the local agency must publish on its website an accounting of how much money was received from the EPA and how the funds were expended*

As illustrated below, the EPA comprises approximately \$29.4 million for the General Fund and \$8.3 million for the Charter Fund, for an approximate total of \$37.6 million.

**General Fund Summary**

The 2022-23 components of ending fund balance include:

- Revolving cash reserve of \$35,000
- Reserve for Economic Uncertainties – State Mandated 3%, \$5,726,000
- Commitment for Stabilization Arrangements per Board Policy, \$16,443,025
- Other Commitments and Assignments
  - Textbooks Adoption, \$2,143,083
  - Additional School Resource Officers (SRO), \$999,000
  - Diversity Recruitment / Aspiring Leaders, \$347,500
  - NMS Athletic Field Replacement, \$750,000

The NMS Athletic Field Replacement commitment is not replacing the original commitment of Athletic Fields (Turf / Track). The change is due to the matter's urgency. The District is still dedicated to pursue these commitments starting next school year.

Also, we did remove the Board Resolution # 21-19 related to Pandemic Staffing commitment as we now have a clear understanding on how to use the remaining one-time pandemic funding prior to expiration.

**Cash Flow**

The District estimates cash flow based on the State Controller’s estimated payment dates for K-12 principal apportionments, lottery apportionments, and EPA apportionments. The District is projecting to have a positive cash flow through 2021-22 and the two subsequent years. The District continues to monitor cash flow to ensure there is sufficient cash to meet all obligations.

**Multi Year Projection**

***2023-24 Assumptions***

**Revenue**

- Use of 8.13% COLA as provided by School Services of California
- Flat ADA percentage at 91% (No ADA Mitigation Loss Factor)
- Removal of one-time federal and state revenues
- Estimates of all other federal, state, and local revenues to remain relatively constant



## Expenditures

- Removal of 2022-23 one-time expenditures
- Step and column increase of 2.1% for Certificated and 1.9% for Classified
- Addition of classified and certificated staff for Heredia-Arriaga School
- Addition of 4 bridge staffing for Heredia-Arriaga School
- Addition of one-time start-up expenditures for Heredia-Arriaga School
- Addition of one-time furniture for additional classrooms for Heredia-Arriaga School
- Addition of 7 General Education Teachers
- Addition of 3 teachers at Larry G. Meeks
- Included 2% one-time off schedule salary payment for CSEA
- Included 5% ongoing salary raise for all staff
- Addition of 1% off schedule Professional Development
- Pension rate increase of 1.63% for PERS (no change for STRS)

## ***2024-25 Assumptions***

### Revenue

- Use of 3.54% COLA as provided by School Services of California
- ADA percentage increase to 92%
- Removal of one-time federal and state revenues
- Estimates of all other federal, state, and local revenues to remain relatively constant

### Expenditures

- Removal of 2023-24 one-time expenditures
- Step and column increase of 2.1% for Certificated and 1.9% for Classified
- Included 1% ongoing salary raise for CSEA
- Moved 5 Social Workers from Pandemic funds to Ongoing LCFF funds
- Addition of one-time furniture for additional classrooms for Heredia-Arriaga School
- Removal of one-time Pandemic Related Staffing and Operational Costs
- Pension rate increase of 1.10% for PERS (no change for STRS)

### **Conclusion**

The projection supports that the District will be able to meet its financial obligations for the current and two subsequent years and maintain a reserve above the state required 3%. Therefore, the Natomas Unified School District certifies that its financial condition is “positive.”


