The following are courses offered at Williamston High School that qualify as advanced classes that may be used to replace approved MMC classes. Wilson Talent Center CTE credits may also be used.

English/Language Arts

Must be a 5th credit beyond English 12 or AP English Literature/Language and is therefore earned through Dual Enrollment at an institution of higher learning such as Lansing Community College or Michigan State University.

Mathematics

The 5th credit must be beyond Algebra 2; qualifying courses include but are not limited to Precalculus, AP Statistics, AP Calculus, concurrent and dual enrollment math courses.

Science

Qualifying courses include but are not limited to Anatomy & Physiology, AP Biology, AP Chemistry, AP Physics, and dual enrollment science courses.

World Language

The third credit must be beyond the 2nd level of the language (ie. Spanish 3, Spanish 4) or a 2nd language after two years of another language have been completed.

Visual, Performing, & Applied Arts

VPAA classes beyond the 1 credit graduation requirement may be used to replace the 2nd year of World Language. They cannot be used to replace any other classes.

Social Studies

No Social Studies classes can be used for replacing other classes.
