## ANNUAL INCOME SURVEY (SY 2025-2026)

Connecticut subsidizes a portion of preschool tuition for students attending Riverside Magnet School (RMS). For RMS to receive funding from the Connecticut State Department of Education, each preschool family must verify their income on an annual basis. Each family must indicate if their income falls at, below, or above 75% of the state median income (SMI). Preschool tuition will be determined annually.

Per CT General Statutes, families of **enrolled** preschool students whose gross annual household income is **above** 75% of the SMI will be required to pay an annual tuition fee.

Tuition for **2025-26** is \$2,320.00 per preschool student.

**Any** family whose gross annual household income is **at or below** 75% of the SMI will **not** be required to pay tuition for 2025-2026 if the following conditions are met:

- 1) A completed, signed and dated, Annual Income Survey (SY 2025-2026) is submitted;
- 2) A copy of your 2024 income tax return is provided for income verification purposes; and
- 3) An authorized school administrator verifies your 2024 income tax return.

RMS **cannot consider** a tuition waiver for any family that is unable to provide documents supporting income verification or modifications. Pending approval, the family *will* be held responsible for the 2025-2026 tuition set forth above and agrees to follow the applicable tuition guidelines.
