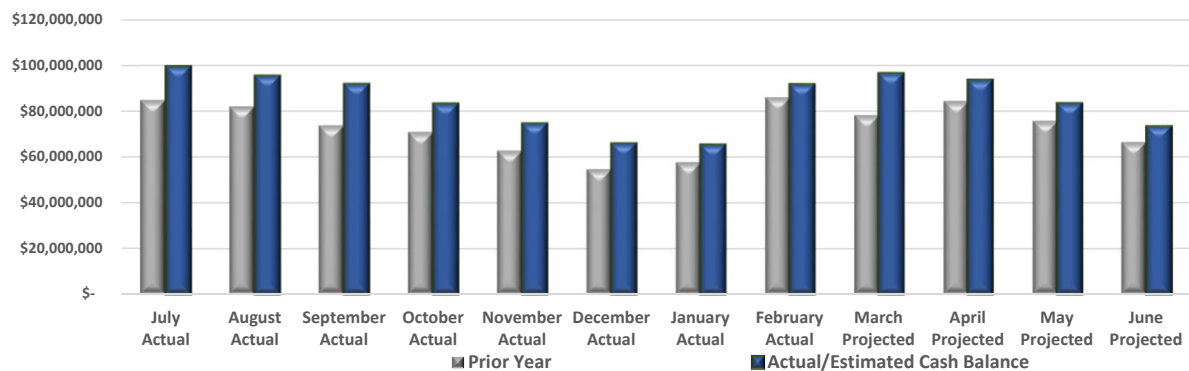

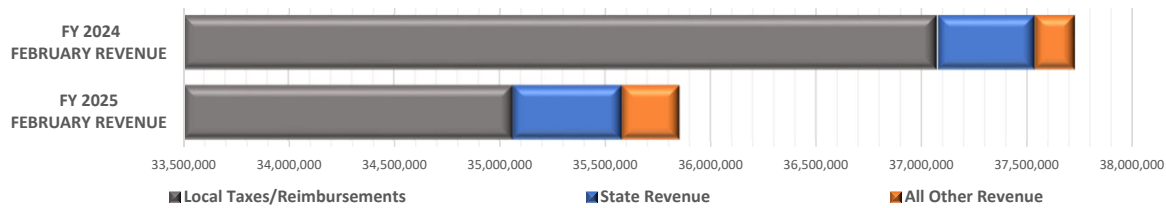

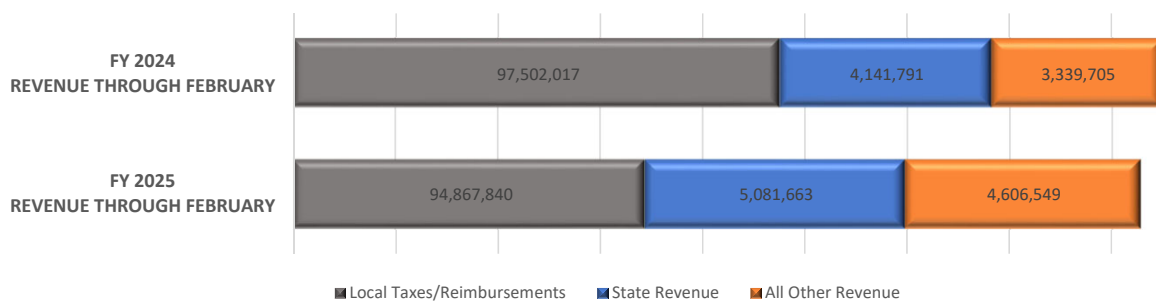

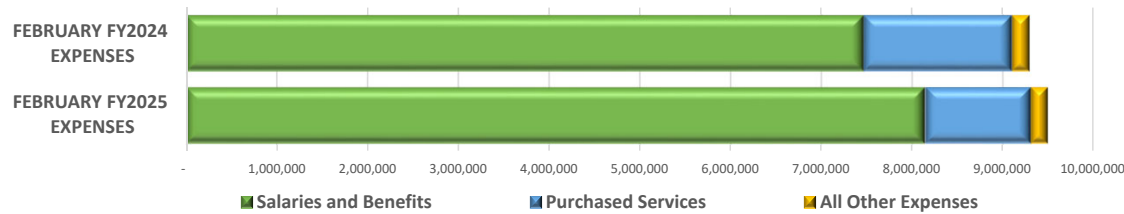

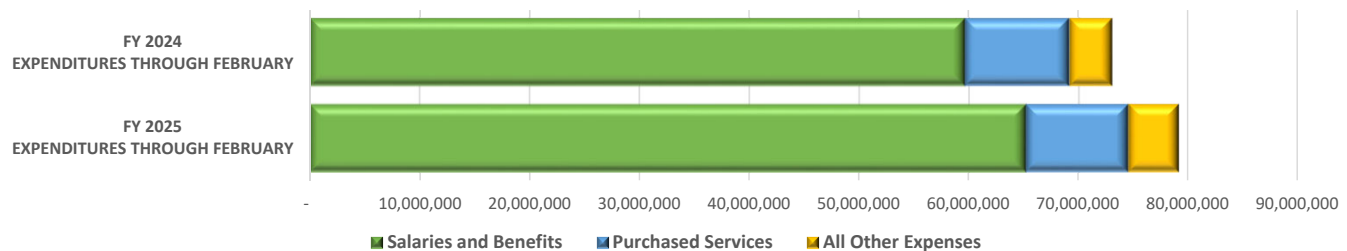

Fiscal year-to-date General Fund expenses totaled \$79,099,972 through February, which is \$6,042,824 or 8.3% higher than the amount expended last year. Through February, the largest categorical variances when compared to last year, are: certified regular salaries higher by \$3,147,352, and retirement higher by \$977,005.
