

GREAT TEAMWORK!

In my December Superintendent's report of 2008, I stated and truly believe that.

"Each individual in an organization must make a choice as to what role he or she will play. The choice is either to actively participate or simply go through the motions from the sidelines. Being a reliable member of an organization means contributing." (Anatomy of a Leader)

I am very proud of our principals, district office staff teachers and staff on the reorganization they have done since the first meeting in August 2008.



It is important for each person to believe that what he or she provides to the group is valuable. The district office is having as much growth as the principals and staff. Realizing that success increases when everyone works toward a common goal will be a powerful incentive for cooperation. Thank you staff, board of education, families and students for such cooperation. I am a lucky superintendent to be a part of such a great group.

STAFFING

It is hard to believe that February is here already and we are looking at next year's certified staffing needs. This year we found a couple of notable statistics about our staff:

- 50% of the certified teaching staff had Alaska experience when we hired them- (34 of 68)
- 100% of the principals had Alaska experience or had lived in Alaska when we hired them.

At present, we are projecting that all of our principals and district office staff will be returning for next school year.

STUDENT COUNT

The official student count for Southwest Region School District came out at 639.85; this is in line with what we built our budget for this year.

The student count at this time is 641. We are holding very well with the number of students staying in our district this year. This may be important in the later years if the state adds another count date.

SUPERINTENDENT'S AASA CONVENTION

This is the first year I have attended an AASA national convention. It started on February 11 and ended February 13th. This was a great opportunity

to see what is going on in the nation with schools and all of the new programs being introduced. The convention was excellent and the focus on learning was very motivational.

ALASKA NATIVE TEACHER INITIATIVE

We have six individuals that are in this program. One of the individuals may do their student teaching next year. We signed a letter of agreement last year in support of this new program designed to increase recruitment, certification and retention of Alaska Native educators. The program is coordinated by the Avante Garde Learning Foundation, led by former Alaska Commissioner of Education Shirley Holloway.

CURRICULUM & INSTRUCTION

David Piazza, Director of Instructional Programs

eRate

The District's Form 471 which is the "official" application for E-Rate funds was submitted before the end of the filing window. Item 21 Attachments that demonstrate proof of service levels such as previous phone bills and the internet and distance delivery contracts have been submitted as well. This allows the Universal Service Administration Company (USAC) the ability to begin the review process of our application. However, if this year follows similar patterns, our application will not be reviewed until late Spring or early Fall. Additional Program Integrity Assurance (PIA) reviews are normally conducted and require the district to submit additional paperwork to satisfy these auditor's questions.

Due to the diligence of Walter William, Nutrition Specialist, and Nate Preston, Student Support Services Specialist, the district was able to identify and certify a larger number of students who qualify for Free or Reduced Lunch from previous "Lunch Counts."

Not only does this help the revenue potential for meeting student's lunch program needs, these counts are used to calculate the district's subsidy level for E-Rate eligible services. Since each school has demonstrated at least a 75% free or reduced level, this sets each schools' and the district's subsidy level for at least 90% for the next 5 years. This means that most of the local and long distance telephone calls, the internet service, and distance learning service costs the district 10 cents for each dollar of service purchased. The federal E-Rate funds are used to pay the remaining 90%. The district has requested \$967,582 in E-Rate eligible services. This will be the 13th year of the E-Rate program.

Curriculum (Deb Endicott)



Science GLEs

In February, the Curriculum Specialist worked with a team of Science Teachers from across the State to complete the Alaskan Science Grade Level Expectations for grades 3-11.

Those new GLE's are now posted on the AKEED website for teachers, school districts to align their curriculum to the GLE's.

HSGQE-related Needs

Last semester, principals identified an immediate need to help those students who were not successful in passing the exit exam requirement to earn a diploma. Upon further investigation of student data, principals identified freshman whose SBA test results and other data would suggest they would struggle with that same requirement. We are continuing to support teachers piloting new courses for the HSGQE Math and Language Arts Classes. Printed texts and resources from AGS Publishing provide lessons that are grade level equivalent using

lower reading skills. Expressive Writing from SRA (vendor for Open Court reading and Reading Mastery) is also being piloted at high school classes to reinforce writing skills. After these courses are piloted and the data is evaluated, the courses could become part of the curriculum across the district.

Math in a Cultural Context

Math in Cultural Content will host two more Saturday workshops in February. Egg Island is a 2nd grade module that teaches math concepts of grouping and place value. The 6th and 7th grade module on Salmon fishing are investigations into Probability. Teachers, Classified Aides are welcome to register for the one-day workshop held at Dillingham Elementary School. The grant from UAF will pay for the round trip flights and pay for meals and housing. Hotel accommodations can be made but to keep expenses down, we recommend to arrive in Dillingham prepared with sleeping bag and mattress to stay in the school library over night. Participants can earn college credit through the workshop. This time of year, everyone needs to make preparations and accommodations to being weathered in Dillingham. Any extra housing or meal expenses due to weather or air taxi flights eliminating traveling back to the villages will be honored.

Staff Recognition Programs

Teacher and Staff Recognition programs have been distributed to site administrators. Teacher of the Year is a program where administrators recommend candidates to complete a portfolio and submit it to district office leadership team. This team will select one teacher who will represent Southwest Region Schools as the candidate to the State of Alaska Teacher of the Year Program. Instructional Aide of the Year is one individual who represents the district for the upcoming year as the exemplary individual support student education. They are recommended by the site administrator and complete a portfolio that shows their highly qualified status, reference letters and an essay. The third award is for Classified Employee of the Year. This individual is rec-

ommended by the administrator in the form of a letter stating their unique qualifications and the service they provide the students of each community. All of those recommendations and portfolios come into the district office April 15th or 25th and selection of the winners is April 30th.

IPT Testing

District wide proctor training including both certified and classified staff for Idea Proficiency Test training has been completed. Idea Proficiency Testing is currently underway at all

sites. Site managers across our district are working diligently to complete the assessment well in advance of the mandated deadline. The Idea Proficiency Test is an assessment of English language acquisition required by EED for identified Limited English Proficient students that focuses on listening, speaking, reading and writing.

Terra Nova

District wide Terra Nova testing was completed the week of February 7th. The Terra Nova test is part of the Alaska Comprehensive System of Student Assessment and is given to grades 5 and 7 only. Mandated content areas tested are; Reading, Part 1&2, Language, and Mathematics, Part 1&2. Terra Nova testing satisfies a federal mandate requiring the Alaska Department of Education and Early Development to administer a national normative referenced assessment in two grade levels in conjunction to our state Standards Based Assessment (SBA).

Media Center (Shannon Clouse)

The registration process has begun with Shannon traveling to Koliganek and soliciting applications. Margie Nelson has done a great deal of the legwork and together they have regis-

tered 11 children for the program. Both Margie and Shannon are scheduled to go to Anchorage for training from Best Beginnings, Alaska to better understand and coordinate the Imagination Library in Koliganek.

Reading Is Fundamental

The district was allocated more money from Reading Is Fundamental for the 2010 contract year, allowing us a larger budget to buy high quality books for our students. Currently our RIF coordinators at site are working on selecting the books that will be used for the three distributions to be held during 2010. Togiak and Twin Hills have submitted their orders and we are waiting for them to be processed.

Battle of the Books

During the month of January we held the district championship for Battle of the Books for 3/4 grade, 5/6 grade, 7/8 grade and the High School. We had 14 teams participate in districts this year, with almost every school in our district being represented at one grade level or another.

The 3/4 grade teams that battled this year consisted of Clarks Point School, Togiak School and Manokotak School. The Clarks Point team will go on to

represent Southwest Region at the state battle on February 18th. The last time that the Clarks Point team won the district battle was in 1987, it took 23 years for them to repeat their win.

The 5/6 grade teams were Clarks Point School, Aleknagik School, Twin Hills School, Togiak School and Manokotak School. The Aleknagik team will represent Southwest Region at the State battle on February 17th.

The 7/8 grade district battle never fails to be the most exciting battle of the year, and this year was no exception. We had five teams competing from Clarks Point, Aleknagik, Twin Hills, Togiak and Koliganek. At the end of the 16 question battle we tallied up the scores and realized we had a three way team tie between Clarks Point, Twin Hills and Aleknagik! So the battle went into "Sudden Death". meaning that the time for teams to answer questions was cut in half from 30 to 15 seconds, and each team had to answer the question correctly to proceed. After five questions one team remained: Aleknagik School. The last three guestions was a battle between Aleknagik and the one-woman team, Alyssa Bushey, of Clarks Point School. What an awesome effort on all of their parts, it was Battle of the Books at its best! The Aleknagik team will represent SWRS at the State level on February 16th. The High School had two teams participate in the district battle this year: Togiak School and Koliganek School. For the first time in many years Togiak will not be representing SWRS at the state battle. Koliganek High School will represent SWRS at the State Battle.









FEDERAL & STATE PROGRAMS

American Reinvestment & Recovery Act (ARRA) No Child Left Behind (NCLB)

The district is making progress in the curriculum audit process in Language Arts and Math. A curriculum committee camp is shaping up in May (after the end of the school year) to provide a block of time to intensely review, update, and format the curriculum. The ParaPro Assessment Preparation Program is being funded through the State Fiscal and Stabilization Funds (SFSF) with the intent to assist all non-highly qualified instructional paraprofessionals to meet the requirements of NCLB (see section below).

Highly Qualified Plan for Title I Paraprofessionals

No Child Left Behind (NCLB)

The Highly Qualified Plan for Qualified Title I Paraprofessionals was completed and submitted to the state. This report contains data about the number of currently employed instructional paraprofessionals that do not meet the highly qualified requirements of No Child Left Behind (NCLB). The plan outlines what method each paraprofessional has completed or will complete to meet the highly qualified requirements of NCLB. In addition, assurances state that all instructional paraprofessionals will meet the requirements under federal and state regulation, develop a joint plan with each paraprofessional to meet the requirements, and that instructional paraprofessionals that are not currently highly qualified will be reassigned to non-instructional duties. It is important to realize the non-highly qualified personnel cannot be hired for instructional duties after this year.

The district has implemented a ParaPro Assessment preparation program for all non-highly qualified instructional paraprofessionals currently employed. This program is being implemented at every school and is designed to better prepare non-highly qualified instructional paraprofessionals to pass the ParaPro Assessment. By passing the ParaPro Assessment and completing a standards checklist, instructional paraprofessionals will meet the requirements of NCLB. The district is working with the testing company and the state to secure additional testing dates, become an internet based testing site, and gather further guidance on the definition of "instructional paraprofessional.

Indian Education: U.S. Dept. of Education

Part I of the Title VII Indian Education application has been completed, certified, and submitted. During the 31-day count period occurring between December 14th, 2009 and January 13th, 2010 a total of 624 students were identified as Alaska Native with a total student count at 636 students. Certificates of eligibility were verified for each of the 624 Alaska Native students. The Yup'ik Studies curriculum committee continues to make very good progress in developing curriculum. Outcomes and formatting for the curriculum document were solidified at the last meeting on February 2nd with the intentions to begin filling in a matrix with activities for each outcome during the next meeting.



EDUCATIONAL TECHNOLOGY

Curriculum

Work continues on the Yup'ik Studies curriculum and a set of draft outcomes is nearly ready for review. Meetings are planned for Language Arts and Mathematics the first week of March and a weeklong curriculum workshop is planned for May.

Computer Aided Instruction Specialist (Corey Evans)



A number of projects have been completed successfully over the past month. The AIMSWeb winter benchmark was completed successfully, the computer audit was completed finally updating our inventory database and

work was completed on several other site specific software issues.

Technology Specialist (Les Parks)



New UPS battery backups were researched, and ordered for the Togiak School data closets following an equipment failure. A rebuild of the LDAP server in Aleknagik was also completed including complete recov-

ery of all students and staff data. Togiak staff were assisted a range of other items as well including scanner issues. New Stuyahok staff was assisted with gaining access to and functionallity on the Rose Urban Exchange website to allow participation in this exciting program. Assistance was also given to sites requesting help with barring student access to inappropriate content.

Spotlight: Migrant Education

Title I-C, commonly referred to as Migrant Education is a title grant that is part of the consolidated No Child Left Behind application. Migrant Education funds are used to support programs that benefit migratory children, which can include activities such as professional development programs for teachers, family activities, integration of technology, and employment for personnel providing instructional support. The law allows school-wide schools to combine migrant education funds with other title funds to enhance programs that serve all children in the school, which is the option that Southwest Region School District chooses for each year.

There are a number of regulations involved in determining who qualifies as a migrant education student including qualifying activities, qualifying moves, the recruiting process, and priority first students (PFS). In relevance to our students, an activity is defined as berry-picking, commercial fishing, and/or subsistence fishing (or a combination of those activities) but not hunting.

Because our district is over 15,000 square miles, a qualifying move is defined as traveling 20 or miles from the home to the activity (not round trip) or crossing the boarder of the district; and consisting of eight day and seven nights away from the home (does not have to be consecutive); and the child has to move with the worker unless the child is 14 years or older, in which they can move on their own.

The recruiting process requires a certificate of eligibility to be filled out for each family that has a student that has made a qualifying move. Once a student has been identified, that student is considered a migrant student for three years. The age range for migrant students is from birth and until they earn a high school diploma or turn 22 years old.

Priority for service students are students that are performing below grade level on the Standards Based Assessment or High School Grade Qualifying Exam and have made a qualifying move during the school year. Priority of service students must be ensured of receiving academic support before other students. The identification of migrant education students occurs during the months of August through mid-November. This year's results show that there are 151 total migrant students, which is down by five students from last year. For additional information contact Jon Clouse at jclouse@swrsd.org



Business Office

We were successful in getting a better fuel bid than the combined effort with AVEC. In January we received the AVEC fuel bid from Delta Western for price differential of 2.5795 added to the index price at time of lift. The estimated cost at the time of the bid was \$4.5078 and it was dependent on the lift cost. We chose to go out for a fixed price bid and Delta Western came back with one with varying costs at the sites ranging from \$3.57 to 3.82. These prices are fixed so we can build our budget with real numbers. This saves us \$166,767 at the time of purchase. However due to the multi year supply at some sites it will save us around \$60,000 in FY11. This will be applied to payroll dollars that were needed after meeting with the principals on February 3rd.

The FY11 budget went out to the sites with the principals on the third. They were given to March 12 to review them and present to their CSC's.

In April 2009 we received \$166,456 of ARRA Impact Aid money which was to be applied as part of our participating share for the new housing units in Togiak and Manokotak. The final report utilizing that money was submitted on January 13.

Negotiations with the certified staff will begin this month. Proposals from NEA and the district will be exchanged by February 19. The first meeting will be February 26th and 27th.

February is a busy month for travel with staff going to ASTE the technology conference and ASSEC the special education conference.



SPECIAL EDUCATION

Lee Webster, Director of Special Education

One significant change in Special Education this month was the finalizing and agreement to a smooth referral process between the various agencies involved with Child Find in Bristol Bay. This is the process of locating and evaluating children with special needs and this agreement should allow all of us involved to have smoother transitions.

All the teaching staff resumed their duties by the 2nd week of January with new transfer students arriving in Togiak. The transferring district helped us by sending IEP information so that the staff could prepare for the new arrivals. Many kudos go out to

Dave Morris and his staff. Mark Snell and his instructional assistants are doing a commendable job adjusting to difficult changes.

On January 14&15, I had the privilege of attending the annual Alaska Winter Conference where national experts conveyed what is happening with Response to Instruction (RtI) nationwide.

Referrals and exits have impacted the number of children identified with disabilities in SWR. Since we are in the evaluation process with a number of children I can best approximate that about 80 children are identified as of this date.



Facilities & Maintenance

Manokotak

The housing transfer has been completed with the city of Manokotak

This was the two duplex units and A frame house that where on leased property from the city

The two District owned houses have been put up for sale using a bid process, there where no Qualifying Bids received, we are going to lower the minimum price and put the houses up for sale to any interested parties and will consider all offers above the minimum price.

We are working towards the final paper work to get D.E.C. approval for the water and sewer systems on the new teacher units as well as the platting and long-term loans to close out the grant.

New Stuyahok

The attorneys have drawn up Quitclaim paper work for the city to review on the transfer of the old school property. The city has accepted and the Deed has been recorded. The attorneys also have provided a Indemnity agreement on the soils cleanup effort. This agreement will protect the city's interest in the property until the soils can be totally cleaned up to D.E.C. standards. We have applied for a D.E.C. Brown-field grant and have been approved for a site assessment in the spring. The city has decided they do not want to keep the two duplex units on the property, we will be putting them out to bid to demo and remove from the site.

We have provided a Deed of Easement to the City of New Stuyahok for ANTHC to construct there new Water Storage Tank up near the new school.

Togiak

We are completing paper work to get D.E.C. approval on the water and sewer systems along with platting and long-term loans to be able to close out the grant for the new Teachers housing

We hope to have the final plat of the old school site done this month (we have been waiting on DNR for 16 months) this will allow us to complete the transfer of buildings and property to the City of Togiak

District wide we are working on boilers and air handlers trying to stay ahead of freeze ups, and catching up on preventative maintenance.

Bulk Fuel Upgrades (KGK/TWA/KEK)

We are still working with the Alaska Energy Authority on Bulk Fuel Upgrade Grants

Ekwok project has been moved back to possible 2011 construction

Twin Hills could start construction this spring 2010

Koliganek could move to the final design stage and possible construction 2011.
