 2. One biological parent lives in Bowie or Cass County in Texas.
 3. The student's parent or legal guardian currently owns a business or property in TISD and pays school property taxes to the District. School district taxes (verified by current tax statement) will be deducted from tuition owed.

Guidelines for Intra-district Transfer Requests

2025-2026

TISD transfer policy requires that students apply for a transfer every year. An Intradistrict Transfer Request form is available to request a transfer. **Please return the form, online, in person or by mail, to the TISD Welcome Center at 2208 Kennedy Lane, Texarkana, TX 75503.**

Important Dates

Transfer applications for 2025-2026 will be accepted beginning April 1, 2025. To retain priority placement status, students enrolled in 2024-2025 must reapply for transfer by April 30, 2025.

The deadline for intradistrict transfer requests from enrolled students is September 19th. After September 19th, intradistrict transfers will only be granted under extenuating circumstances as approved by the Superintendent or designee.

All transfer students are subject to campus reassignment for the first two weeks of school if class sizes exceed allowable limits.

Campus Assignment Policy

Campus Assignments to a school outside of the student's attendance zone will be granted on the following basis in order of priority:

1. Students who attended the school during the prior school year and reapplied for transfer by the designated deadline. (If necessary, tenure or length of time at the school will be considered.
2. Sibling(s) of a current student enrolled at the requested campus.
3. Student whose parent is a current full time employee of TISD.
4. Students enrolling within their attendance zone.
5. Date and time transfer requests were received by TISD Welcome Center.
6. Application and acceptance to the Martha & Josh Morriss Mathematics and Engineering Elementary School will be governed by regulation in place for that school.

The Superintendent may designate specific campuses or grade levels that will be closed to new transfer applications due to projected space availability.

Students must maintain good attendance, behavior, and work habits to be eligible for transfer each year.

Transportation Policy

TISD does not provide transportation for intradistrict transfer students.

Students Requiring Special Needs or Additional Programs

If a child has special program needs, the campus ARD or SIT Committee will review transfer requests and availability of services. A change in programs/services needed during the school year will require the transfer to be reevaluated to determine the availability of the needed programs/services.
