



- Expand opportunities for authentic learning experiences for students.






## **ELA Academic Performance**

**Overall Placement** 




Beginning of the Year Snapshot




Beginning of the Year Snapshot

#### Relative Areas Identified for Improvement

- 55% of students are upstanders for bullying
- 83% of students feel safe at school
- 69% of students report they have never experienced cyberbullying

# **Enhancing School Connectedness**

#### **School Connectedness:**

- Continue to incorporate student voice & service through student-led groups
- Continue to implement Community
  Circles/Restorative Practices to enhance student
  problem-solving and empathy
- Participate in school wide events







# **Enhancing PBIS & SEL Tier I Instruction**

#### **Enhancing PBIS:**

- Enhancement focus of monthly SEL topics during recess and assemblies
- Ongoing integration of digital citizenship in tech and library lessons
- Continued monthly recognition of students

#### **Strengthening SEL Tier I Instruction:**

- Weekly SEL classroom lessons to enhance connectedness at Tier 1
- Monthly additional focused activities to highlight a topic and build classroom cohesiveness
- Refinement of roles and responsibilities of Counselor and Student Support Specialist to respond to changing needs of students







# Goal 3: Safe, Equitable, & Inclusive Schools

### Top of the World's Plan:

- Enhance MTSS to Strengthen Tier II and Tier III Behavioral Supports for Students
- Continue to reduce Chronic Absenteeism
- Continue to increase Parent/Family Engagement



# **Enhancing Behavioral Supports through MTSS**

### **Tier II and Tier III Supports**

- Inclusion of behavior and SEL data analysis through MTSS cycles with assignment of Tier II and Tier III support with School Counselor, Student Support Specialist and other key personnel
- For example, Student Support Specialist's role:
  - Weekly, individual counseling 18 students
  - Weekly, group counseling 37 students
  - Additional support through classroom observations, Check In/ Check out, participation in MTSS and SST/504 meetings





# **Improving Chronic Absenteeism**

#### **Identified Need:**

TOW focused on <u>reducing chronic absenteeism</u> through ongoing outreach and collaboration with students and families.

#### **Key Moves:**

- Multiple modes of communication
- Created Collaborative Meetings (SART) and Attendance Contracts
- Installed system of Context Driven Data Review
- Disaggregated by grade level





# **Parent Engagement**

- Host Parent Education Events events in partnership with Family Resource Center and PTA
- Offer meaningful Family Events to welcome parents/guardians and community members on campus
- Schedule accessible tours to showcase Top of the World campus and programs to New Families
