GENERAL INFORMATION

The bidder shall provide a proposal for the materials as stated in the Specifications and Descriptions.

Oxford City Schools (OCS) is issuing this bid in order to purchase a variety of HVAC equipment, parts and supplies. OCS is seeking one or more suppliers of HVAC products to provide direct shipments to the designated locations as stated in the descriptions.

Requirements:

- Bid pricing is to be established as a ceiling price. At no time may the bid products be
 offered pursuant to this contract at prices above this ceiling price without approval by
 OCS. Prices may be reduced to meet the specific needs of OCS.
- 2. All products sold by the vendor must be new.
- 3. The vendor agrees that full refund, credit or exchange will be granted to any defectiveon arrival merchandise, if reported within thirty (30) days of receipt of the order.
- 4. When applicable, shipping charges must be clearly identified in the bid.
- 5. Sales and other taxes, where applicable, shall not be included in the prices quoted.

Specifications and Descriptions:

- 1. Oxford Middle School HVAC Equipment:
 - a. Gymnasium: the unit to be replaced is a 1997 Trane Model WCD240B400EA, 460 volt, 3-phase, medium strip heat. Depending on the type replacement equipment, an adapter curb may be required and should be included in the bid. Contact OCS if more information is needed.
 - b. 10 ton split heat pump, 460 volt, single circuit, medium strip heat.
 - c. 15 ton split heat pump, 460 volt, dual circuit, medium strip heat
- 2. Coldwater Elementary HVAC Equipment:
 - a. 3 ton Bard Wall Hung heat pump, 208 volts, 3-phase

Bid Submission:

- 1. All bidders must use the attached Oxford City Schools (OCS) proposal form for submitting their bid.
- 2. Bids must be submitted in triplicate.
- 3. All bids must be sealed and marked in the lower left hand corner "BID #25-0002, April 4, 2025."
- 4. Late bids will not be opened.

Quality, conformity with specifications, purpose for which required, terms of delivery, and past service and experience are among the factors that may be considered in determining the responsive bidder. Upon the awarding of this contract and bid, OCS has the sole right to end said contract at any time at our sole discretion.
