## 4. PRESENTATION

Jeff Budrow: Septic System

Webutuck Wastewater Disposal System -Mr. Budrow reviewed the history of his involvement with the Wastewater Disposal System and his fieldwork study. Mr. Budrow referenced a letter he had written during the capital project time frame which stated the area would be a difficult site to add a wastewater system to and offered several options in the letter. He spoke about the fill that had been added to the wastewater site and displayed a picture of the beds noting which ones were currently failing. He commented that in his opinion the fill seemed to be the problem due to the water not being able to drain properly. An audience member suggested looking at alternatives such as secondary treatment, stating it is a cost effective option. He discussed with the Board the next steps in addressing the problem commenting that the focus moving forward should be to decide the best alternative that would be the most cost-effective for taxpayers. Discussion ensued.

Nate Anctil: New York Power Authority Project (NYPA)

Mr. Anctil partners with NYSERTA and NYSED to help improve energy efficiency in schools. He discussed the energy efficient project and what would be done in each building. NYPA will monitor the bills for three years to ensure Webutuck is getting the savings that were projected by NYPA. It is a self funding project. The original numbers show it will generate \$20,000 for the District for the next fifteen plus years. The project will be submitted to SED after the Board of Education approves the resolution tonight. Discussion ensued.

### 7. SUPERINTENDENT'S REPORT

A. 2013-2014 Proposed Budget Presentation

Mr. Gratto began his presentation by expelling some rumors that had been floating around during the week that were false. Mr. Gratto reviewed his proposed budget for 2013-2014 with reductions and additions along with other considerations. Mr. Gratto noted that he was notified that Webutuck will potentially receive an increase of approximately \$232,000 in State Aid next year. He asked for input from everyone within the next week on where the additional money would be most effectively used.

### **B.** Bus Proposition Discussion

Mr. Gratto stated the Board needs to decide the number of buses it would like to put up for a proposition on May 21, 2013. Discussion ensued.

### C. NECC Summer Meals Program

Mr. Gratto reported that NECC has given the dates for the summer meals program. It will be the same program that was run last year.

### 5. PUBLIC COMMENT

The following topics were commented on by the public:

- -taking social worker out of school in today's society is wrong; global world needs German
- -when German classes went abroad fantastic; scheduling has been a problem to be able to take certain courses
- -can't do Guidance Counselor work; concerned about replacing a mental health worker for an educational worker.
- -as parent, guidance counselors have helped immensely this year, IEP mandates social worker- concerned his needs will be ignored.
- -works closely with social worker, needs of students gr. 4-6 very different from gr. 9-12, students coming in have more that they deal with at home than they ever had, need counseling piece.
- -small school, hard times, kids need music and art all the time, teachers give and give beyond the call of duty, primary care physician mental health in our area stretched thin. -stated there were increased offerings but questions how we are cutting art and music and maintaining the program.
- -expensive process to bus students to where she works at Deveraux, need social workers before they even to get to her school, save the arts program
- -need social worker gr. 4-8, trained in clinical and mental health.
- -Board is cutting important parts of education; need to provide German, French very important in Europe, worried about taking away social workers.
- -took German five years couldn't take it this year because of the combination class.
- -at EBIS would like to keep social worker and not fill principal position, don't reduce art or music.
- -poster in classrooms they say goal to be highest performing school in Dutchess county but mower won't help with that, German will help; goal should be to educate our students, German, art and music are very important.
- -music teacher has been their mentor and made the program strong, spoke passionately about the music teacher and program.
- -born in Shreveport, LA the moved to NY to get a better education, art and music are very important to an education.
- -art and music had alot of fundraisers to bring culture to its students- we live in a small community. I want my siblings to have the same experience I have had
- -without Mr. Stowe I would not have a voice, I know due to Mr. Stowe I want to be a music teacher.
- -since I was little I was taught not only learning was important but creativity and expressing oneself and without art and music you are eradicating creativity.
- -he is currently in English and home and consumer sciences a lot of talk about intelligence testing talks about core subjects but other studies focus on creativity. He doesn't know what to do now that the play is over he enjoys it so much.
- -the increase ESL she supports, social worker position social workers see twice as many students than are mandated.
- -most senior faculty member, the impact on art has not come out this evening the structure will be completely different, gr. 4, 5, 6 students will have art or music quarterly, project adventure focuses on all areas of education they write curriculum every six days.

- -support social workers not being cut, older kids get more stressed as more is put on them like common core, the arts is only outlet for students and escape of common core. Her son was inspired by taking German.
- -when she was little loved to draw, inspired by Ms. Molloy and Mr. Fitzgerald, need more creativity.
- -inspired by the students here tonight, we all have passions in different areas, sad to have to cut.
- -need social worker in HS and EBIS, guidance counselor cannot cover an entire school.
- -cutting art and chorus has been shown to lower test scores. My children love their music and they need it they are planning on going into music. Music and art are a big part of life.
- -listen to your medical staff and nurses, it's is a lot of psych: mental health is hugely needed.
- -questioned cost of football.
- -would rather see football money go towards the kids art and chorus
- -schedule has been mentioned as to it being the reason kids can't take certain courses so how can you cut back on a guidance counselor?
- regarding monetary issues that we face, fortunate that state has increased state aid for next year spent a lot of money on superintendents and superintendent consultants, there is money in reserves, saved money on health insurance each of the last two years, cutting programs is the wrong way to go, should be focusing on how to allocate the money better.
- -enrollment numbers are inaccurate my kids wanted to take music but couldn't.
- -if we do have cuts to programs this year as a parent ask to see your child's schedule and courses offered before September, if cuts are going to be made would like to see electives being proposed.
- -you made decisions to cut certain things due to low enrollment but now it's being shown that students would like to take those courses but can't so maybe you don't need to cut. -all county was amazing, consulting fee is large if it's true.
- -we are talking about a new septic system but have two wet spots and we are talking millions of dollars to fix, we are cutting teachers, maintenance.
- -if you cut music in 3<sup>rd</sup> grade no one will want to do it as they get older reading is the same way, if you don't read when you are young you won't do it when you are older, can't cut art and music, you don't know us and walk among us we need a social worker.
- -I want my sister to be able to have someone to talk to if there is a problem, where did the 300,000 go is that why I have so many study halls.
- $-3^{rd}$  grade chorus and instrumental might not see advantage in  $3^{rd}$  grade but notice it by  $5^{th}$  grade, we have had  $5^{th}$  and  $6^{th}$  students in pit, collateral damage is space usage pre-k was moved into elementary and space is limited huge impact on music and art, consider side effects of any budget reductions.
- -perception of Webutuck has changed since Mr. Sauer has been here, he's to be commended.
- -a lot of these kids are not wired to do band and chorus but I have a class with two students those students have IEPs, they could not function in orchestra and drama etc., whoever picks up the cut position will have to pick up courses and will have to cut their lessons back.

- -if you combine German classes, who will suffer?
- -with cut to German how is it going to impact French and Spanish?
- -starting instrumental in 3<sup>rd</sup> grade is reason why we have great success in All County, it is vital to have 3<sup>rd</sup> grade.
- -is a principal going to be hired at EBIS, where is the money coming from for the consultant hired to do evaluation can that money be put to different use, you have been hiring part-time people for full-time positions.

Mrs. Panzer excused herself from the meeting at 10:00 p.m.
