Call to Order

Vice-President Moran called the business meeting of April 7, 2015 to order at 7:34 p.m and lead the Pledge of Allegiance.

Proposed 2015-2016 Budget

Mr. Castellani reviewed the upcoming Board meeting dates with regards to the Budget and Budget vote. He reviewed the 2014-2015 budget numbers, fixed costs and the 2015-2016 Proposed Budget of \$21,787,172. The program requests for 2015-2016 are one Math AIS teacher, one English Language Learner (ELL) Teacher and the Naviance Guidance Program for EBIS and WHS students. He noted that they were supported by the District and reviewed the costs as it related to the budget. The program requests total \$87,000 which brings the Proposed Budget of 2015-2016 to \$21,874,172. He reviewed budget savings and efficiencies that were found after a review of all programs and going through line by line budget items totaling \$542,094. He reviewed the program efficiencies of teachers and staff, explaining each position reduction including 1.8 teaching staff, 4.0 teaching assistants, 2.0 teaching aides, 1.0 bus monitor, 1.0 part-time clerical staff and a retirement breakage. With the savings and efficiencies the adjusted budget is \$21,332,078. He explained the tax levy limit and the tax cap law which is in it's fourth year. The tax levy limit is 1.66% and with the proposed budget we are compliant. Mr. Castellani reviewed the anticipated revenues and in the end there would be a shortfall of \$282,504. He reviewed possibilities to address the shortfall through the balanced approach of budget reductions, additional revenue or increased tax levy. The Board agreed with using additional monies of \$100,000 from the reserves and Other Post Employment Benefits (OPEB) Fund of \$182,504 which would eliminate the shortfall. Mr. Castellani explained the tax freeze credit. In a proposed budget star-eligible homeowners, within the Webutuck Central School District, would receive a rebate check when taxes increase. The 2015-2016 proposed budget is \$21,332,078, with a tax levy of \$12,938,714. Mr. Castellani noted the proposed 2015-2016 budget meets the criteria of allowable tax cap set forth by NYS. Discussion ensued.
