3.01 Academic Intervention Services - Principals

Mr. Sauer thanked the Board for adding an additional AIS teacher. He noted the assessments WES use which are the DRA and Fountas and Panelle scale assessments as well as the "Go Math" assessment. He stated it is more difficult to identify at risk students in the younger grades because there isn't as much data to refer back to. He has begun to identify them as "students of interest". He plans on visiting Little

Professors to identify what they are learning and also to let them know what will be expected coming into Webutuck Elementary.

Mrs. Panzer thanked Mr. Sauer for chairing the athletic meeting last week. Mr. Sauer felt he moved it forward and put things into motion. Communication was the most prevalent issue. He explained to parents the chain of command for concerns and issues. Discussion ensued.

Jennifer Chason reported that AIS is a two tiered structure with ELA and Math at EBIS. They use flexible groups, small group settings and they are push in and pull out. She explained what each area focuses on. The goal at EBIS is to not have the student be life long AIS students. Mrs. Panzer questioned what happens if a non certified teacher teaches AIS. Ms. Chason explained that Ms. Coon is a Teaching Assistant and depends on the teacher for direction and lesson planning. Discussion ensued.

Katy McEnroe - AIS is provided for identified students for English and Math. She explained that the teachers looked at global social studies scores from last year and looked at the regents questions. They identified whether students were getting them wrong due to vocabulary or content. The group came up the a list of vocabulary words and skills that will be shared with all of the staff so they know they can focus on those as well. They will do the same thing for Earth Science this year. Ms. McEnroe pointed out High School has a Teaching Assistant in Earth Science, they have an ISS Teaching Assistant assigned to class rooms when there are not students in ISS, and additionally, they have a teacher aide that supports the classroom if the class size is large or the content is particularly difficult for AIS students. Mrs. Panzer questioned why a parent will call and ask for their child to be remove from AIS. Mrs. Bailey explained why she requested her son to be removed from AIS. Ms. McEnroe added that we base AIS on the test so if a student is a poor test taker a parent would ask for their removal from AIS classes. Discussion ensued.
