Mr. Sauer spoke about the letter that was given to all of the coaches regarding lack of player attendance at the Heroin presentation at the beginning of the school year. Mr. Sauer stated he was disappointed in the poor turn out. He reported that he is enjoying his new position but misses the high school. He has been riding buses. The big issue is students not staying seated and he encouraged them to buckle up. He has asked transportation to have the buses arrive a little later so there is not such a wait. Lastly, he stated he was proud of the 97% high school graduation rate.

Ms. Chason report that the opening of school went well, no one was lost or cried. It was a great transition from third to fourth grade. EBIS had parent information night on September 11 and it went well. Rosanna Hamm gave an NWEA presentation on what to expect.

2.02 Purchasing - Sheila Moran

Sheila Moran stated that we purchase cafeteria items through Dutchess County Cooperative Bid which includes thirteen other schools in the surrounding area. Dutchess County Cooperative is a group of schools which, by combining purchasing power, provides schools with better prices on food and other cafeteria supplies. There are basic items that are necessary to purchase, but Mrs. Moran tries to offer a variety of foods from many the venders she uses. She noted that she has taste testing days where students try different food in small cups. Mr. Perotti had concerns about how much local food products we purchase, particularly dairy products. He stated Hudson Valley Fresh has no growth hormones but we don't know for sure about other non-local resources. Mrs. Moran stated the local farmers did not put a bid in, and local prices are higher. Cost and pricing was discussed. Mr. Perotti commented that there are recent studies that state children need the fat found in whole milk for brain development. Mrs. Moran stated there has to be a balance and that the guidelines do not allow for whole milk with school lunches. Mrs. Moran explained several points about the cafeteria such as students using money versus Nutrikids, food allergies, and number of

lunches served. Discussion ensued.

Mr. Gratto reported that the Policy Committee is working on Policy updates from 2011 and moving forward.

Mr. Gratto noted the Jeanne Rebillard had called him Friday, asking about if the Board had questions on the Silo Ridge Project. Mr. Gratto and President McGhee had attended a recent town meeting on the topic. Mrs. Rebillard and Pedro Torres are attending the Board meeting to answer any questions Board members may have. Mr. Torres spoke about the Fiscal Analysis regarding the project. He spoke about school aid and noted that there is a slight decrease in school aid which he said is virtually impossible to figure out the calculation. President McGhee spoke about the concern that the District looks like a richer district than we are, and the district loses state aid. Mr. Torres

calculated different analysis and one was what would happen to the state aid if the district became richer. With reduction of foundation aid, the District generated a surplus of 4.1 million instead of 5.1 million. This was calculated with construction costs not fair market value therefore the numbers probably will be much higher. Mr. Torres went through other points in the analysis and discussed what will be completed on the project this year. The first phase will have nine holes completed. The assessment will be evaluated through the different phases. Discussion ensued.

Ms. Moran stated that study halls should begin at 3:15 p.m. if that is the way it is supposed to be. Students are wandering the halls. If we need to hire an aide we should. The Board needs to discuss if we need that extra hour. Mr. Zenz stated having teams begin at 3:15 may create problems. Allowing one team to begin before 3:15 helps with field availability. Ms. Moran stated that AIS elementary lost a full-time AIS position. There no longer is a half-time AIS person. How do students with low scores get help? Classroom teachers need to bring that to Mr. Sauer's attention and then he would come to us. Ms. Holderlin is working on a plan as well as the AIS Committee. Mr. Gratto reported on the history of AIS at WES the last couple of years. Ms. Moran questioned the number teachers assigned to AIS. Mr. Gratto stated it is Stephanie Holderlin.
