The petition must be filed with the District Clerk, Jacqueline Dunning, no later than thirty days prior to the election, at the District Clerk's Office between the hours of 7:30 a.m. and 3:30 p.m. **The deadline is 5:00 p.m. on Monday, April 21, 2025.**

To qualify for membership on the school board, an individual:

- Must be able to read & write.
- Must be a qualified voter of the district; that is, a citizen of the United States, at least 18 years of age or older, and not adjudged to be an incompetent.
- Must be and have been a resident (but need not be a taxpayer) of the district for a continuous and uninterrupted period of at least one year immediately before the election.
- May not have been removed from any school district office within the preceding year.
- May not reside with another member of the same school board as a member of the same family
- May not be a current employee of the school board.
- May not simultaneously hold another incompatible public office

## **VOTER REGISTRATION**

Voter Registration will be held Thursday, May 8, 2025 in the School Lobby from 2:00 pm - 6:00 pm.

If a person is registered to vote with Suffolk County Board of Elections, they are automatically entitled to vote in school elections. However, if a person has not voted within the past four years, they must re-register.

A person is entitled to vote if they are:

1. A citizen of the United States.
2. Eighteen years of age.
3. A resident within the district for a period of thirty days prior to the vote.

*New York State Law states that a person may claim only one residence for purposes of voting.*

## **ABSENTEE BALLOT VOTING PROCEDURES**

Registered voters may vote in school elections by absentee ballot for any of the following reasons:

- a. Absence from county on election day
- b. Temporary illness or physical disability
- c. Permanent illness or physical disability
- d. Duties related to primary care of one or more individuals who are ill or physically disabled



- e. Resident or patient of Veterans Health Administration Hospital
- f. Detention in jail/prison, awaiting trial, awaiting action by a grand jury, or in prison for conviction of a crime or offense which was not a felony

To obtain an absentee ballot, an Absentee Ballot Application must be filled out. Applications are available from the District Clerk either by mail, on-line, or in the District Clerk's Office between the hours of 7:30 a.m. and 3:30 p.m. The Absentee Ballot Application must be received by the District Clerk at least 7 days before the election if the ballot is to be mailed to the voter, or the day before the election, if the ballot is to be delivered personally to the voter.

Upon receipt of the completed Absentee Ballot Application, and verification of registration, the District Clerk will mail the ballot to the voter. The completed ballot must be received by the District Clerk no later than 5:00 p.m. on the day of the vote.

### **STRAW POLL INFORMATION**

A straw poll will be held on April 21, 2025 at 5:01 p.m., for the purpose of determining the placement of the candidates' names on the ballot. "In the event that any candidate is not present in person or by a person designated in a written proxy to accomplish the drawing, then I as the District Clerk, shall be authorized to act as proxy" (§§ 2032(2)(b);2608(2)).

### **CAMPAIGN EXPENSES**

Candidates for election to the Shelter Island Union Free School Board of Education must file Campaign Contributions and Campaign Expenses with the District Clerk, thirty (30) days prior to the Election, and also five (5) days prior to the Election, between the hours of 7:30 a.m. and 3:30 p.m. in the District Clerk's Office, and again twenty (20) days after the Election, a notarized statement, signed by the candidate, that election expenses incurred by her/him and others on her/his behalf, with her/his approval, have not exceeded \$500.

Candidates for election to the Shelter Island Union Free School Board of Education must file with the District Clerk, and the Commissioner of Education (Commissioner of Education, c/o Educational Management Services, New York State Education Department – 1075 EBA, 89 Washington Avenue Albany, NY 12234), thirty (30) days prior to the Election, five (5) days prior to the Election, and again twenty (20) days after the Election, a notarized statement, signed by the candidate, that election expenses incurred by her/him and others on her/his behalf, with her/his approval, were \$500 or more, itemizing all expenses.

Note: Section 1528 of the Education Law prohibits persons from making expenses on behalf of a candidate without the candidate's approval, unless such person(s) file a sworn statement with the District Clerk and Commissioner of Education that the candidate did not approve of expenditures. All such unapproved expenditures by any individual shall be limited to \$25 and are not to be included in the \$500 affidavit.

Campaign affidavits must include information up to date before day of filing.

Second affidavit need not repeat expenses listed in prior affidavit but such expenses shall be included in calculating \$500 limit.
