<p>PE Courses: Two PE teachers presented the following modified courses:</p> <ul style="list-style-type: none"> - Team Sports - Personal Fitness <p>They shared that they want to provide students an opportunity to meet the second year requirement. The different courses meet the needs of students who need to meet requirements for the second year</p>									

PE 10 requirement since PE 10 was renamed to Team Sports. Group Fitness was renamed to Personal Fitness.

Amy provided 7 minutes to the team to review Team Sports and Personal Fitness. All schools would not cover all 12 units. No additional questions. Consensus reached on Team Sports. Consensus to approve Personal Fitness.

PE teachers presented the following new course:

- Lifetime Sports

LifeTime sports will be provided for students who do not want to take Team sports. This course will provide students with options to satisfy PE requirements.

A question was asked around scheduling. Teacher shared that each site will need to discuss with their individual teams how they will schedule these courses.

Consensus to approve LifeTime Fitness.

There is a recommendation to change the names of a few courses from Performing Arts Courses. No changes to courses just course name changes:

Discussion around being transparent about the materials that will be used for the courses in the materials section.

All courses need to go to the site council and ask for clarity around what the process is on how courses get approved.
