FIRST READING OF PRESS PLUS POLICY UPDATE 117, 30 DAY REVIEW

Mr. Brown moved, Mr. Banks seconded the Approval of the District 205 TV and Digital Signage Pilot Program. This is a pilot that includes 22 digital screens in the most highly visible areas. Approximately 5-6 screens will be in the cafeteria, most office areas (inside or out). This will allow for students and staff to visually see morning announcements, upcoming events, etc. The expected rollout is April 14, 2025, to go live. The cost is approximately \$35,000.00. Dr. Cunningham stated the following:

Good evening, members of the board and community,

I want to address the many changes happening within our district, state, and nation, and I assure you that, despite these changes, the sky is not falling. Our Standard Operating Procedures (SOPs) for working with law enforcement, federal grants, and weather remain consistent. We have a system in place, and it has proven effective.

SUPERINTENDENT REPORT

Earlier this year, there was concern about how the district would deal with law enforcement. The district has partnerships with local law enforcement agencies, and we work together to keep our schools safe. We deal with state and federal law enforcement based on the law. We cannot and will not share records or release students or student information; that is the law, and we follow it. When parents send their children to our schools, we are responsible for caring for them. We operate in loco parentis—in place of parents—and ensure that all students are treated fairly.

Next, there was concern about federal funding; the district confirmed that all our funding was in place. We assured our employees that nothing was changing (for this year) and the community that we would not have interruptions in service. We have continuously operated based on the funding we receive and will continue to do so.

When mentioning finances, it reminds me that our district has made significant financial progress with assistance, moving from 60% Adequacy in 2018 to 98% Adequacy in 2025. In Illinois' Evidence-Based Funding (EBF) for education, financial adequacy refers to the funding necessary for a school district to provide a high-quality education to all its students. Additional state funding is then allocated to help us meet our Adequacy Targets. We thank Senator Harris, Representative Davis, and Representative Jones for all their work to get us to adequacy and to continue reducing the reliance on property taxes. This ensures we have the funding to educate our students while properly rebating taxes to the public.

We live in the Chicago Suburbs, and the weather will always be what it is: Hot in the Summer and cold in the Winter, with lake-effect snow and flooding from our creeks and rivers. The district has five eLearning days each year to work to ensure students and staff do not have to extend the school year because of inclement weather. Last year, we finished a major overhaul of our air conditioning systems, and we feel that heat will not be an issue that interrupts school. In October, we made plans for our Winter Weather issues with our employees, contractor support, and planning system. The employees and contractors will ensure our parking lots and sidewalks are clear and safe. The district will make weather determinations by 5:00 a.m. so that employees and buses do not commute on days we deem unsafe for travel. These are our processes – again the system works.

We continue to do the necessary work to educate our students and ensure they are enrolled, enlisted, or employed by graduation. This requires us to create and maintain systems that support our goals. Even in tough times, we must not fall into the trap of saying, "The sky is falling!" like Chicken Little. Instead, we stay true to our systems that continue to move us forward. All three of our schools are commendable, and we are on the road to exemplary status. Our kids and community deserve it, and I appreciate the teamwork we created to get us there. Thank you for your continued support and dedication to our students and district.
