- Remember that you ***must*** file your **2024 PA-1000 State Property Tax Rebate form** sign it and attached to your 2024 Senior Citizen Tax Rebate along with a copy of State rebate check that was issued to you or a copy of your bank statement indicating a direct deposit.
  - ***Please note if you have filed your 2024 Pa-1000 State Property Tax Rebate form and have not received your state rebate check by December 2, 2025, please call our office for further instructions.***
  - **ONLY accepting Rebate forms by mail.**
  - **Processing time is approximately 6 to 8 weeks.** ***Providing all information is correct and complete.***

The following is a brief summary of the program for assisting senior citizens to pay school taxes on the home that they own and occupy that was adopted by the Board of Education on \_\_\_\_\_

a. EFFECTIVE DATE: School Real Estate Taxes issued August 1, 2024 and **PAID** by December 31, 2024

b. ELIGIBILITY: One or more of the following (A, B, C):

1. A) One member of the household must be age 65 or over on December 31, 2024.
- B) Individual is a widow or widower and age 50 or over on December 31, 2024.
- C) Individual is permanently disabled and age 18 or over on December 31, 2024

2. INCOME: \$45,000 or less.

3. AMOUNT OF REBATE: based on income, as follows:

Household Income	Rebate Amount
\$ 0 - \$ 8,270	\$1,000.00
\$ 8,271 - \$15,510	\$770.00
\$15,511 - \$18,610	\$460.00
\$18,611 - \$46,520.	\$380.00
\$46,521 and over	not eligible

4. MAXIMUM REBATE - cannot exceed \$1,500.00, on **homestead only**.

5 Must provide all information on the CHECKLIST.

c. FILING - **LATE APPLICATIONS WILL NOT BE ACCEPTED NO EXCEPTIONS**

1. **WHEN TO FILE: August 1, 2025 - December 31, 2025**

**Applications postmarked after December 31, 2025 will be denied. Applications that are received incomplete will not be processed.**

2. **WHERE TO FILE: ONLY ACCEPTING APPLICATIONS BY MAIL, THERE WILL BE NO OFFICE HOURS OR DROP OFF THIS YEAR.**

d. A COPY OF THE ENTIRE RESOLUTION CAN BE OBTAINED UPON REQUEST.

Excessive claims made with fraudulent intent will subject the claimant to a penalty of 25% of the entire amount claimed. The claimant shall be guilty of a misdemeanor punishable by a fine of up to \$1,000 and/or imprisonment for up to one year upon conviction.
