# New Jersey Department of Education Title I School Parent and Family Engagement Policy

At Jospeh A Taub, we have monthly meetings for you to receive information and for you to share information with us. We have Unit Benchmarks, Linkit A, B, & C, and NJSLA assessments to measure the growth of our school and student achievement. We follow the New Jersey Student Learning Standards which are state adopted and approved. This curriculum is aligned with our assessments.

5. If the Annual School Plan (schoolwide program plan) is not satisfactory to the parents of participating children, submit any parent comments on the Annual School Plan (ASP) when the school makes the plan available to the local educational agency. The Annual School Plan was accepted by parents and involved the achievement of ELA goal, Math Goal, Data Goal, and Attendance Goal. These goals are to improve our school.

#### D. Shared Responsibilities for High Student Academic Achievement

As a component of the school-level parent and family engagement policy, each school shall jointly develop with parents for all children served under this part a school-parent compact that outlines how parents, the entire school staff, and students will share the responsibility for improved student academic achievement.

As a school community together we will monitor student growth on assessment scores and uphold high student achievement. We will celebrate our data at our monthly meetings as a community.
