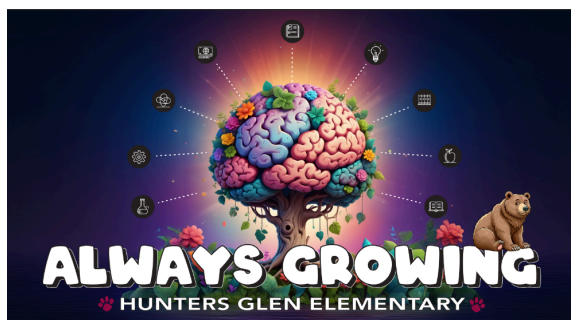

Safety and Security Update

From now on, any visitor who is not in our system MUST have a valid ID or a picture of their ID through the myColorado app on their device to be issued a visitors badge and be let in the school. If you have had your ID scanned this year, you may continue to sign in on the computer, as normal. For those who have not had their physical ID scanned or entered through the myColorado app, you will need to have your ID in our system before being let in the building. It is best to always have your ID with you when you need to enter Hunters Glen or any Adams 12 schools as the system can often delete previous scanned IDs when there is an update to the software.

Vaccine Exemptions:

Note that under Colorado law a student may be exempted from immunizations if they have a signed medical exemption or a parent/guardian has completed one of two options for a non-medical exemption. Non-medical exemptions expire on June 30th of each year and must be submitted annually - after July 1st for the next school year. Please read the requirements for non-medical exemptions in the notice.
