NOTES ON THE DEVELOPMENT OF THIS MEETING SCHEDULE

Board/Superintendent's Operating Procedure 18 provides:

1. *No later than March 1st of each year, the Board President, in cooperation and consultation with the Superintendent, shall begin to develop the Board's annual calendar of Workshop and Regular and Pre-Agenda Board meetings. The calendar shall be posted to the District's website after it has been approved by the Board.*
4. *Board Workshops will generally be held on the second Monday of each meeting month, while Regular Board Meetings will generally be held on the fourth Monday of each meeting month. Where calendar conflicts arise, the Board will give consideration to specially observed days, but will set meeting dates based on the needs of the system.*

In addition, BE (LOCAL) - BOARD MEETINGS provides:

Regular meetings of the Board shall normally be held monthly except for the month of July.

There are a few exceptions where Board meetings are not scheduled on the second and fourth Mondays of each month:

- **September** –The Regular Meeting is scheduled for the fifth week due to Rosh Hashanah.
- **October** – The Workshop Meeting is scheduled for the second week Tuesday due to Columbus Day.
- **November** – The Regular Meeting is scheduled for the first week, and the Workshop Meeting is scheduled for the third week due to Thanksgiving break.
- **December** – Due to the Winter break, no Regular meeting will be held; instead, an all-day workshop/winter retreat meeting will be held in December.
- **January** - The Regular Meeting is scheduled for the fourth Tuesday due to the TASA Midwinter Conference.
- **March** – The Workshop is scheduled for the first Monday due to Spring Break.
- **April** – An all-day workshop/retreat meeting will be held on Friday of the third week.
- **May** – The Regular Meeting is scheduled on Tuesday due to Memorial Day.

Other Discussion Points:

May 13 Canvass Meeting – The meeting could be earlier or later. By law, it must fall on a date that is 3 to 11 days after the May 2 election (May 5 to May 13). Note: If provisional votes are cast in the election, it can take 4-5 days to verify them.

Notes:

- No conflicts were identified with significant religious holidays.
- This schedule is for regularly scheduled Board Meetings only. The Board has the right to set additional meetings as the need arises.
