1. Review of 2025-2026 Tentative Budget- Dr. Kochis & Mrs. Metzgar presented the 2025-2026 tentative school budget. Detailed information was provided regarding projected revenues and expenditures. Information was also provided on state aid, tax levy and impact, enrollment projection, available adjustments, school programs, building projects, and the future of funding for the district.

As per NJAC 6A:23A-7.3, the proposed budget provides for a maximum expenditure amount that may be allotted for travel and expense reimbursement. The maximum amount of travel and expense reimbursement for the 2024-2025 budget was \$10,494. As of March 1, 2025 the amount spent to date is \$5,282.63. The 2025-2026 tentative budget includes a maximum travel appropriation of \$11,546. The School Business Administrator shall track and record these costs to insure that the maximum amount is not exceeded. Included in the 2025-2026 proposed budget is a maximum regular business travel amount of \$1,500 per employee.

Further be it resolved, the Stillwater Township Board of Education approves the use of \$132,354 in Enrollment Adjustment, which will support instructional costs in the 2025-2026 fiscal year budget.

Further be it resolved, the Stillwater Township Board of Education approves the use of \$119,736 in Healthcare Adjustment, which will support increased costs of healthcare in the 2025-2026 fiscal year budget.

Further be it resolved, that included in line 630, Budgeted Withdrawal from Maintenance Reserve is \$80,000 for parking lot repairs and general maintenance costs.

This proposed budget includes sufficient funds to provide curriculum and instruction which will enable all students to achieve the New Jersey Student Learning Standards, and is in compliance with N.J.S.A. 18A and N.J.A.C. Title 6 and 6A.

NOW, THEREFORE, BE IT RESOLVED that the Board formally approves the budget workbook and narrative submission for the grant listed above for a total award of \$908,922 of PEA aid based on per pupil costs, 25% Carryover deduction of \$-52,829, \$47,838 general fund contribution as required, and the use of \$111,327 in carry over funds. Grand total of the 2025-2026 anticipated budget of \$1,015,258.

BE IT FURTHER RESOLVED that the school administrators are hereby authorized to submit an electronic grant application to the New Jersey Department of Education on behalf of the Stillwater Township Board of Education.

BE IT FURTHER RESOLVED that Superintendent and Business Administrator are hereby authorized to sign the grant agreement on behalf of the Stillwater Township Board of Education and that their signature constitutes acceptance of the terms and conditions of the grant agreement and approves the execution of the grant agreement.

<u>Dave Manser</u>-Stillwater Township Liaison-He understands the budget is very tough to develop especially with losing all the state aid. He commended the board for a job well done. Mr. Manser also thanked Dr. Kochis and expressed he was sad to see him leave, but good luck in the future.

<u>Kaitlyn Hammerle</u>-952 Millbrook Road- Asked about the snack policy for school parties if it is directed from the state or a local policy. Dr. Kochis responded that it is a local policy developed and reviewed by our wellness committee. Mrs. Hammerle also questioned the difference of snacks at the parties and the snacks available for school lunch. Dr. Kochis said that our wellness committee is still working on different ideas to ensure the healthy eating of our students throughout the day.
