What is Running Start?

Running Start is a program that allows 11th and 12th grade students to take college courses at a community or technical college.

- High school and college credits
- Classes are at the college
- Taught by college instructors
- Full-time or part-time
- College level placement required for tuition free enrollment
- Different than College in the High School (CHS), CTE Dual Credit, and AP



What is Running Start?

- ❖ Tuition-free: traditionally up to 15 credits, now up to 18 or even 21
- ❖ Families incur some costs: textbooks, class fees, parking, courses under 100 level
- ❖ Summer classes have not been tuition-free in the past, though some exceptions now exist.
- ❖ Transportation is not provided to the college.
- ❖ Students must maintain good standing in GPA.





- One **5** credit college class is equivalent to **1** credit at the high school. For example, if you take **English 101 (5 credits)** at the community college that will count for the entire year of **English 11** at the high school.

Semesters vs. Quarters



- GP has two semesters →
3 high school credits per semester =
6 high school credits per year
- Running Start has three quarters →
15 college credits / 3 high school
credits per quarter =
45 college credits / 9 high school
credits per year

Running Start Enrollment Steps

Check these steps off as they are completed

- Student and parent/guardian **read through this entire packet**.
- Student and parent/guardian **research colleges** for Running Start and **choose** which one the student will apply to.
 - Google search: "(Name of College)" and "Running Start". Colleges most often attended by GP students: Everett Community College, Cascadia College, Edmonds College, Bellevue College, Lake Washington Technical Institute.
 - Go to the Running Start webpage of the college of your choice to sign up for and attend a Running Start information session (if offered by the college).
- Student **applies online to the college**.
- Student **applies online to Running Start at the college**. The application process differs by college but will include **completing English placement** through the college (and Math placement if planning on taking a math course through Running Start next year). The placement process differs by college and may involve taking a test (e.g., Accuplacer) or submitting materials (e.g., transcript or SBA scores).
- Student and parent/guardian **complete and sign the attached agreement**.
- Student and parent/guardian **send or give the attached agreement to the student's GP counselor**, who will set up a meeting to change GP course requests and create a Running Start Enrollment Verification Form (RSEVF).
- Student **sends the completed RSEVF to the Running Start Office** at the college.
- Student **completes college requirements for advising and registers** for college classes on the college's website.

Running Start Enrollment Verification Form (RSEVF)

- Your RSEVF is completed with your high school counselor **EVERY** quarter you attend Running Start.
- It is your responsibility to schedule an appointment with your counselor to complete your RSEVF at least 7 days before your registration date.
- Your registration will be blocked each quarter until you submit your RSEVF.

If the student enrolls for more high school and college credits than are identified in the Running Start Funding Limit Table, the student is responsible for: <ul style="list-style-type: none"> 1) paying all college tuition and fees associated with exceeding the college credits identified in the table; 2) withdrawing from the excess college or high school course(s). Unless waived based on family income, the student is required to pay any college/lab fees charged for college classes. The signature below acknowledges the need to share FRPL eligibility only with the college to ensure access to tuition/fee waivers. Choosing not to disclose income status (see checkbox in "Student" section) will not affect eligibility for Running Start or free and reduced-price meals. Individuals receiving the information will not share it with any other entity or program. Enrollment in specific college classes cannot be guaranteed—even if the classes are needed to fulfill high school graduation requirements. To add/withdraw from a course, the student must complete the college Add/Drop process by the college deadline and notify the high school counselor. The student is responsible for ensuring that college courses completed as part of the Running Start program will meet high school graduation requirements. If the student plans to transfer, it is the student's responsibility to determine college admissions policies/deadlines and whether earned college credits will transfer. After completing their college coursework, students are responsible for requesting official college transcripts through the college's registrar's office. 			
<small>Per the U.S. Department of Education, "If a student is attending a postsecondary institution - at any age - the rights under FERPA have transferred to the student. However, in a situation where a student is enrolled in both a high school and a postsecondary institution, the two schools may exchange information on that student. If the student is under 18, the parent(s) or guardian(s) still retain the rights under FERPA at the high school and may inspect and review any records sent by the postsecondary institution to the high school. Additionally, the postsecondary institution may disclose personally identifiable information from the student's education records to the parent(s) or guardian(s), without the consent of the eligible student, if the student is a dependent for tax purposes under the IRS rules."</small>
