BOARD FOCUS: Action Required

Responses to the District's Request for Qualifications (RFQ) for Construction Management at Risk (CMAR) Services were received on February 6, 2025, for the Facilities Maintenance Project. The scope of work involves providing CMAR services including design phase collaboration, budget management, schedule adherence, quality assurance, and minimizing disruption during construction to successfully deliver projects across the District.

The Long-Range Facilities Plan emphasizes the importance of addressing aging infrastructure of school facilities across the District. The scope of work in this project focuses on modernization and deferred maintenance, funded through the Building Fund, which aligns with the plan's aim to ensure all facilities can support modern educational programs and remain operationally efficient.

Three responses to the RFQ were received. Administration interviewed the firms on Thursday, March 13, 2025 and ranked based on the following rubric:

Based on the final rankings, Administration recommends Gehrtz Construction Services (Gehrtz) for CMAR services for the multi-facility projects.

A preliminary list of projects is attached to this memo which are planned to begin the summer of 2026 with completion by the winter of 2026. During the initial phase of work, the construction manager will work with the facilities team to finalize the budgets and scopes of work at the various locations. We will then determine which projects fit within the budget and proceed accordingly.

Construction Manager at Risk Fees and Approval Process:

- Design Phase Fee: The \$15,000 fee previously approved pertains solely to the design phase services provided by Gehrtz.
- Guaranteed Maximum Price (GMP) Approval: As the project progresses, the Construction Manager (CM), Gehrtz, will develop a GMP that encompasses the full scope of work, including all phases beyond design. This GMP will include all remaining CM costs such as:
 - o Construction management (e.g., on-site supervision, coordination, safety management)
 - o General conditions, overhead, and profit
 - Bonding and insurance costs
 - o Post-construction services (e.g., project closeout, warranty management)
- The costs listed above generally fall between 10-20% of a project's overall budget. The preliminary budget for this project is \$10,000,000; the total paid to the CM will fall between \$1,000,000 and \$2,000,000 based on the final project scope, phasing, staffing, bidding, and other project variables that are established during the design phase of the project.

The GMP will be presented to the Board for review and approval, ensuring comprehensive oversight of the project's total costs and financial planning.

RECOMMENDATION: Accept the proposal from Gehrtz Construction Services for Construction Management at Risk Services on the Facilities Maintenance Project and issue a contract accordingly.
