Wildcat Spotlight—JES and Ireland Elementary Update—Kent Taylor-Shannon Bauer-Ryan Erny
 The principals gave a presentation specific to the progress made in diversity and Non-English speaking students resources. They also informed the Board about the Arts Programs, Music Programs, Library Programs and Social Workers Programs.

Mr. Taylor thanked the School Boards' past and present as well as his family, saying that a positive attitude has been key to his success. Building & Maintenance Update—The Stenftenagel Group

The President stated that the Building Corporation was previously formed to assist the School Corporation in the financing of certain projects. After discussion of the proposed Building

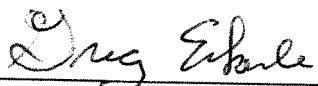
Corporation, and upon motion duly made, seconded, and carried, the Board adopted the resolution attached as Exhibit C.

RESOLUTION DETERMINING NEED FOR PROJECT

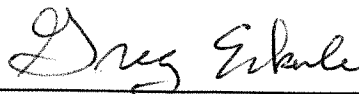
WHEREAS, an investigation has been conducted by the Board of School Trustees (the "Board") of Greater Jasper Consolidated Schools (the "School Corporation") with respect to the construction, renovation and improvements at Jasper High School, Jasper Middle School, and Jasper Elementary School, including classroom additions, HVAC improvements, deferred maintenance improvements, site improvements, and the purchase of technology and equipment (collectively, the "Project") and leasing all or a portion of the Project from the Greater Jasper School Building Corporation (the "Building Corporation"); and

WHEREAS, this Board now finds that a need exists for the Project, and that the School Corporation cannot provide the necessary funds to pay the cost of the Project required to meet such need; and

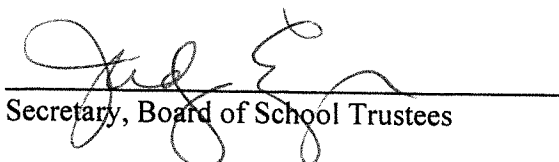
WHEREAS, it is deemed desirable to proceed with the necessary negotiations and all other steps looking toward the financing of the Project by the Building Corporation and the lease of such facilities to the School Corporation; now, therefore,

BE IT RESOLVED, that a need exists for the Project, and that the Project cannot be funded from sufficient funds available to the School Corporation, and that this Board proceed to take such steps as may be necessary to secure the Project and leasing of such school facilities as provided by the Indiana Code Title 20, Article 47, Chapter 3.

RESOLUTION APPROVING FORM OF LEASE

WHEREAS, the Greater Jasper School Building Corporation (the "Building Corporation") has previously been organized pursuant to the Indiana Nonprofit Corporation Act of 1991 for the purpose of constructing, renovating and improving facilities for the use of the Greater Jasper Consolidated Schools (the "School Corporation"); and

WHEREAS, counsel for the Building Corporation has drafted and submitted a proposed Lease Agreement (the "Lease") for renovations and improvements to Jasper Middle School building (the "Leased Premises") and other school facilities owned and operated by the School Corporation; and

WHEREAS, preliminary plans and estimates (collectively, the "Documents") for the completion of renovations upon the Leased Premises and other school facilities owned and operated by the School Corporation have been prepared; and

WHEREAS, the Documents have been submitted to and now meet with the approval of this Board of School Trustees (the "Board"); and

WHEREAS, such Documents have been marked to indicate the work covered by the proposed Lease; and

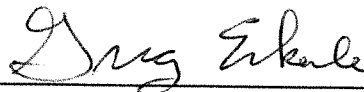
WHEREAS, it now appears to this Board that the preliminary Documents provide the necessary facilities for the students of the School Corporation, and that the proposed Lease with the Building Corporation provides for a fair and reasonable rental; now, therefore,

BE IT RESOLVED, that the terms and conditions of the proposed form of Lease and the Documents are approved and agreed to as the basis for a hearing, as required by law, and that such hearing should be held by this Board upon the necessity for the execution of such Lease and whether the Lease rental provided therein is a fair and reasonable rental for the proposed

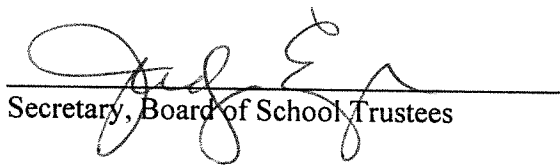
construction and renovation, prior to final determination of such questions, so that this Board may determine whether to execute such Lease as now written, or as modified.

BE IT FURTHER RESOLVED, that the Secretary's publication of a notice of such hearing as required by law is hereby ratified and confirmed; further, that any references in such notice to the "Greater Jasper Middle School Building Corporation" are hereby ratified and confirmed to apply to the "Greater Jasper School Building Corporation."

EXHIBIT C

RESOLUTION REAPPROVING BUILDING CORPORATION

WHEREAS, the Greater Jasper School Building Corporation (the "Building Corporation") had previously been formed as a not-for-profit corporation to assist in financing, renovating, constructing and improving facilities within the Greater Jasper Consolidated Schools (the "School Corporation"); now, therefore,

BE IT RESOLVED by the Board of School Trustees (the "Board") of the School Corporation, as follows:

SECTION 1. That it is hereby determined to be proper and in the public interest of the citizens of this School Corporation to reapprove the incorporation of the Building Corporation known and designated as the "Greater Jasper School Building Corporation" for the purpose of financing, renovating, constructing and equipping certain school facilities and leasing same to this School Corporation.

SECTION 2. That the Articles of Incorporation and Bylaws of the Building Corporation, previously presented to the Board, are hereby reapproved.

SECTION 3. That providing for the financing, renovating, constructing and equipping of such school facilities by the Building Corporation and the leasing of same to this School Corporation is in the public interest of the citizens of this School Corporation, and it is a proper public purpose for which this Board agrees to cooperate with the Building Corporation and to assist it in fulfilling the requirements of all agencies of the federal, state and local governments.

SECTION 4. That the issuance, sale and delivery by the Building Corporation of one or more series of bonds designated "Greater Jasper School Building Corporation Ad Valorem Property Tax First Mortgage Bonds, Series 2025" (or such other name or series designation as

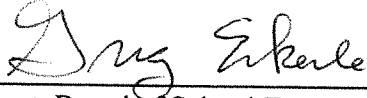
determined at the time of sale) (the "Bonds") in the aggregate principal amount of approximately \$41,615,000 is hereby approved.

SECTION 5. That, upon the redemption or retirement of the Bonds, the School Corporation will accept from the Building Corporation title to such school facilities, free and clear of any and all liens and encumbrances thereon.


SECTION 6. That this Board hereby approves to serve as Directors of the Building Corporation the persons as appointed by the Building Corporation at a meeting of the Building Corporation which has been duly conducted on the date hereof.

SECTION 7. That the Building Corporation may issue, sell and deliver the Bonds, pursuant to the applicable laws of the State of Indiana, may encumber any real property or equipment acquired by it for the purpose of financing the construction and equipping of such school facilities and may enter into contracts for the sale of the Bonds and the construction and acquisition of such school facilities.

A meeting of the Board of Directors (the "Board" or "Directors") of Greater Jasper School Building Corporation (the "Building Corporation") was held at the Community Room, Jasper High School, 1600 St. Charles St., Jasper, Indiana, Jasper, Indiana, on February 24, 2025, at the hour of 6:30 p.m. (Local Time), pursuant to call and waiver of notice, duly signed by the Directors, which appears in the minute book immediately preceding the minutes of this meeting.

The Directors were present or absent as stated:

[A majority of the Directors being present, the President presided and the Secretary kept the minutes of the meeting.

The minutes of the last meeting of the Board were read and approved.

A quorum was present and discussed the resignation of Frederick Hollinden from the Board. Pursuant to the bylaws, the remaining members of the Board appointed Bernard Vogler to fill the vacant position(s) after accepting the resignation.

With all Board members now appointed and serving, the following individuals were unanimously elected to serve as the officers of the Corporation until the next annual meeting:

President: Anne Brosmer

Vice President: Bernard Vogler

Secretary/Treasurer: Jerrill Vandeventer

[Counsel next stated that another purpose of this meeting was to consider a proposed Lease Agreement (the "Lease") between the Building Corporation and Greater Jasper

Consolidated Schools (the "School Corporation"), including the plans and estimates referred to therein and made a part thereof. The President presented the plans and estimates, and a form of the Lease, and stated that the Lease provided for an annual rental payment in an amount not to exceed \$7,500,000, plus additional rental for taxes and assessments. It was also stated that the Lease granted an option to the School Corporation to purchase the property leased thereunder on certain conditions after the lapse of a specified period of time, and that the Lease will run for a period of twenty-two (22) years. It was stated that before the School Corporation can enter into the Lease, the School Corporation must hold a public hearing on the Lease, and that under the controlling statutes, the expense of publications of the notice of the Lease hearing must be assumed by this Building Corporation. The Lease was examined by all Directors present and its terms and provisions discussed.

On motion duly made, seconded and carried, the following resolution was adopted:

WHEREAS, a Lease Agreement (the "Lease") between the Greater Jasper School Building Corporation (the "Building Corporation"), as lessor, and the Greater Jasper Consolidated Schools (the "School Corporation"), as lessee, and plans and estimates for the Jasper Middle School to be leased thereunder were presented to this meeting; and

WHEREAS, the Board of Directors (the "Board" or "Directors") of the Building Corporation have reviewed the Lease and the plans and estimates; now, therefore,

BE IT RESOLVED that the plans and estimates have been marked to indicate the work which is covered by the Lease; and that the plans and specifications as so marked are hereby approved.

BE IT FURTHER RESOLVED that the proposed Lease between the Building Corporation and the School Corporation, submitted to this meeting, be and the same hereby is approved.

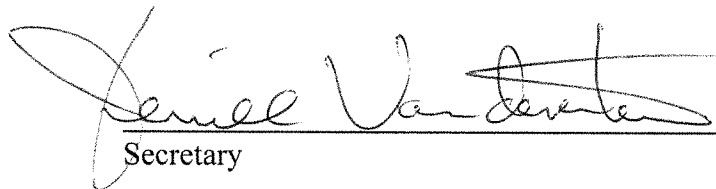

meeting, and the Lease is made a part of this resolution as fully as if the same were set forth herein.

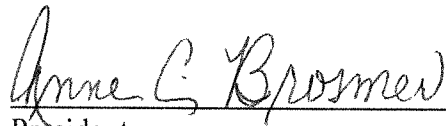

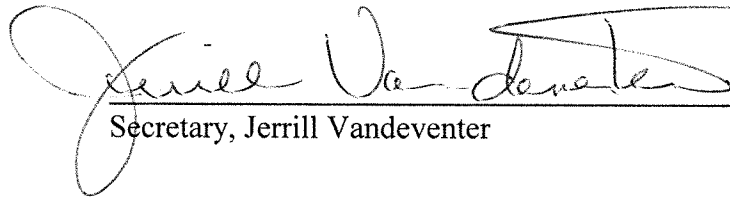

EMPLOYMENT AGREEMENT FOR CONSULTING SERVICES
AND FOR INTERIM SUPERINTENDENT SERVICES

COMES NOW the Greater Jasper Consolidated Schools ("GJCS"), and COMES NOW Mary Roberson ("INTERIM SUPERINTENDENT"), and based upon the mutual promises, covenants and consideration herein contained, do agree as follows:

1. GJCS shall employ the services of INTERIM SUPERINTENDENT to act as consultant to GJCS commencing on January 28, 2025, and continuing until terminated as provided herein. INTERIM SUPERINTENDENT's employment herein is as a consultant and as an independent contractor. INTERIM SUPERINTENDENT shall determine the days and hours that she will work to deliver the services provided for herein and will also determine the means and methods of providing those services. The services to be rendered in general are those services customarily rendered by a superintendent of a public school corporation, which include, but are not limited to those described in the attached Exhibit "A". The INTERIM SUPERINTENDENT shall, in all regards, exercise her independent professional judgment as to how to perform the services to be rendered to GJCS.

2. It is understood between the parties that the INTERIM SUPERINTENDENT is expected to perform at least ten (10) days of on-site services per month for GJCS pursuant to this agreement. The parties further understand that under no circumstances shall INTERIM SUPERINTENDENT be expected to provide services to GJCS more frequently than ten (10) on-site days per month.

3. INTERIM SUPERINTENDENT shall be compensated in the amount of Ten Thousand Dollars (\$10,000.00) per month for each month services are provided pursuant to this agreement. Should the need arise, the INTERIM SUPERINTENDENT, at her discretion, may provide more than ten (10) days of on-site services at the rate of \$1,000.00 per day not exceed five (5) additional days for a total of \$5,000.00. If the INTERIM SUPERINTENDENT provides additional on-site days in excess of this amount she will doing so without the expectation of additional compensation.

4. Payments shall be made upon submission and approval by GJCS of a properly itemized executed claim. If the services of the INTERIM SUPERINTENDENT are terminated prior the completion of a full month of service the INTERIM SUPERINTENDENT shall be paid on a pro rata basis for the days actually served based upon the total number of days in the month of termination.

5. This agreement may be terminated by either party upon seven (7) days written notice to the other party.

6. INTERIM SUPERINTENDENT shall be responsible for assuming and paying all expenses incurred in connection with providing services pursuant to this Agreement.

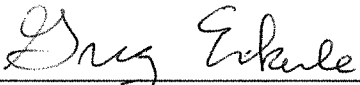

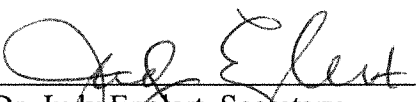

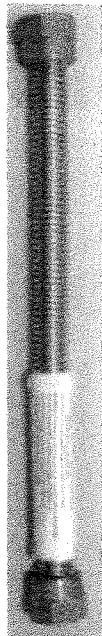

SAFETY WARNING



Flexible gas connectors are used to bring gas from supply pipes to appliances such as stoves, dryers, and room heaters. They are made of corrugated metal tubing—newer models being fabricated from stainless steel or from brass that has been coated with plastic. Most older connectors, however, were made from uncoated brass.

Some of the uncoated brass connectors have a serious flaw in the way they were made. Solder was used to braze, or join, the flexible brass tubing to the new pieces. Over time, the brazing can fail causing a serious gas leak. This could lead to an explosion or fire.

It is very difficult to see whether a flexible connector has been brazed so don't take a chance. If you have an uncoated brass connector in your home, it should be replaced with either a new stainless-steel or a new plastic-coated brass connector.

In fact, it's a good practice to replace any flexible gas connector which is more than 10 years old. This is because flexible connectors are not meant to last a lifetime. Older units can wear out from too much moving, bending or from corrosion. If you can, check your flexible connector without moving the appliance attached to it. If you cannot make this check without moving the appliance, we recommend that you have a service contractor inspect the connector for you. Moving the appliance could strain the connector, possibly causing a gas leak. So, if your appliance must be moved, it's best to have a professional on hand to do it.

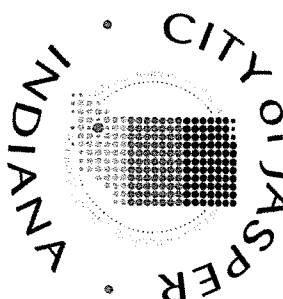
If a replacement is needed, make sure the new connector is certified by the American Gas Association (AGA) and conforms to the American National Standards Institute (ANSI) standard Z21.24.

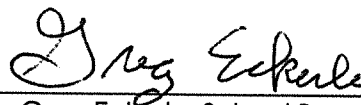
