Dear Members of the New Hartford Board of Education and Board of Finance,

My name is Mary Coburn, and I am a parent of four children in the community. I went to school for Psychology with a background in Early Childhood Development. I also run a preschool in town and have a CT-AIMH Endorsement for Infant and Young Child Mental Health. I am writing to express my deep concern regarding the potential elimination of critical programs such as Band, Chorus, the Talented and Gifted (TAG) program, Math Olympiad, and essential support position that helps our teachers focus on teaching rather than overwhelming administrative tasks. These programs and positions have played a significant role in the education of my own children, helping to nurture their self-confidence, self-esteem, and love of learning. I know many other families who share these sentiments and feel equally impacted.

The district's current five-year strategic plan aims to improve school climate to allow teachers and students to maximize their potential in a positive learning environment. However, taking away

programs like Band, TAG, and Math Olympiad, along with essential support positions that help teachers focus on students rather than overwhelming prep work, will do the exact opposite.

Music and the Arts, like Band, are so much more than extracurricular activities. They help children build self-esteem, creativity, and cognitive skills. I have seen firsthand how participating in Band has helped my children grow more confident and comfortable expressing themselves. Two of my four children who struggle with dyslexia and dysgraphia learning to read sheet music was a feat that they are incredibly proud of. Cutting these programs would strip away opportunities that nurture personal growth and emotional well-being—essential components of a positive school climate.

If Band is made into an afterschool program, many children will be excluded from participating, and families who do participate will be forced to seek expensive lessons outside of school. The dedication of our music teachers cannot be overstated. Spend just a moment around our band teacher, and you'll see someone who is always smiling, excited, and driven her passion for band and music flowing out around her. My children are currently coming home inspired, writing songs and poetry because of how chorus has stimulated their creativity. Losing our passionate, dedicated music teachers would be a tremendous loss that would be felt for years to come. If you move Band to afterschool hours, you risk losing some of the biggest assets in our schools—the teachers.

The TAG and Math Olympiad programs provide advanced learners with the challenges they need to stay engaged and excited. Many of history's brightest minds and influential innovators were given opportunities like these as children. People like Albert Einstein, Katherine Johnson, and Bill Gates thrived because they were challenged to push boundaries and think creatively. Without these opportunities, many students will feel neglected or unstimulated, which can lead to frustration and disengagement.

I have witnessed firsthand how my children felt lost and disengaged before reaching the grades where they could participate in these activities. This year, they are creating inventions, collaborating with others, and turning their ideas into tangible projects. It's been thrilling to see them learn and grow through these experiences. Investing in all levels of education is essential to maintaining the strongest, most effective school system possible.

Support positions that assist teachers with planning, preparation, and administrative tasks are critical. Without this help, teachers will be stretched too thin, forced to spend valuable time on tedious prep work instead of teaching and supporting our children. This burden will only lead to burnout and force talented teachers to leave. Children today are vastly different from previous generations shaped by technology, societal changes, and more. Teaching has become significantly harder, and more is required of our educators. Taking away essential support will only hurt the entire education system.

If we are serious about improving our school climate and giving students the best possible chance to thrive, we must preserve these vital programs and the support systems that allow our teachers to focus on what matters most our children, the very ones who will one day guide us into the future.

There are many things parents can take pride in when it comes to our school system. Having a Blue Ribbon High School is a testament to the strength and quality of the education provided at all levels, starting from our elementary and middle schools. Almost everyone I meet who is trying to move into our highly sought-after district, or who has already moved here, says it's because of our school system. I hear this time and time again, and I am deeply involved in our community. I know many families who would seriously reconsider staying here if our schools no longer offered the challenging, engaging, and top-tier education that makes our district so special.

We must step back and consider the bigger picture—the long-term future and success of our entire district.

Thank you for your time and attention to this matter. I hope you will seriously consider the importance of keeping these programs and supports intact for the benefit of our students, teachers, and the entire community. To further support the need for these vital programs, I encourage you to review the district's strategic plan for 2022-2027 a link under the word MISSION on <https://antolini.newhtfd.org/>.

I also would like to add that I do not believe this burden should fall entirely on the Board of Education. The Board of Finance must step up and meet these essential programs halfway at the very least, by yes raising the taxes slightly. What we are asking for is a modest increase—equivalent to the cost of just a few cups of coffee for the approximately 4,000 taxpayers in this school system.

Dear Board Members and Mr. Sousa,

After listening to the 'Public Comment' at the Board of Education meeting on Tuesday, I feel the need to send a follow-up letter regarding the clerical aide position.

It occurred to me that most of the board members, and perhaps even Mr. Sousa, may be unaware of an important piece of information. Originally, there were two Instructional Aides in the district. About nine years ago, during a similar budget meeting, the Instructional Aide positions were slated for removal. After passionate pleas from our primary schools, the board ultimately decided to cut the position here at Antolini while sustaining it at Bakerville and New Hartford Elementary. As a result, we at Antolini were forced to absorb the work mainly done by the IA among the paraprofessionals, the office staff, and, primarily, the

classroom teachers. I have seen firsthand the extra work the loss of that position has caused the building and faculty as a whole.

Now, we are faced with the prospect of eliminating another position that benefits the entire school. My concern is that Antolini is at risk of losing yet another position that helps support the largest number of students and staff in the district, as well as Oak Hill. This would further disrupt the balance of office support relative to the student/staff ratio. The clerical aide position provides essential support to both the office and the entire staff. I implore you to reconsider this decision and not allow Antolini to once again bear the brunt of these budget cuts. It has been proven that the office at Antolini cannot function properly with only one person.

On another note, I strongly support keeping our band and music program here at Antolini. I firmly believe it is one of the programs that reaches the largest number of students. Students who may never have known about a talent they possess are given the opportunity to explore a new avenue. My daughters started their musical journey here at Antolini and continued with their love of music through Northwest Regional and even throughout their college careers. While I have never played an instrument or sung in a chorus, I am grateful that the music program at Antolini School fostered that passion in them.

I am writing to you today as both a concerned parent and taxpayer regarding the proposed budget cuts to our educational programs, specifically those that impact the arts and gifted education. As you are aware, the proposed cuts threaten the funding for vital programs such as band, chorus, the talented and gifted (TAG) program, and Math Olympiads, and I feel it is important to share

my concerns about how these reductions will impact our students, families including my own, and the community as a whole.

As a parent, I have seen firsthand the positive impact these programs have had on my child and others in our community. Participation in the band has provided my child with a sense of belonging, creativity, and discipline that extends well beyond the classroom. Rather than eliminating these opportunities, I urge you to explore other avenues for budgetary adjustments that will not compromise the future of our children and their ability to thrive in a rapidly changing world. Dear Mr. Klepps,

I'm writing concerning the proposed budget cuts for the New Hartford Schools. I realize that the Board of Education needs to be fiscally responsible, but my understanding is that they are also supposed to keep the better interests of the students in mind.

I'm going to specifically discuss one specific budget cut you are proposing. Let me provide some context. I was the chairperson of the NWR7 Music Parents Association for 10 years when our children were students at the middle and high schools. Both were avid musicians, and started their instrumental music studies at Antolini School. They were in the band there, as well as at the Middle and High Schools. In addition, both played at the Hartt School Precollege ensembles (Greater Hartford Youth Wind Ensemble, and Connecticut Youth Symphony). They were seated in the All State and Regional ensembles every year they were in Middle and High Schools. Our son also played in a number of auditioned ensembles and summer programs. Both continue to play their instruments as adults. Our son is a professional freelance musician, and our daughter continues to play her instruments for pleasure.

There is no doubt that our children would not have been competitive musicians for any of the ensembles if they hadn't started their instrumental studies at Antolini School. The vast majority of instrumentalists doing auditions for outside ensembles have studied their instrument and played in ensembles since elementary school. We were very grateful our children had this opportunity. In addition to building music skills, they learned commitment, working as part of a group, taking clear direction, and enjoyment of instrumental music. I don't think any of these things should be lost on future students.

There is much research about the benefits of music education, and how this impacts overall learning, and the whole person.

For the life of me, I don't understand how cutting the Antolini Band would even be a consideration in your budget talks. This should be high on the list of programs to maintain, and grow, not eliminate.

I strongly urge you to reconsider this cut in your budget. I think it's very short sighted, and not in the best interest of our students.

I should add, I'm still a resident of this community, and no longer have children in the schools. Nevertheless, I would urge you to maintain the elementary instrumental music program and band program.

I appreciate how much care is being put into the budget of New Hartford schools this year. I am invested in this year's budget in two ways; as an employee and as a parent. My husband and I moved to New Hartford in 2008 planning ahead that this is where we would love to raise a family and the school system was reason number one. We both grew up in Harwinton and agreed that this town would give our children different opportunities than we had. The teachers and staff are phenomenal, and incredibly dedicated to the children in the schools. Until this year, I hadn't realized how dangerously close our children are to losing opportunities that my husband and I both had growing up. I was a part of our band program for seven years and joined the high school marching band. This time in band created long lasting, amazing friendships, and a feeling of belonging to something passionate that has carried on into my adult life. Chorus did the same thing for me and I am forever grateful.

Both of our children have a love for music and singing and I was really looking forward to them joining something that we had growing up. As an artist myself, I will always advocate for the arts, in many capacities, as being one of the most important experiences of a young person's life. All of the arts help a child's development cognitively, creatively, boosts their self-esteem as well as fostering their social-emotional maturity. It also improves fine-motor skills and their math and science skills learning about shapes and spatial reasoning and making comparisons. The arts are also an important outlet for many kids and it's something that they will carry on into adulthood as a safe way to express themselves. My husband is a veteran and now a quality engineer and the way his brain is stimulated is different than mine. He would have benefited from programs like TAG and Math Olympiad's growing up. It would have given him the math and problem-solving skills that he learned in the army and now at his courant job, at an earlier age. It wasn't until learning in a very serious way, being deployed overseas in the army and then in college that he really was able to develop and advance his talent with numbers, problem solving and efficiency. We both share our loves from all sides of learning with our kids and we need the schools help to provide the missing pieces of community and inclusivity in all areas where kids are talented.

I urge you to please reconsider closing these programs and encourage our community to rally together and provide for these kids who we love and are our future. We all want the best for our children and I think all New Hartford residents would agree. To the Board of Education:

My name is Matt Flaherty, and I am a taxpayer with three children currently enrolled in the New Hartford Public Schools. I am writing to ask that the Boards of Education and Finance reconsider the proposed education budget for the 2025/2026 year. I am not only concerned by the magnitude of cuts proposed this year but also disappointed with the year-over-year trajectory of the education budget. It is clear that the drastic measures identified in the proposed budget have been several years in the making.

For the past few years, Superintendent Sousa has proposed reasonable budgets that account for capital needs and rising costs associated with contractually negotiated obligations while simply maintaining academic programs and instructional services. Each request has been met with a directive to reduce spending and find cuts. Managing increased obligatory costs with constant cuts to academic programs, instructional services, and staff is neither responsible nor sustainable. The painful cuts now under consideration, coupled with the district's difficulties in responding to unanticipated costs, are the result of continued underfunding, and it's little wonder that maintaining the status quo would require an 8.89% spending increase. Directing the district to bring its request in line with or below the state average of 5% is inconsistent with its mission of inspiring and preparing "all children to become independent and enthusiastic learners who achieve personal excellence by providing a challenging and exemplary education." An "average" or below average budget, with chronic cuts to instructional services and meaningful academic programming such as music, is not a reflection of excellence in education but rather mediocrity. Is that really the standard our community holds for its students and future?

I appreciate that both boards are faced with "difficult decisions" and that Board of Education members never wish to cut administrative and instructional staff, academic programming, and support services. But for several years, that has been the response to increased costs, many of which are known obligations and capital improvements. In their respective deliberations, both boards allow conversations to be driven by voices that see education as a burden rather than an asset worthy of investment. At what point will the Board of Education advocate for the learning needs of students and our community's families, who are also part of New Hartford's tax base, and defend the district's budget needs and the quality of education in New Hartford?

With the dismantling of public education at the federal level, funding will become increasingly difficult for states and local governments of all demographics. Difficult decisions will not become easier. Both remedial interventions and special education will likely become more costly. Cutting instructional staff and failing to fund counseling in the face of that likelihood is shortsighted and will have predictable outcomes in student performance. Directing the district to pursue disappearing "creative funding" opportunities will not be a viable solution to problems that lie ahead, and there is little left to cut.

I plan to vote no on the proposed budget if it moves forward to referendum. Please understand that at least one vote against your proposal is not a rejection of the nearly 5% increase in spending but a vote against the continued disinvestment in public education and our community's children.

I hope this letter finds you well. I am writing to express my strong support for the position of clerical aide, which has been an invaluable position at Antolini School. I understand that not every position and program can be saved in the most recent proposed budget, and I would like to take this opportunity to highlight the significant contributions and value that our clerical aide brings to the school.

As I hope you are aware, our clerical aide has many responsibilities that are invaluable to our school. In addition to managing daily office operations, they handle the communication of important messages to staff, manage student crises, and coordinate pickup passes to ensure each student gets home in the correct manner, despite in the moment changes at dismissal time. They are responsible for school and student safety by determining who is allowed in and out of the school. They coordinate building substitutes, organize funding to alleviate the cost of field trips, record necessary data in our Powerschool program and support the staff with preparation of curriculum materials when necessary. The clerical aide's ability to manage multiple tasks efficiently and maintain a positive and professional environment has made them a key asset to our team.

Furthermore, our clerical aide has an integral role in making sure the Antolini office runs smoothly and efficiently. Our clerical aide and administrative assistant work as a team, along with our building principal, taking care of all the behind the scenes operations. They alleviate some of the more timely responsibilities that the administrative assistant is tasked with, and while they work as a cohesive unit, this is only possible because there are two people sharing the responsibilities of managing the Antolini office. Frankly, the range of tasks that must be accomplished on a daily/weekly/monthly basis in the office is too much for one person to successfully handle. Losing such a skilled and experienced team member, such as our clerical aide, could result in increased administrative burdens on other staff members, leading to potential delays and decreased productivity in day to day operations.

I understand that tough decisions need to be made in any organization, but I truly believe that preserving this position is of the utmost benefit to our school and its community in the long run. I am confident that maintaining the clerical aide position at Antolini School is necessary to contribute to our continued success as a school community.

On a more personal note, the staff member currently in this position, Shelly McCoy, has had one of the greatest impacts in my experience at Antolini School, and she has had a significant role in shaping me into the educator that I am today. Without her knowledge and expertise, I would not have been able to navigate my first year of teaching (during the height of covid) as easily as I did. Her dedication to the New Hartford Public Schools community is truly remarkable. The years of experience and knowledge that she has, of Antolini School especially, is invaluable, and I believe it would be a disservice to our staff and students if we lost a person like her.

Thank you for taking the time to read this letter and consider my perspective. I would be happy to discuss further how maintaining the clerical aide position would have continued value in our schools. Please do not hesitate to reach out if you have any questions.



My daughter, Luna, has this year been working closely with Shayla Vu, the school counselor at Antolini, and counts her sessions with Ms. Vu as the highlights of her school days, where she can feel free to express emotions and work on solutions to issues, such as anxiety during test taking, and learn coping skills for handling challenging emotions. Luna has been applying the strategies she has learned, and her academic performance has markedly improved, and she has reported decreased anxiety overall. Our family – as well as I'm sure dozens of others – would be extremely disappointed to see these channels disappear.

Activities such as band, chorus, and White Memorial offer valuable opportunities to enrich students' learning, collaborate with peers, and find joy in their school experience. My son, Dexter – one of the student representatives to the Board of Education – has immensely enjoyed being a part of the 5th and 6th grade band; Luna, now in 3rd grade, has been asking since her first day at Antolini when she'll have the chance to join the band and chorus. Should these programs be eliminated, she would be heartbroken to know that she was not allowed the same wonderful opportunities that her brother was afforded.

I urge you to reconsider these cuts. While I realize that changes must be made somewhere to compensate, these programs in particular are worth saving, even at the expense of higher taxes on residents to ensure that all New Hartford children have the opportunities they deserve.



To the members of the Board of Education:

My name is Marcia Jones. I live at 298 Ramstein Road, and have lived in New Hartford for 40 years. I have seven grown children who all attended New Hartford schools and Northwestern Regional 7, and I am currently raising a granddaughter who is 9 years old, in 4th grade at Antolini School and part of the Special Education program. I am also the Instructional Assistant at Bakerville School and New Hartford Elementary School, and have held this position for almost 14 years.

I have already written and sent you all a letter stating my feelings about the cuts being proposed for the 2025-26 budget. I would like to take a moment to thank the Board and the Superintendent's office for posting all the letters many of us have written regarding these proposed cuts. I personally appreciate your time and energy to do this, and encourage the public to read these letters, as they are important and enlightening to our current budget situation,

I am particularly highlighting here the proposed cut of the Instructional Assistant, and feel compelled to speak directly to this position, because I believe there may be a lack of information and perhaps even misconception regarding what this position actually entails.

In many districts, the phrase "instructional assistant" and "paraeducator" are interchanged. Not so in New Hartford. While I am a qualified paraeducator, I took this particular job 14 years ago as a separate entity, with a separate set of guidelines and expectations, because I believe the instructors in our schools need the support it offers them. Instead of working IN the classroom supporting the instructors as they teach, I work outside of the classroom, supporting the instructors much as the Administrative Assistants support the Administrators. I perform a myriad of tasks for our instructors, including copying, organizing, creating, prepping, sorting, filing, laminating, brainstorming, facilitating and effectively managing all their needs in order to support their teaching. I also work directly with the Curriculum Director producing massive quantities of manipulatives needed to support and fuel our ever-changing curriculums.

My strengths lie in multitasking, organization and time-management, specific requirements for the job I do, and I utilize every minute of my 5 hours each day to get these jobs done,

But when help is needed for duties such as lunch or recess or door duty, literally anything at all, I am always readily available for whatever is needed and more than willing to take time out of my full workday to do so. I am also one of only two substitutes trained and capable of substituting for the three Administrative Assistants in our primary schools and have done so frequently at any time and for any length of time, whether they are called away from their desks, need to leave for a period of time, or have to be out for days or even weeks at a time. This substitute requirement is very specific in relation to knowledge of Power School, the phone system, and most importantly, school security and student privacy. The average substitute, while fully capable of substituting for a classroom para or a classroom teacher, does not have the training to manage the Administrative Assistant position. I am capable and confident in my ability to manage that position and am always available to them, even last-minute, as, coincidentally, just recently happened.

I sincerely hope I have managed here to enlighten and clarify the duties of the Instructional Assistant and that I've shown how important and needed this position is. I ask that you consider my statement here and reconsider the decision to eliminate this position. I speak not for myself, personally, although I truly love my job, but for the position itself, as I truly feel what the position does for our teachers directly relates to their ability to stay in their classrooms, focus on their teaching and their students and thereby maintain a calm, organized and productive classroom.

Dear Board of Education, Board of Finance, Superintendent Sousa, and First Selectman Jerram,

We are writing to plead with you to increase the budget for the New Hartford school system so that we will not have to eliminate current resources and programs crucial to the everyday function of our schools, teachers, and the development of our children. We currently have three children attending, and Rina is an alumni of the New Hartford School system.

We are shocked to learn that the 5th and 6th grade band and chorus would be cut under the current plan due to budget limitations. Rina played band at Antolini, and both the Band and Jazz Band at Regional. Chris played in the school and all-town orchestra in MA. Music was a large part of our early education and social experience at school, and we are excited for our children to enjoy the same. Strong music programs are a staple of a good school system. It has been demonstrated time and again that students involved in music

have an overall improvement in engagement, academics, and enjoyment at school. However, we are broken-hearted to think our kids will miss this invaluable experience under this proposed budget.

We are also grateful for school counselors Ms. Mailhot and Ms. Vu, and the support they gave to both of our children at Antolini. They detected issues which were invisible to the classroom teachers and provided small but game-changing support, which in particular for our daughter truly shifted her entire school experience. Their work helps teachers to better understand the behaviors and emotions of our children, enhancing their experience and education, especially for children at high risk.

Teaching in today's environment is not what it used to be. We expect more from our teachers and administrators than ever before. We live next door to the New Hartford Elementary school and often see teachers and other staff cars in the parking lot until 6 or 7pm. How can we justify adding more work to their already overburdened days? Yet under this proposed budget, several cuts include teaching materials, counselors, and administrative support staff.

While we would understand elimination of unnecessary positions, and the importance of fiscal responsibility, these cuts are instead clearly the result of difficult decisions to reduce the budget. For our family, and for many parents across New Hartford, the quality of the school system is so much more important than the few-thousand-dollars these cuts save. And once cut, school programs such as band become exponentially more difficult to reinstate. We moved from Massachusetts 5 years ago and stayed because New Hartford really seems to care about its children. Many school systems don't have the resources and those children and schools are struggling. You have the chance to maintain a top-tier school system here in New Hartford with minimal incremental investment, and it would be a tragic mistake to let this slip away. Please provide Dr. Sousa the additional funds needed to save these programs.

I am writing to address the proposed elimination of the Clerical Aide position from our budget for the 2025-2026 school year. I would like to present a scenario that frequently occurs at Antolini School and emphasizes the critical need for additional support in the Main Office.

In the Health Office, I often care for multiple students at once, each with varying levels of medical and emotional needs. These can range from colds, vomiting, cuts and scrapes, injuries, and fevers, to the administration of medication and mental health support. On many occasions, these needs must be addressed simultaneously for several students. I often rely on help from the office staff, when possible, to assist with contacting parents for various reasons, managing communications, and addressing other needs that arise during the day.

While I do my best to manage, if I am required to step away from the Health Office due to inadequate staffing—such as answering phones, opening doors, making copies, assisting students with their stars, or managing deliveries for both the school and Oak Hill—this compromises the level of care I can provide to each student.

Ensuring the safety of our students and staff is our most important responsibility. It is simply not feasible to expect the Nurse to take on all these additional duties, especially if our Administrative Assistant is absent or otherwise unavailable, and the Principal is tied up with her own responsibilities. We work together as a team every day, but this staffing cut would undoubtedly compromise my ability to do my job effectively and provide the quality care our students deserve.

This is precisely why our school, with 238 students, requires two clerical positions. Operating effectively with only one would stretch our resources too thin, especially compared to schools that serve fewer students but have a similar ratio of staff.

I strongly urge you to reconsider the proposal to cut the Clerical Aide position. The safety, well-being, and proper care of our students depend on it.

Dear Superintendent & Board of Education,

I write this letter to you as a Taxpayer, a parent of 2 children in the school district & overall concerned citizen. I can't imagine the time & stress you have all endured throughout this Budget season but I need you to know that I am thoroughly disheartened with the 2025/26 proposed budget.

A 4.99% increase is upsetting & completely unsustainable year after year. My husband & I love our schools, we love our community, but we are becoming increasingly concerned that if we as a district don't take a step back & rein in this spending there are going to be a lot of families, myself included, that will soon be out taxed of our homes. We need to start being responsible and start making hard cuts & decisions, and we absolutely must take the emotions out of the equation. Over the last few weeks, I've heard a lot of emotional responses regarding the budget, but I haven't heard practical ones. Well, it's time we began those practical talks, to find practical solutions, we must start talking about school consolidation & increase in class sizes. Enrollment is down again, yet staffing levels remain the same. Now is the time to begin those conversations, our community cannot continue to fund budgets of this size when costs such as Special Education & Health Care continue to increase all the while we pay salary duplication for multiple positions.

As a parent, I put my children's educational needs above that of a taxpayer, yet as I look back, I must ask, what truly have our children gained in education & services with all these continued increases? Honestly, the answer is nothing in terms of education. At the end of the day the quality of education our children receive (which is truly amazing in my opinion) is the same as it was in years past, just a lot more. I do feel though, we as a district are spending entirely too much in way of Emotional Support staff/ services while taking away from valued programs such as Band & Chorus. Cutting the Arts is a disservice to our children & our district. We should be encouraging those programs not cutting. We should be pushing back on parents to parent/discipline their children, it's not the school's responsibility to parent these kids. We should not be offering Emotional/ Behavioral Support programs in place of educational programs, if anything these should be the after school programs.

We need to start doing better. We cannot continue on this current trajectory of throw more money at it, the school budget is already 80% of the Towns entire budget. We need to consider the financial impacts on the vast majority of our community who don't have children in our schools. It is time to start making the necessary decisions that are long-overdue. We cannot be asked to always pay more.

Dear Superintendent Sousa and Members of the Board of Education,

We write to you both as concerned parents and as physicians. We recently moved to New Hartford at the end of 2023. One of the main reasons we chose this town was the quality of the school system.

We are extremely disheartened to learn of the proposed budget cuts that would greatly impact our children's and our town's educational experiences. If these had been in place when we were looking for homes, it would have negatively impacted our decision to move to the town.

Several concerning budget items came to our attention, including but not limited to the following:

We understand that the decrease in General Music FTE would lead to the band program becoming an afterschool program without instrumental lessons. Students who do not have instrumental lessons will not be prepared to participate in band, resulting in either a very unsuccessful band or a band made up of only students whose parents have the time and finances to allow their children to participate in private lessons outside of school. Also, by making this an afterschool program, children of many working parents may no longer be able to participate. Music education/band participation should not be influenced by socioeconomic status and should be an opportunity for all students to learn a skill that will help them throughout their lives. Numerous studies point to the benefits of participation in music education and in learning an instrument. Removing chorus from Ann Antolini excludes students whose voice is their instrument. Had chorus not been available to me (Jennifer), I would not have been able to participate in music education as my talents were vocal, not instrumental. I would also have not been prepared to participate in high school chorus or high school musicals, which offered me a much needed creative outlet and an opportunity to round out my high school studies and participate in regional and national competitions. Being a part of band and/or chorus, helps students to be more well rounded and more competitive as college applicants. As parents, we are concerned that our children will be behind in music education compared to our neighboring towns and therefore not be prepared to participate/succeed in Region 7 Middle and High School band and chorus or become frustrated/lose interest, therefore putting them at a disadvantage when applying to college.

As a family physician and pediatrician, we are extremely concerned about the elimination of the school counseling position. We are in agreement with the American Academy of Family Physician Policy Statement on School Safety and Student Mental Health which states "Mental health supports should be available for students who need them. Untreated mental health conditions are associated with poor academic performance, misconduct, school drop-out, unemployment, involvement with the juvenile justice system, and violence. Suicide is the second leading cause of death among this age group, and according to the Centers for Disease Control and Prevention (CDC) during the period 2009-2016 the suicide rate increased 33%." It is unfortunately not a secret that we are experiencing a mental health crisis in our country, with our youngest children

deeply impacted. We need dedicated mental health professionals on site for safety. If a child is in crisis, they are in need, but it also impacts the mental health and experience of the entire school. Given the district needs and multiple schools served, there are times when Ms. Vu has been the sole mental health professional on site to handle crises when they occur. If her position is eliminated, our students may be without assistance in their time of greatest need. Another unintended consequence of eliminating her position, would be the resulting increase in the caseloads of the other mental health professionals in town. Additionally as Ms. Vu's position offloads some of Mr. Ploud's caseload, he has been able to provide additional enrichment services for students to help them to be challenged and successful in their education. This would no longer be possible if her position is eliminated.

We are also deeply concerned with the elimination of the Talented & Gifted and Math Olympian programs. Special education encompasses the needs of students on all ends of the educational spectrum. While integrated classrooms undoubtedly benefit all students, there will always be students requiring additional assistance and students requiring enrichment. It cannot be another responsibility added to the already overloaded classroom teacher to provide this enrichment. These programs help students to achieve their full potential. Challenging students helps them be more engaged in their regular classroom learning and when they share the knowledge/skills they have acquired through these programs with their peers, it benefits all of the students in the classroom.

Thank you for taking our concerns into consideration.

Dear Board of Finance, Board of Education, Superintendent Sousa and Selectman Jerram,

We write with a simple message -- can you please work together to enable/request Superintendent Sousa and, in turn, the BOE to submit a revised budget proposal to the BOF that can be utilized this coming Tuesday, April 1, at the Town Meeting?

As background, having attended both the BOE meeting last week and the BOF meeting yesterday evening, we heard the BOE say they need to hear the BOF wants a revised budget before submitting a revision, and heard the BOF say they need more information and a revised budget to consider before adding more funding, but there was no formal action taken that will lead to a revised budget ahead of April 1.

Given the vote during yesterday's BOF meeting, it is now clear that the budget that will go to the Town will include the 4.99% increase -- and continue to have the cuts that led to the public outcry -- unless action is taken to put forward the more informed, revised budget version that does not include the aforementioned cuts.

Therefore, and per what you have said you want to see happen, we truly hope you all can work together starting today to revise the local education budget for the meeting on April 1.
