### DISTRICT WIDE PARENT INVOLVEMENT POLICY

#### PART I

#### GENERAL EXPECTATIONS

The Weymouth Township School district agrees to implement the following statutory requirements:

- The school district will put into operation programs, activities and procedures for the involvement of parents with Title I, Part A programs, consistent with section 1116 of the Elementary and Secondary Education Act (ESEA). Those programs, activities and procedures will be planned and operated with meaningful consultation with parents of students in Title I programs.
- Consistent with section 1116, the school district will work to ensure that the required school-level parent involvement policies meet the requirements of section 1116(b) of the ESEA, and each include, as a component, a school-parent compact
- The school district will incorporate this district wide parent involvement policy into its LEA plan developed under section 1112 of the ESEA.
- In carrying out the Title I, Part A parent involvement requirements, to the extent practical, the school district will provide full opportunities for the participation of parents with limited English proficiency, parents with disabilities, and parents of migratory children, including providing information and school reports required under section 1111 of the ESEA in an understandable and uniform format and, including alternative formats upon request, and, to the extent practical, in a language parents understand.

## PART II IMPLEMENTING PARENT INVOLVEMENT POLICIES

1. The Weymouth Township School district will take the following actions to involve parents in the joint development of its district wide parent involvement policy under section 1112 of the ESEA:

Pursuant to federal law, the district and the parents of students participating in Title I district programs have jointly developed the following parent involvement policy. Parents will be notified of state assessment results and have opportunity to participate in a public discussion during open Board of Education meetings.

3. The Weymouth Township School district will provide the following necessary coordination, technical assistance, and other support to assist Title I, Part A schools in building the capacity for strong parent involvement activities to improve student academic achievement and school performance: This coordination, assistance and support shall include:

a. Shall provide assistance to the parents of children served by the district, as appropriate, in understanding such topics as the state's academic content standards and state student academic achievement standards. State and district assessments, the requirements of this part, and how to monitor a child's progress and work with educators to improve the achievement of their children.

b. Shall provide materials and training to help parents work with their children to improve their children's achievement, such as literacy training and using technology, as appropriate, to foster parental involvement.

c. Shall educate teachers, pupil services personnel, principals, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school.

d. Shall ensure that information related to school and parent programs, meetings, and other activities is sent to the parents of participating children in a format and, to the extent practicable, in a language parents can understand.

e. Shall provide such other reasonable support for parental involvement activities under this part as parents may request.

- f. May involve parents in the development of training for teachers, principals, and other educators to improve the effectiveness of such training.
- g. May provide necessary literacy training from funds received under this part if the district has exhausted all other reasonably available sources of funding for such training.
- h. May train parents to enhance the involvement of other parents.
- i. May arrange school meetings at a variety of times, or conduct in-home conferences between teachers or other educators, who work directly with participating children, with parents who are unable to attend such conferences at school, in order to maximize parental involvement and participation.
- j. May adopt and implement model approaches to improving parental involvement.

4. The Weymouth Township School district will coordinate and integrate parent involvement strategies in Part A with parent involvement strategies under the following other programs: State-operated preschool program.

5. The Weymouth Township School district will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parent involvement policy in improving the quality of its Title I, Part A schools. The evaluation will include identifying barriers to greater participation by parents in parent involvement activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background). Hosting virtual information sessions and parent/teacher conferences to inform parents of their child's academic achievement

The school district will, with the assistance of parents, educate its teachers, pupil services personnel, principals, and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents and in how to implement and coordinate parent programs and build ties between parents and schools.
