









Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Before and After School Programs:	An after school tutoring program was offered to students who met a certain criteria in the areas of ELA and Math.
Staff and Professional Learning:	Faculty members continue to enhance their skills and knowledge through their involvement in professional development programs and opportunities provided through the Long Hill Township School District. Teachers participate in Curriculum Mondays and are involved in Professional Learning Communities (PLC's) that focus on best practices for student achievement. Faculty meetings provide staff with ongoing opportunities for professional development and resources. Additionally, faculty members have collaborated with our sending districts and receiving high school through learning walks.
Postsecondary Information:	Articulation takes place with the receiving high schools, Watchung Hills Regional High School, to ensure a smooth transition for our students into High School. We also promote vocational opportunities to all 7th and 8th grade students. The Morris County Vocational School and Somerset County Vocational School District visit and showcase their array of programs and the application process to students in both of these grade levels. For collaboration, teachers at the middle school level conduct learning walks and visit our receiving high school. This provides opportunities to review courses, instructional practices, and curriculum that students will be exposed to in high school.

Student Supports and Services:	Programs that address the special individual needs of students are provided within all of our schools, including Special Services, ESL, and BSI, a gifted and talented program and horizon courses for advanced students. An Intervention and Referral Services Committee meets with parents, as needed, to address questions and develop strategies for success.
Student Health and Wellness:	Central School has a lunch program where parent volunteers from the PTO help distribute food that is pre-ordered by students. The food is ordered from various restaurants in town, providing healthy options for students. All students receive 240 minutes a week of health and physical education. Students participate in daily, 48 minute periods of physical education per week. Health Education is provided to students through the Physical Education Curriculum.
Parent and Community Involvement:	F.O.R.C.E. (Focusing Our Resources for Children's Enrichment) the Long Hill Education Foundation, the P.T.O provide financial contributions as well as volunteers to support academic, arts, and athletic programs in our district. 

Facilities:	All three buildings within the Long Hill Township School district have central air conditioning and are equipped with All Purpose Rooms, Libraries, Art Rooms, STEAM rooms, Band and Choir rooms, and Gymnasiums. Additional security measures have been added to each of our buildings.
School Safety:	All three buildings have various committees that work collaboratively with the entire school community to ensure we are providing our students with a safe environment to learn and grow. Our Mathematics program provides opportunities for students to enroll in Algebra I and Geometry. Sixth, seventh and eighth grade students have the choice of French or Spanish as a World Language. Each grade level rotates through four cycle classes that rotate with each marking period. Cycle classes include: Art, STEAM (Science Technology Engineering Art and Math), Music, 21st Century Literacy, and Geography. High achieving students have the option of Horizon level courses in specific academic areas. These areas include Language Arts, Science, Mathematics, and Art.
