BOARD OF EDUCATION COMMITTEE MEETING SCHEDULE

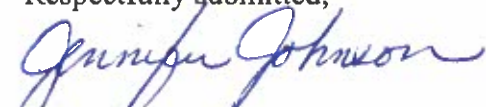
