## RESIDENT/TENANT WITH NO CURRENT LEASE/EXPIRED LEASE

- 1) Resident/tenant with <u>no current lease/expired lease</u>:
  - A) The resident/tenant will need to provide a newly drafted current lease or Declaration of Legal Residence will need to be completed by both resident and property owner. The owner will need to have this document notarized. Original notarized DLR needs to be presented at time of registration appointment. These documents must contain the owner/landlord's name and phone number.
  - B) Resident/tenant must provide a driver's license or passport and car registration.
  - C) Resident/tenant must provide two different and current (within the last month) utility bills (gas water, electricity, internet/cable, landline). If recently moved, letters of account set-up from the utility companies with the **resident's** name, address, and current dates.
  - D) If utilities are stipulated in the lease to be included in the rent, the following documentation will be accepted in lieu of utility bills the two documents must have renters/tenant name, address, and current date.
    - Internet/cable bill (if not specified in lease agreement) is the preferred proof (one) of residency. The second proof can be a cell phone bill with name, address, and current date. If internet/cable is included in the lease, they will need two forms of proof from the list below.
    - Renter's insurance with name, address, and current date, cell phone bill, with name address and current date, current documentation from federal/state/local government such as: Husky benefits letter, state benefit letters (SNAP/TFA, disability, Medicaid, social security), court documents with name, address and current date, Homeland Security, Immigration or Office of Refugee Resettlement documents, voter's registration approval confirmation with name, address, and current date, current driver's license or car registration change or renewal confirmation with name and address current date, car tax bill with current date, name, and address. All these documents must contain, name, address, and date within the last 30 days of registration date.
