COURSES AND CREDITS

Paradise Valley Community College Concurrent Enrollment Credits

Concurrent Enrollment is not available to high school graduates and students with a GED.

- 1st Semester
 - BPC 170 A+ Exam Prep: Computer Hardware Configuration and Support (3 credits)
 - GBS 109 Introduction to Esports Management (3 credits)
 - CRW 176 201 Writing Narrative for Video Games (3 credits)

[Students must earn a 70% or higher in ALL 1st semester courses to fulfill the 2nd semester college prerequisite.]

- 2nd Semester
 - CIS 120 DK introduction to Digital Video Editing (3 credits)
 - MTK 110 Marketing and Social Networking (3 credits)
 - AVC 202 Media Productions (3 credits)

COST REQUIREMENTS

- West-MEC pays the college tuition (in-state tuition only; out-of-state students are responsible for the difference between in-state and out-of-state tuition) for students accepted to the Esports Program.
 - \$15 registration fee per semester
 - \$97 per credit hour due soon after classes begin
 - Cost based upon meeting Maricopa residency and U.S. citizen/legal residency criteria (Must complete "Maricopa Community Colleges Student Declaration of Citizenship or Status" form. Visit www.maricopa.edu/residency)
- Additional cost for textbooks and uniforms will apply
- Courses taken under concurrent enrollment may impact federal financial aid eligibility. To obtain additional information, students are encouraged to inquire with the college or university where they intend to enroll.
