Transportation Information

SEPTA Student Fare Card Information

Students attending Nazareth Academy High School and who reside in the city of Philadelphia will have their name, address, phone number and date of birth submitted to the School District of Philadelphia, Transportation Services. Students who qualify will receive a Student Fare Card at the beginning of the school year. This is to be retained for the remainder of their time at Nazareth Academy.

Please note the SEPTA eligibility requirements

- Student must be a resident of Philadelphia in grade 9 through 12.
- Student must live 1.5 miles or more from Nazareth Academy HS.
- Must be a Public, Charter, Archdiocesan or Non-Public school student.
- May only be used from 6:00 AM to 7:00 PM Monday through Friday. No weekend uses.
- May only be used when school is in session. Adults may not use the SEPTA Student Fare Card.
- A Student Fare Card may only be given to those students whose names appear on the eligibility report.
- Students will be responsible for the safety and security of their Student Fare Card.

New Jersey Van Students

New Jersey students using the Nazareth Academy High School van are picked up at the Morrestown Library at 2nd Street and Church Rd. at 7:00 AM.

The cost to use the van service for the 2025 – 2026 academic year is \$10 per day. Please note that you will be billed for the number of days used following the month end. TOWNSHIP BUSSING INFORMATION 2025-2026

If your daughter will be taking a township bus for transportation to and from school, please read the following information:

1. No student is permitted to ride or invite another student to ride a township bus if she is not registered in that township.
2. When Nazareth Academy received your application with your bussing township, we sent the student's pertinent information to the township's transportation department so that pick-ups and drop-offs would be created.
3. The township will set up a time and place for pick-up and drop-off each day. These arrangements are all made through your township. A schedule of the bus stop will be provided to the student.
4. Students may be removed from the list if student does not appear to be using the township bus. Please inform Nazareth Academy if a student's reinstatement needs to be made.
5. Most townships only allow for a select number of early pick-ups on "early dismissal" days. Please refer to the "Early Dismissal Chart" on the school website for the days and dates scheduled for your township.
6. Several townships supply an after school "late activities bus" for students involved in after school activities. The student must sign in at the Main Office that day before 8:00 AM so that we can schedule a late bus in a timely fashion.
7. In the case of a school closing, a school messenger text will be sent to inform the families.
