SECTION 00 43 13 – PROPOSAL GUARANTEE BOND Name of Contractor KNOW ALL MEN BY THESE PRESENTS, THAT we as Principal, and as Surety, are held and firmly bound unto the Board of Trustees, Dallas Independent School District, Dallas, Dallas County, Texas, hereinafter called the Obligee, in the penal sum for the payment of which sum well and truly to be made, we bind ourselves, our heirs, executors, administrators, successors and assigns, jointly and severally, firmly by these presents. THE CONDITION OF THIS OBLIGATION IS SUCH, that whereas the Principal has submitted the accompanying Competitive Sealed Proposal, dated ______, 20____, being for the construction of with appurtenances thereto, at Dallas, Dallas County, Texas, the kind and extent of work involved being set forth in detail in the proposed Contract Documents; NOW, THEREFORE, if the Obligee shall accept the proposal of the Principal and the Principal shall enter into a Contract with the Obligee in accordance with the terms of such proposal, and give such bond or bonds as may be specified in the proposal or Contract Documents with good and sufficient surety for the faithful performance of such Contract and for the prompt payment of labor and material furnished in the prosecution thereof, or in the event of the failure of the Principal to enter such Contract and give such bond or bonds, if the Principal shall pay to the Obligee the difference not to exceed the penalty hereof between the amount specified in said proposal and such larger amount for which the Obligee may in good faith contract with another party to perform the Work covered by said proposal, then this obligation shall be null and void, otherwise to remain in full force and effect. This Proposal Guarantee Bond applies to all contracts in excess of \$100,000 involving a contract for construction, alteration or repair of any public building or the completion or prosecution of any public work. This Proposal Guarantee Bond must be payable to the awarding authority, Dallas Independent School District, as the named Obligee, and it must be approved as to form by such awarding authority. Surety must be corporate surety duly authorized to do business in Texas. This Proposal Guarantee Bond must be equal to 10% of the full amount of the contract which it secures. Power of Attorney from Corporate Surety should be attached to this Proposal Guarantee Bond.
