Texas Government Code Section:

- 551.074 Deliberate the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee or to hear a complaint or charge against an officer or employee.
- 551.076 Considering the deployment, or specific occasions for implementation, of security personnel or devices; or a security audit.
- 551.082 Considering discipline of a public-school child, or complaint or charge against personnel.
- 551.089 Considering security assessments or deployments relating to information resources technology; network security information described by Government Code section 2059.055(b); or the deployment, or specific occasions for implementation, of security personnel, critical infrastructure, or security devices.

Should any final action, final decision, or final vote be required in the opinion of the committee with regard to any matter considered in such Closed Session, then the final action, final decision, or final vote shall be either:

- (a) in the Open Meeting covered by the Notice upon the reconvening of the public meeting; or
- (b) at a subsequent public meeting of the committee upon notice thereof; as the committee shall determine.
