Electors will consider the following issues at the election:

- One (1) Trustee(s) to be elected for a one (1) year unexpired term,
- One (1) Trustee(s) to be elected for a three (3) year term.
- Mill levy proposition to finance the school's General Fund
- Proposition: Shall the board of trustees be authorized to impose an increase in local taxes to support the general fund in the amount of eighty two thousand two hundred twenty and thirty one cents DOLLARS (\$82,220.31) per year which is approximately 15.77 mills, for the purpose of: maintaining and operating Fromberg School District's General Fund .Passage of this proposal will increase the taxes on a home with a market value of \$100,000 by approximately \$21.29, on a home with a market value of \$300,000 by approximately \$63.87, and on a home with a market value of \$600,000 by approximately by \$127.74. An increase in property taxes may lead to an increase in rental costs. The durational limit of the levy is permanent once approved by the voters, assuming the district levies that amount each year thereafter. However, lowering over-BASE tax levies in any year will lower the amount of permissively over-BASE levies in subsequent years.

A qualified registered elector who will be absent from the district during the time the election is being conducted may: a) vote in person in the election administrator's office as soon as the ballots are available and until noon the day before the ballots are scheduled to be mailed; b) make a written request, signed by the applicant and addressed to the election administrator, that the ballot be mailed to an address other than the address that appears on the registration card.
